INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Plan Participants
West Point 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of West Point 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 19, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period ended December 19, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of West Point 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 19, 2023 and December 31, 2022, and for the period ended December 19, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about West Point 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

NOTE 1: DESCRIPTION OF THE PLAN

General

The WEST POINT 401(K) PLAN (the "Plan") was adopted effective April 1, 1995 as a defined contribution plan covering all of the eligible employees of Southwest Lincoln Mercury, West Point Lincoln Mercury Buick and Hot Rides ADI, L.P. (the "Company", or "Plan Sponsor"). The Plan was amended effective November 29, 2011 by changing the plan name to WEST POINT 401(K) PLAN in lieu of SOUTHWEST/WEST POINT 401(K) PLAN. The amendment also removed Southwest Lincoln Mercury as a Participating Employer. On April 6, 2023, through an asset purchase, the Lincoln dealerships River Oaks L-M Inc. dba West Point were acquired and a new entity West Point Lincoln LLC, was created. As part of the transaction West Point Lincoln LLC assumed in its entirety the assets and obligations of the West Point 401(k) Plan previously sponsored by River Oaks L-M, Inc. dba West Point. Subsequently the Plan was amended to change the name to West Point Lincoln LLC 401(k) Plan and the Plan Sponsor was changed to West Point Lincoln LLC. The Plan formally terminated as of December 19, 2023, see Note 9 for Plan termination. The Plan is a qualified plan as defined by Section 401(a) of the Internal Revenue Code and contains a provision for salary reduction contributions under Section 401(k) of the Internal Revenue Code. The Plan is also subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The following description provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

Eligibility

Employees who have attained the age of 21 are eligible to participate in the Plan after completing 1,000 hours of service during the twelve-month period following their employment date. Upon eligibility, employees are allowed to enter the Plan on the first day of each month of the Plan year.

Contributions

Employees may elect to contribute up to 100% of their eligible compensation to the Plan and may direct their contributions to various investment alternatives. Contributions for employees are limited in any calendar year to an amount which is adjusted annually by the Internal Revenue Service ("IRS"). Participants who have attained the age of 50 before the end of the plan year may make additional pre-tax catch-up contributions. The Plan allows rollover contributions from other qualified retirement plans.

For each plan year, the Company may also elect to make discretionary matching employer contributions for each eligible participant. Through May of 2023, the Company contributed 25% of participant contributions up to 6% for a maximum contribution of 1.5% of the employee's compensation. The Company, at the discretion of the Board of Directors, may also make a profit-sharing contribution to the Plan during the year. There was no profit-sharing contribution in 2023.

Notes Receivable from Participants

In accordance with the plan document, participants may borrow the vested balance of their account, subject to a minimum of \$1,000 and a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable bear interest at reasonable interest rates and are secured by the participant's vested account balance. Principal and interest is paid ratably through payroll deductions.

Forfeitures

Amounts which are forfeited due to termination of employment may be used to reduce the Company's matching contribution or to pay plan expenses under the Plan. Forfeitures of \$7,907 were used to reduce the Company's matching contribution in 2023.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions, (b) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the plan. Income for each of the investment directives is allocated to the participants' accounts on a daily basis. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting and Payment of Benefits

All participant contributions vest immediately. Company contributions vest according to the following schedule:

Years of Service	Percentage Vested
Less than 2	0%
2 but less than 3	25%
3 but less than 4	50%
4 but less than 5	75%
5 or more	100%

The normal retirement age under the Plan is 59 ½. Upon a participant's death, termination, retirement, disability, or attainment of age 59 ½, the vested funds in the participant's account are available to be distributed in a lump-sum payment. The Plan also allows for hardship withdrawals from a participant's account. If death or permanent disability occurs during employment, an employee's entire account becomes fully vested. Installments are required for employees over 70 ½ to meet the minimum distribution requirements of Internal Revenue Code regulations. Separating participants may elect to rollover their account into another plan, as permitted by Internal Revenue Service regulations.

CARES Act

Effective August 2022, the Plan has implemented certain requirements by the Coronavirus Aid, Relief, and Economic Security (CARES) Act and the Setting Every Community Up for Retirement Enhancement (SECURE) Act of 2019, which laws change the plan to, among

others, allow certain eligible individuals to receive coronavirus-related relief for loan repayment, increased loan limits, expanded distribution options, and delayed the commencement date for required minimum distributions.

Basis of Accounting

The financial statements have been prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported changes in net assets during the reporting period. Actual results could differ from those estimates.

Investments

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of the guaranteed investment contract. See Note 6 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade date basis.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative fees and other when incurred. As of December 19, 2023 and December 31, 2022, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Excess Contributions Payable

Amounts payable to participants totaling \$2,309 for contributions in excess of amounts allowed by the IRS are recorded as accounts payable, with a corresponding reduction to 2022 contributions. The Plan distributed the 2022 excess contributions prior to March 15, 2023.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to notes receivable from participants, withdrawals, and certain investment transaction fees are charged directly to the participant's account and are included in administrative fees and other. Other investment-related expenses are included in net appreciation in fair value of investments.

Payment of Benefits

Benefits are recorded when paid.

NOTE 3: ADMINISTRATION

As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, Voya Institutional Trust Company ("VITC"), the trustee, has certified to the completeness and accuracy of all investments reflected in the accompanying statements of net assets available for benefits as of December 19, 2023 and December 31, 2022, the schedule H, line 4i – schedule of assets (held at end of period) as of December 19, 2023 and the related investment activity reflected in the statement of changes in net assets available for benefits for the period ended December 19, 2023.

NOTE 4: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 5: GUARANTEED INVESTMENT CONTRACT

The Plan is invested in a fully benefit-responsive guaranteed investment contract with VITC. VITC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value in accordance with ASU 2015-12. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract value of the investment contract at December 19, 2023 and December 31, 2022 was \$0 and \$958,669, respectively. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than three percent. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

The Voya Fixed Account guarantees principal and a guaranteed minimum interest rate ("GMIR") for the life of the product as well as featuring two declared interest rates: a current rate, determined at least monthly, and a guaranteed minimum floor rate declared for a defined period - currently one calendar year. The guaranteed minimum floor rate may change after a defined period, but it will never be lower than the GMIR that applies for the life of the contract. The Voya Fixed Account yield for the period ended December 19, 2023 was approximately 1%.

NOTE 6: FAIR VALUE MEASUREMENTS

ASC 820-10 provides standards and disclosures for assets and liabilities that are measured and reported at fair value. As defined in ASC 820-10, fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (exit price). ASC 820-10 requires disclosure that establishes a framework for measuring fair value and expands disclosure about fair value measurements. The statement requires fair value measurements be classified and disclosed in one of the following categories:

Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities. An active market for the asset or liability is a market in which transactions for the asset or liability occur with sufficient frequency and volume to provide pricing information on an ongoing basis.

Level 2: Measured based upon inputs that are observable, either directly or indirectly, for the asset or liability other than quoted market prices included in Level 1. These inputs include: a) quoted prices for similar asset or liabilities in active markets b) quoted prices for identical or similar assets or liabilities in markets that are not active c) inputs other than

quoted market prices that are observable and d) inputs that are derived primarily from or corroborated by observable market data by correlation or other means.

Level 3: Measured based on unobservable inputs for the asset or liability for which there is little, if any, market activity for the asset or liability at the measurement date. This input includes management's own assumptions about the assumptions that market participants would use in pricing the asset or liability. The inputs are developed based on the best information available in the circumstances, which might include management's own data.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 19, 2023 and December 31, 2022.

Pooled separate accounts:

The fair value of these mutual funds is a publicly quoted pricing input used in determining the NAV of the pooled separate account, which is not publicly quoted. Pooled separate accounts are valued at the NAV or equivalent based on units of the pooled separate accounts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is generally based on the fair value of the underlying investments held by the pooled separate account less its liabilities. This practical expedient is not used when it is determined to be probable that the pooled separate account will sell the investment for an amount different than the reported NAV.

As required by ASC 820-10, financial assets and liabilities are classified based on the lowest level of input that is significant to the fair value measurement. The Company's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of the fair value of assets and liabilities and their placement within the fair value hierarchy levels.

NOTE 7: PARTY-IN-INTEREST TRANSACTIONS

Plan investments include shares of pooled separate accounts and a guaranteed investment contract managed by VITC, the trustee. During the period ended December 19, 2023 the Plan paid VITC \$6,552 in administration fees that are included in administrative fees and other. Notes receivable from participants also qualify as party in interest transactions. These transactions are covered by an exemption from the prohibited transaction provisions.

NOTE 8: INCOME TAX STATUS

The Plan has adopted a non-standardized prototype plan, which obtained its latest opinion letter dated September 1, 2014 in which the IRS stated that the prototype document satisfies the applicable provisions of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, contributions to the Plan and earnings from its assets are not currently taxable to the Plan or its participants.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 19, 2023 and December 31, 2022, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9: PLAN TERMINATION

The Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, participants would become 100% vested in their employer contributions.

On April 6, 2023 through an asset purchase the Lincoln dealerships River Oaks L-M Inc. dba West Point were acquired and created a new entity West Point Lincoln LLC. In a separate transaction by a separate buyer River Oaks L-M Inc. dba West Point sold their GMC Store and Parts Warehouse. The Plan had terminated 20% of its employees which triggered a partial termination of the plan. All employees that remained active during the plan became fully vested.

On October 31, 2023, the Company formally executed an asset transfer with the trustee and terminated the Plan effective as of December 19, 2023, and employee and employer contributions ceased. The Plan Sponsor provided in its formal termination resolutions that Plan assets were to be transferred as soon as administratively feasible in accordance with the terms of the Plan. The transfer of assets to Higginbotham PEP, by West Point Lincoln, took place on December 19, 2023.
