Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Cleanstreet 401(k) and Davis-Bacon Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1 - Plan Description

The following description of Cleanstreet 401(k) and Davis-Bacon Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan covering substantially all employees of CleanStreet, Inc. (the "Company"), excluding nonresident aliens and employees covered by collective bargaining agreements, who have been employed for one year, completed at least 1,000 hours of service, and are age 18 or older. An employee who met the eligibility requirements may have entered the Plan only on January 1, April 1, July 1, and October 1 of each plan year. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

In addition, employees performing services that are covered by the federal, state, or municipal prevailing wage law or the Davis-Bacon Act, as amended, received company prevailing wage law 401(k) contributions. There were no age or service requirements for a Davis-Bacon eligible employee to participate in the Plan. A Davis-Bacon eligible employee may have entered the Plan on the first day of each calendar month of the plan year.

Effective July 6, 2022, the Plan merged into the SCA 401(k) Plan, see further details in Note 3.

Contributions

The Plan provided for employee pretax deferral contributions up to a maximum of 100 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants who attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants may have also made contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Company may have made discretionary profit-sharing contributions to the Plan. Participants who attained the eligibility requirements specified above and remained employed by the Company through the last day of the plan year were eligible to receive employer discretionary profit-sharing contributions. No employer discretionary profit-sharing contributions were made during the period ended July 6, 2022.

The Company made qualified nonelective employer contributions (QNEC) to the Plan based on state and federal prevailing wage jobs. No eligibility conditions applied to prevailing wage contributions unless the prevailing wage contract provided otherwise. Total annual contributions made to the Plan on behalf of any participant were subject to limitations imposed under the IRC. No qualified nonelective employer contributions were made during 2022.

Certain participant contributions in 2021 were paid after the time frame required by the Department of Labor. The late contributions were not corrected in 2022 and were transferred with plan assets to the SCA 401(k) Plan, as further described in Note 3. The lost earnings will be remitted to the SCA 401(k) Plan in 2023.

Participant Notes Receivable

Participants who incurred an immediate and heavy financial hardship or an unusual or special situation, as defined in the plan agreement, may have borrowed from their accounts a minimum of \$100 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. The notes receivable were secured by the balance in the participant's account and bore interest at rates that were commensurate with local prevailing rates determined periodically by the plan administrator. Principal and interest were paid ratably through monthly payroll deductions.

Note 1 - Plan Description (Continued)

Participant Accounts

Each participant's account was credited with the participant's contributions, discretionary profit-sharing contributions, allocations of the QNEC, and any earnings thereon and charged with an allocation of administrative expenses. Discretionary profit-sharing contributions were allocated as a percentage of compensation of eligible participants for the plan year. QNEC contributions were allocated based on the fringe benefit amount determined by the prevailing rate schedule for the participant, reduced by contributions made to other plans that counted toward fringe rates. Allocations of earnings and expenses were based on the participants' account balances. The benefit to which a participant was entitled was the benefit that could have been provided from the participant's vested account. Participants may have directed the investments of their account balances into various investment options offered by the Plan.

Vesting

Participants were immediately 100 percent vested in employee salary, rollover, and QNEC contributions and any income or loss thereon. Vesting in the Company's discretionary profit-sharing contribution portion of their accounts, plus actual earnings thereon, was based on years of service. A participant was 100 percent vested after five years of credited service or after attaining age 55, whichever occurred first. Participants who became totally disabled or died before normal retirement age became fully vested in their accrued benefits.

Benefit Payments

Distributions were payable upon retirement, death, disability, termination of employment, or attainment of 59½ years of age in the form of a lump-sum amount equal to the vested balance of a participant's account or a series of payments at the election of the participant. Participants may have requested that all or a portion of their accounts be distributed in the case of severe financial hardship, as defined in the plan document, to the extent such account was fully vested.

Forfeitures

If a participant was not fully vested on his or her termination date, the nonvested amount of the account was forfeited. Forfeitures were used to reduce future company contributions or to pay administrative expenses of the Plan.

Termination

While it has not expressed any intent to do so, the Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan document and ERISA. Upon termination of the Plan, participants became 100 percent vested in their account balances. Subsequent to the merger with the SCA 401(k) Plan described in Note 3, the Plan terminated.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

Investments held by the Plan were stated at fair value. Fair value was defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded as earned. Dividends were recorded on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable were recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable were written off when deemed uncollectible.

Benefit Payments

Benefits were recorded when paid.

Administrative Expenses

Various administrative costs were paid by the Company. These transactions qualified as party-in-interest transactions.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America required management to make estimates and assumptions that affected the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could have differed from those estimates.

Risks and Uncertainties

The Plan invested in various investment securities. Investment securities were exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could have materially affected participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures included evaluations of events up through and including October 11, 2023, which was the date the financial statements were available to be issued.

Note 3 - Plan Merger

During 2022, the Plan assets and liabilities were merged into the SCA 401(k) Plan. All assets, participants, and their related account balances were transferred to the SCA 401(k) Plan on July 6, 2022.

Note 4 - Certified Information

In 2022, the Plan changed its trustee from John Hancock Life Insurance Company U.S.A. to Empower Trust Company, LLC (collectively, the "Trustee"). The Trustee of the Plan held the Plan's investments and participant notes receivable and executed all related transactions during the periods under audit. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements were based solely on information certified by the Trustee.

Note 5 - Fair Value Measurements

The following valuation methodologies were used to value the Plan's investments:

Pooled Separate Accounts

The pooled separate accounts were valued at net asset value per share or its equivalent of the funds, which was based on the fair value of the funds' net underlying assets. There were no redemption restrictions or unfunded commitments on these investments.

Note 6 - Tax Status

During 2022, the Plan adopted a preapproved plan. Previously, the Plan, as adopted, used a prototype plan. There were no significant changes as a result of the adoption of the preapproved plan. The preapproved plan and prototype plan have received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.
