### **Note 1 - Plan Description**

The following description of Roskam Baking Company Hourly Employees Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan covering all hourly employees of Roskam Baking Company (the "Plan Sponsor") and its controlled group of the corporations (collectively, the "Company"). Participation is voluntary and effective immediately upon employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### ***Contributions***

The Plan provides for employee deferral contributions in an amount that does not exceed the maximum tax-deferred limitations established by the Internal Revenue Code. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan provides for employer discretionary matching contributions of \$0.50 per hour worked, up to 40 hours, regardless of the employee's deferred compensation for all employees with at least one year of service. The Plan also provides for additional employer discretionary contributions; however, there were no additional discretionary contributions in 2023 and 2022.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### ***Vesting***

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. Vesting in the Company's contribution portion of their accounts, plus actual earnings thereon, occurs immediately upon fulfilling one day of employment.

#### ***Benefit Payments***

On termination of service due to death, disability, or retirement, a participant (or the participant's beneficiary in the case of death) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various installment annuities. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. The plan administrator must approve any such hardship withdrawals.

#### ***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Principal Life Insurance Company (Principal Life), Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal Trust Company), and Principal Global Investors Trust Company (Principal Global) or their affiliates. Principal Life, Principal Trust Company, and Principal Global are the custodians of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

### **Note 1 - Plan Description (Continued)**

#### ***Termination***

As discussed in Note 7, following the merger of plan assets, the Company has terminated the Plan effective April 17, 2023 in accordance with the provisions set forth in the plan agreement and ERISA.

### **Note 2 - Summary of Significant Accounting Policies**

#### ***Investment Valuation***

The Plan's investments are stated at fair value except as noted below. The fully benefit-responsive investment contract is valued at contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

The common collective trust funds and pooled separate accounts are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying net assets. There are no redemption restrictions or unfunded commitments on these investments. See Notes 5 and 6 for additional information.

#### ***Participant Notes Receivable***

Current participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible. New participant notes receivable are not permitted by the Plan.

#### ***Benefit Payments***

Benefits are recorded when paid.

#### ***Transfers***

A participant may transfer his or her account balance between the Plan and a related plan sponsored by the Company if the participant changes positions resulting in a change in plan eligibility. Such amounts are presented as transfers in - from Roskam Baking Company Salaried Employees Retirement Savings Plan on the statement of changes in net assets available for benefits and amounted to \$0 and \$12,800 in 2023 and 2022, respectively.

#### ***Administrative Expenses***

Various administrative costs are paid by the Company.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

#### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

### **Note 2 - Summary of Significant Accounting Policies (Continued)**

#### ***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including August 28, 2024, which is the date the financial statements were available to be issued.

### **Note 3 - Certified Information**

Principal Life, Principal Trust Company, and Principal Global hold the Plan's investments and execute all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by Principal Life; Principal Trust Company; and Principal Life, on behalf of Principal Global.

### **Note 4 - Tax Status**

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

### **Note 5 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

#### ***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

#### ***Level 2***

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

#### ***Level 3***

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

### Note 6 - Investment Contracts

The Plan has a benefit-responsive investment contract with Principal Life Insurance Company. Principal Life maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a semiannual basis for resetting but may not be less than 1 percent or greater than 3 percent. When establishing interest crediting rates for this product, Principal Life considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account.

Generally, there are no events that could limit the ability of the Plan to transact at contract value paid within three days or, in rare circumstances, contract value paid over time. There are no events that allow the issuer to terminate the contract and that require the Plan Sponsor to settle an amount different than contract value paid either within three days or over time.

### Note 7 - Plan Merger

During 2023, the Plan merged and combined with the SuccessWise Pooled Employer Plan. Accordingly, all assets, participants, and related account balances were transferred to the SuccessWise Pooled Employer Plan in 2023.
