As discussed in Note 1 to the financial statements, Whitney, Bailey, Cox & Magnani, LLC (the Plan Sponsor) terminated the Plan on September 19, 2023, in conjunction with the merger of the Plan Sponsor with another company. All Plan assets were distributed to the participants during the period ended September 19, 2023. Our opinion has not been modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the Financial Statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the Financial Statements.

In preparing the Financial Statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Whitney, Bailey, Cox & Magnani, LLC 401(k) Profit Sharing Plan's ability to continue as a going concern for one year after the date the Financial Statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Whitney, Bailey, Cox & Magnani, LLC 401(k) Profit Sharing Plan, and determining that the Whitney, Bailey, Cox & Magnani, LLC 401(k) Profit Sharing Plan's transactions that are presented and disclosed in the Financial Statements are in conformity with the Whitney, Bailey, Cox & Magnani, LLC 401(k) Profit Sharing Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the Financial Statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgement made by a reasonable user based on the Financial Statements. In performing an audit in accordance with GAAS, we:

- Exercise professional judgement and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the Financial Statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the Financial Statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Whitney, Bailey, Cox & Magnani, LLC 401(k) Profit Sharing Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgement, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Whitney, Bailey, Cox & Magnani, LLC 401(k) Profit Sharing Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the Financial Statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the Financial Statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

Note 1. Description of the Plan

The following brief description of the Whitney, Bailey, Cox & Magnani, LLC 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan, first established January 1, 1985, is a defined contribution plan intended to qualify under Internal Revenue Code Section 401(k) covering substantially all employees and members of Whitney, Bailey, Cox & Magnani, LLC and WBCM Construction Services, LLC (the Sponsor). The Plan provides for pre-tax and after-tax (Roth) employee, member, and sponsor (employer) contributions. It is subject to the provisions of the Employee Retirement Income Security Act of 1974. The members of the sponsor oversee governance of the Plan. The Plan's 401(k) Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

Employee participation in the Plan is entirely voluntary. Employees must be at least 21 years old to become eligible. Employees who meet the age requirement may participate in the Plan effective on the first of the month following their month of hire.

Contributions

Within limits as outlined by Internal Revenue Code Section 401(k), Plan participants may elect to contribute amounts up to the maximum contribution of \$22,500 for 2023. The Internal Revenue Code allows participants over age 50 to make catch-up contributions. The maximum catch-up contribution was \$6,500 for 2023.

The Sponsor may contribute a matching percentage of the participant's contributions. The Sponsor may also make discretionary contributions to the Plan. Matching and discretionary contribution rates are determined annually by the Sponsor. The Sponsor matched participant contributions at a rate of 50% up to the first 6% of eligible employee compensation for each pay in 2023. There were no discretionary contributions during the period ended September 19, 2023.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 6% of eligible compensation. Contributions are automatically invested in an American Funds Target Date fund, aligned with the age of the participant, until changed by the participant. The deferral rate is increased by 1% of eligible compensation each March 15th until the deferral rate reaches 10%

Participants may also make rollover contributions representing distributions from other qualified defined benefit or contribution plans. Such rollover contributions are deposited in the appropriate investment funds in accordance with the participant's election and the Plan's provisions.

Notes to Financial Statements

Participants direct the investment of their contributions and the employer contributions into the investment options offered by the Plan. The Plan currently offers various mutual funds and a guaranteed interest fund as investment options for participants.

During the period ended September 19, 2023, there were distributions of excess contributions in the amount of \$14,850. The contributions in excess of amounts allowed by the IRS related to participant contributions made during the year ended December 31, 2022. The return of excess contributions are reported as distributions in these financial statements.

Participant Accounts

Each participant's account is credited with the participant's contribution, an allocation of employer contributions, and an allocation of Plan earnings or losses. Allocations of Plan earnings are based on account balances.

The amount of the benefit to which a participant is entitled is the amount provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their elective deferrals and rollover contributions, and the earnings on those contributions. Employer contributions vest according to the following schedule:

Notes Receivable from Participants

Participants may borrow from their account, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or up to 50% of their vested account balances. The loans are secured by the balance in the participant's account and bear interest at rates, which are commensurate with the Prime Rate of interest published in the Wall Street Journal (plus 1%) at the time the loans were originated. Principal and interest are repaid ratably through biweekly payroll deductions. Participants are limited to one loan outstanding at any time. All loan balances were repaid in conjunction with the termination of the Plan in 2023.

Notes to Financial Statements

Payment of Benefits

If a participant separates from service with the Sponsor, and has a Plan balance of \$5,000 or more, the participant or his beneficiary may elect to leave the assets in the Plan, receive some or all of his Plan balance in a lump sum distribution, receive payment of vested benefits in installments over a period of time not to exceed the participant's life expectancy, or by direct rollover to an individual retirement account or to another qualified plan. Participants with Plan balances of less than \$5,000 upon separation, will receive a full distribution to an Individual Retirement Account. Participants that reach the age of 59½ may receive in-service withdrawals. The normal retirement age is 65 years old.

Plan Termination

In June 2023, the Plan was terminated in conjunction with the acquisition of the Sponsor by another company. Participants were notified of the termination on June 28, 2023, and informed the money in the participants' accounts would be distributed as allowed under the terms of the Plan and federal regulations. Participants had the option to: 1) have vested balances distributed directly as a lump sum, subject to mandatory federal and state tax withholding and 10% early withdrawal penalty, if applicable; 2) roll over the vested balance to another eligible retirement plan; or 3) roll over the vested account balance to an individual retirement account of the participant's choice. All funds were distributed during the period ended September 19, 2023.

Forfeited Accounts

Nonvested forfeited balances are deposited into the account. The Sponsor may use these amounts to reduce future employer contributions. The Sponsor applied forfeited balances of \$17,024 during the period ended September 19, 2023, toward employer contributions. Such forfeited amounts used are not included in employer contributions reported on the statement of changes in net assets available for benefits. In addition, in conjunction with the termination of the Plan, the \$30,647 remaining balance in the forfeiture account was allocated to remaining active participants in the Plan.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accounting and reporting policies reflected in the financial statements conform to accounting principles generally accepted in the United States of America applicable to employee benefit plans. The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

Notes to Financial Statements

Investments

The Plan reports its investments at fair value. For mutual funds, the values represent the net asset value of shares held by the Plan at year end. Purchases and sales of mutual funds are recorded on a trade date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. For the Guaranteed Interest Fund, the values represent the sum of contributions and deposits by and on behalf of participants plus interest credited less amounts distributed and transferred. Mutual fund fees reduce net appreciation in fair value of investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. These amounts are not materially different from the current fair values of the notes. Interest on notes receivable is calculated based on the unpaid principal balance outstanding. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred.

Contributions

Employee contributions are recognized as additions to net assets available for benefits at the time the related payroll withholdings are made by the employer.

LLC member contributions are recognized as additions to net assets available for benefits in the year when deductible on their personal income tax returns.

Employer matching contributions are recognized as additions to net assets available for benefits in the Plan year in which the related employee and LLC member contributions have been recognized.

Payment of Benefits

Benefits are recorded when paid.

Expenses

The expenses of investment management are withdrawn from the individual participant's Plan funds by the investment manager and are based on an agreed upon fee schedule. The expense of investment advisory services as well as the audit of the Plan are allocated to the participants. Other administrative expenses borne directly by the Sponsor are not reflected in these financial statements.

Reclassifications

Certain prior year amounts have been reclassified to conform to the current year presentation. Reclassifications had no effect on the prior year reported net increase in net assets or ending net assets available for benefits.

Notes to Financial Statements

Date of Management's Review of Subsequent Events

There are two types of subsequent events: (1) recognized events, which are events that provide additional evidence about conditions that existed at the date of the financial statements, including the estimates inherent in the process of preparing the financial statements, and (2) nonrecognized events, which are events that provide evidence about conditions that did not exist at the date of the financial statements but arose after that date.

The Plan has evaluated subsequent events through August 21, 2024, the date the financial statements were available to be issued. Based on this evaluation, the Plan did not identify any recognized or nonrecognized subsequent events that would have required adjustment to or disclosure in the Plan financial statements.

Note 4. Income Tax Status

The Plan uses a prototype document for its original plan document and amendments. The prototype plan provider has received an opinion letter from the Internal Revenue Service dated June 30, 2020, as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Notes to Financial Statements

Note 5. Parties-In-Interest

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Fees were paid to Great-West Life & Annuity Insurance Company for Plan recordkeeping, Morgan Stanley Smith Barney for investment advisory services, Advised Asset Group for investment management, and Yount, Hyde & Barbour, P.C. for audit services. The Plan lends funds to its participants according to applicable provisions of the Plan Agreement. The Sponsor provides certain accounting and administrative services to the Plan for which no fees are charged. All such transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

Note 6. Guaranteed Interest Fund

The Plan invests in a Group Fixed Deferred Annuity contract that is part of the General Account of Great-West Life & Annuity Insurance Company. This Fund is comprised of corporate and U.S. government agency and other bonds. The objective of this Fund is to safeguard principal value and guarantee a minimum amount of interest for the life of the annuity contract. Provisions in the contract prevent the immediate and full payout of the contract value for Plan-initiated transactions.

Because the Fund is not benefit responsive at the Plan level, the fair market value is the relevant measurement attribute for the portion of the net assets available for benefits attributable to the Fund. Using a discounted cash flow valuation method where the interest rate for the investment contract is reset at least as frequently as annually, fair value of the investment contract, prior to contract termination, equals the contract value.

Note 7. Risks and Uncertainties

The Plan invested in mutual funds and a guaranteed interest fund. Such investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
