Reasonable Cause Letter

September 5, 2024

On August 27, 2024 I received a letter from the IRS concerning a missing form 5500 SF for Dr. Hector M Bush PC for the plan year ending 12-31-2022. The issue arose because in 2021, I executed an entity change with a new Tax ID number and the 5500 SF for 2022 was submitted under the new entity name "Hector M Bush DMD PLLC." As a result, the IRS was unable to make the connection to the previous filing. The letter prompted me to visit the EFAST website to locate all the forms that were filed for the company. I was shocked to discover that the form 5500 SF for plan year 2023 that was completed using our payroll company's (Paychex) website was never filed with the US Dept. of Labor. At no point did I receive any notification to let me know that the form was not received and had no way of knowing that there was an issue. After several calls and emails to both my payroll company and their Retirement Services Division I was instructed to contact EFAST for direction and they advised me to refile the 5500 SF for 2023 and attach this "Reasonable Cause Letter" to explain the situation. The payroll company provided me with a copy of the original 5500 SF for 2023 which I will attach when I submit the form. Please know that if I had known that the form was not submitted by the payroll company, I would have rectified the situation immediately. I would appreciate if any penalties for the late submission can be waived since the form was completed before the deadline but for some reason not filed with EFAST.
