### NOTE A – DESCRIPTION OF THE PLAN

The following description of the Kaiser Permanente Washington 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**Kaiser Permanente acquisition** – Kaiser Foundation Health Plan of Washington acquired and became the sole corporate member of Group Health Cooperative (Cooperative) on February 1, 2017. Following the acquisition, Kaiser Foundation Health Plan of Washington was renamed KFHPW Holdings, and the Cooperative was renamed Kaiser Foundation Health Plan of Washington (KFHPWA).

Effective February 1, 2017, the Board of Trustees of KFHPWA (the Board) amended the Plan to appoint the Kaiser Permanente Retirement Plans' Investment Committee (KPIC) as the named fiduciary as defined under Section 402(a) of the Employee Retirement Income Security Act of 1974 (ERISA), as amended for investment matters.

Effective February 1, 2017, the name of the Plan was changed from Group Health Cooperative Employee Defined Contribution Plan to Kaiser Permanente Washington 403(b) Plan.

Effective July 11, 2017, the Board amended the Plan to appoint the Kaiser Permanente Administrative Committee (KPAC) the Plan administrator of the Plan.

Effective December 29, 2023, the Board amended the Plan such that the Plan merged their assets and liabilities into the Kaiser Permanente Tax Sheltered Annuity Plan III. As a result of the Plan merger, assets of approximately \$849,199,000, including notes receivables from participants of approximately \$8,994,000, were transferred into the Kaiser Permanente Tax Sheltered Annuity Plan III as of December 29, 2023. The Plan provisions disclosed hereon after were applicable during 2023 and through December 29, 2023.

**General** – The Plan was a defined contribution plan established for the purpose of establishing investment arrangements for eligible employees of KFHPWA pursuant to Section 403(b) of the Internal Revenue Code (IRC). The Plan was subject to provisions of ERISA. KFHPWA is the Plan's sponsor. KPAC became Plan administrator effective July 11, 2017. Prior to that date, the Plan administrator was the Group Health Cooperative Pension and Deferred Compensation Plans Committee.

**Eligibility** – All employees of KFHPWA except leased employees and nonresident aliens were eligible to participate in the Plan.

**Trustees and custodian** – Vanguard Fiduciary Trust Company (Vanguard) served as the trustee for the mutual funds and collective investment funds. Global Trust Company and State Street Bank and Trust Company (State Street) served as the trustee and custodian, respectively, of the Stable Income Fund.

**Participant accounts** – Each participant's account was credited with the participant's contributions, as well as any relevant employer's contributions plus allocated plan earnings and losses and charged with administrative expenses. Allocations were based on participant account balances, as defined. The expenses incurred in operating the Plan, including the fees paid to accountants, legal professionals, and other plan service providers, could have been charged against the accounts of plan participants at the discretion of KPAC or KPIC (the Committees) as defined in the Plan document. Any actual administrative expenses charged to a participant's account would be reflected in the participant's quarterly account statement. The benefit to which a participant was entitled was based on the participant's vested account balance.

**Contributions** – Each year, participants could contribute up to 75% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

KFHPWA matched 50% of participant pre-tax contributions, excluding catch-up contributions, up to 4% of eligible compensation deferred to the Plan. Employees classified as temporary employees were eligible for the match on pre-tax contributions as of the six-month anniversary of their first employment date unless they were covered by a collective bargaining agreement which excludes temporary employees from participating in the Plan. Employees classified as medical residents were not eligible for the match. Contributions are subject to regulatory limitations.

**Vesting** – Participants were immediately and fully vested in their salary deferrals and KFHPWA's contributions, plus annual earnings thereon.

**Notes receivable from participants** – Participants could borrow from their pre-tax contribution, transfer, and rollover accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were issued by the Plan and secured by the balance in the participant's account. All loans should be repaid within a period of five years, unless the loan was used to purchase a principal residence, in which case, the loan must be repaid within a reasonable period of time not to exceed 30 years. Under the terms of the Plan agreement, plan loans would bear a reasonable rate of interest determined by the Plan administrator. Principal and interest was paid ratably through payroll deductions.

**Payment of benefits** – On termination of service, a participant should have elected to receive either a lump-sum amount equal to the value of the participant's account balance or payment in a series of annual or more frequent installments. Upon attainment of age 59½, a participant could elect to withdraw all or a portion of the value of the vested interest in his or her pre-tax contribution, transfer, and rollover accounts as a lump-sum distribution.

**Forfeitures** – Forfeitures were any amounts properly removed from a Plan account for any reason provided under the terms of the Plan other than a distribution of withdrawal pursuant to an appropriate election. Forfeitures were retained in the Plan and never reverted to the Plan Sponsor. Forfeiture amounts in a plan year were first used to restore rehired participants' and abandoned accounts. Then, to the extent forfeiture amounts remained, the Plan Administrator, in its discretion, could have used such remaining amounts to pay reasonable administrative expenses of the Plan or reduce future employer contributions. For the period ended December 29, 2023 and prior years, the Plan Administrator had used forfeiture amounts that remained after the reinstatement of rehired participants' and abandoned accounts to pay Plan administrative expenses and had not used forfeitures to reduce employer contributions.

### NOTE B – SIGNIFICANT ACCOUNTING POLICIES

The following are the significant accounting policies followed by the Plan.

**Basis of accounting** – The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles (GAAP).

**Use of estimates** – The preparation of financial statements in accordance with GAAP requires plan management to make estimates and assumptions that affect certain reported amounts in the financial statements and accompanying notes. Accordingly, actual results may differ from those estimates.

**Investment valuation and income recognition** – Investments were reported at fair value (except for the investment contract with MetLife which was valued at contract value—see Note D - Investment Contract with Insurance Company.) Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note C – Fair Value Measurements).

Purchases and sales of securities were recorded on a trade date basis. Net realized and unrealized appreciation (depreciation) was recorded in the accompanying Statements of Changes in Net Assets Available for Benefits as net appreciation (depreciation) in fair value of investments. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date.

**Notes receivable from participants** – Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants was recorded on the accrual basis. Delinquent notes receivable from participants were reclassified as distributions based upon the terms of the Plan document. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in the notes receivable from participants on the Statements of Net Assets Available for Benefits.

**Payment of benefits** – Benefits were recorded when paid.

**Administrative expenses** – Expenses for maintaining the Plan including the fees paid to accountants, legal professionals, and other plan service providers should be paid by the Plan. During the current year, these fees were paid by the Plan Sponsor. Investment advisory fees and other participant-initiated consulting fees are allocated based on participants' account balances and are included in administrative expenses.

**Subsequent events** – The Plan's financial statements have been evaluated for subsequent events or transactions for potential recognition through August 19, 2024, the date the financial statements are available to be issued. Plan management determined that there are no subsequent events or transactions that require disclosure to, or adjustment in, the financial statements.

### NOTE C – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used as of December 29, 2023 and December 31, 2022:

- Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that were registered with the Securities and Exchange Commission. These funds were required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan were deemed actively traded.
- Participant-directed brokerage accounts held mutual funds and common stock.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### NOTE D – INVESTMENT CONTRACT WITH INSURANCE COMPANY

Effective September 28, 2018, Kaiser Foundation Health Plan Inc. entered into a group annuity contract with MetLife. These accounts were credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan.

Contract value, as reported to the Plan by MetLife, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could have ordinarily directed the withdrawal or transfer of all or a portion of their investment at contract value.

There were no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate was based on a formula agreed upon with the issuer, but could not be less than 1.00%.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such value, which would limit the Plan's ability to transact at contract value with participants, is probable.

### **NOTE E – TAX STATUS**

The Plan meets the qualification requirements under Section 403(b) and was tax exempt under provisions of the Internal Revenue Code (IRC). The Plan was required to operate in conformity with the IRC to maintain its qualifications. The Plan administrator believes the Plan was being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan was qualified and the related trust was tax exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service (IRS). The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **NOTE F – PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments were managed by an affiliate of Vanguard. Vanguard was the trustee of the Plan. An affiliate of Vanguard also served as the recordkeeper. Transactions with the trustee and recordkeeper qualified as party-in-interest transactions.
