#### NOTE A – DESCRIPTION OF THE PLAN

The following description of the Kaiser Permanente Tax Sheltered Annuity Plan II (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General** – The Plan was established on July 21, 2014 (inception date), for the purpose of providing retirement benefits to employees who meet specified requirements. As of the inception date, all non-union employees formerly participating under the Kaiser Permanente Tax Sheltered Annuity Plan (TSA) started participating in this Plan.

The Plan was a 403(b)(7) defined contribution plan which was intended to comply with the applicable provisions of the Internal Revenue Code (IRC) and provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Effective December 29, 2023, the Kaiser Foundation Health Plan, Inc. (the Company) amended the Plan such that the Plan merged the assets and liabilities into the Kaiser Permanente Tax Sheltered Annuity Plan III. As a result of the Plan merger, assets of approximately \$6,843,664,000, including notes receivable from participants of approximately \$74,725,000, were transferred into the Kaiser Permanente Tax Sheltered Annuity Plan III as of December 29, 2023. The Plan provisions disclosed hereon after were applicable during 2023 and through December 29, 2023.

**Trustees and custodians** – Vanguard Fiduciary Trust Company (Vanguard) served as the custodian for the mutual funds. Metropolitan Life Insurance Company (MetLife) served as the custodian of the investment contract with insurance company.

**Participant accounts** – Each participant's account was credited with the participant's contributions, as well as any relevant employer's contributions plus allocated plan earnings and losses and charged with administrative expenses. Allocations were based on participant account balances, as defined. The expenses incurred in operating the Plan, including the fees paid to accountants, legal professionals, and other plan service providers, could have been charged against the accounts of plan participants at the discretion of the Administrative Committee or the Investment Committee (the Committees) as defined in the Plan document. During the current year, these fees were paid by the plan sponsor. Any actual administrative expenses charged to a participant's account would be reflected in the participant's quarterly account statement. The benefit to which a participant was entitled was based on the participant's vested account balance.

**Contributions** – A participant could elect to contribute 1% to 75% of eligible compensation as defined by the Plan document. The Employer made contributions for certain employee groups as defined by the Plan document. All contributions were subject to applicable limitations set by the Internal Revenue Service (IRS).

**Vesting** – Each participant was fully and immediately vested at all times in his or her employee contribution accounts unless a transfer account where the applicable vesting applies. Participant vested 20% per year of service in his or her employer contribution account and was 100% vested after 5 years of service.

**Notes receivable from participants** – A participant with a minimum account balance of at least \$2,000 could borrow up to the lesser of 50% of his or her account balance or \$50,000, reduced by the highest outstanding loan balances carried by the participant in this and/or all other employer plans during the 12-month period prior to the new loan. The term of the loan was limited to not more than 5 years, except for residential loans which may be extended up to 15 years. The interest rate was "Prime Rate" plus 1%. Loan repayments were made through payroll deductions and were credited to the participant's account.

**Payment of benefits** – A participant should be entitled to receive all or a portion of his or her account upon occurrence of the earlier of the participant's retirement, death, disability, or termination of employment, attainment of age 59 ½, or the participant's hardship, as determined by the Plan.

**Forfeitures** – Forfeitures were any amounts properly removed from a Plan account for any reason provided under the terms of the Plan other than a distribution of withdrawal pursuant to an appropriate election. Forfeitures were retained in the Plan and never reverted to the Plan Sponsor. Forfeiture amounts in a plan year were first used to restore rehired participants' and abandoned accounts. Then, to the extent forfeiture amounts remained, the Plan Administrator, in its discretion, could have used such remaining amounts to pay reasonable administrative expenses of the Plan or reduce future employer contributions. For the period ended December 29, 2023 and prior years, the Plan Administrator had used forfeiture amounts that remained after the reinstatement of rehired participants' and abandoned accounts to pay Plan administrative expenses and had not used forfeitures to reduce employer contributions.

#### NOTE B – SIGNIFICANT ACCOUNTING POLICIES

The following are the significant accounting policies followed by the Plan.

**Basis of accounting** – The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles (GAAP).

**Use of estimates** – The preparation of financial statements in accordance with GAAP requires plan management to make estimates and assumptions that affect certain reported amounts in the financial statements and accompanying notes. Accordingly, actual results may differ from those estimates.

**Investment valuation and income recognition** – Investments were reported at fair value except for the investment contract with MetLife which was valued at contract value (see Note D – Investment Contract with Insurance Company). Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note C – Fair Value Measurements).

Purchases and sales of securities were recorded on a trade date basis. Net realized and unrealized appreciation (depreciation) was recorded in the accompanying Statements of Changes in Net Assets Available for Benefits as net appreciation (depreciation) in fair value of investments. Interest income is recorded on the accrual basis. Dividends were recorded on the ex-dividend date.

**Notes receivable from participants** – Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants was recorded on the accrual basis. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in the notes receivable from participants on the Statements of Net Assets Available for Benefits.

**Payment of benefits** – Benefits were recorded when paid.

**Administrative expenses** – Expenses for maintaining the Plan including the fees paid to accountants, legal professionals, and other plan service providers should be paid by the Plan. During the current year, these fees were paid by the Plan Sponsor. Investment advisory fees and other participant-initiated consulting fees are allocated based on participants account balances and are included in administrative expenses.

**Subsequent events** – The Plan’s financial statements have been evaluated for subsequent events or transactions for potential recognition through August 19, 2024, the date the financial statements are available to be issued. Plan management determined that there are no subsequent events or transactions that require disclosure to, or adjustment in, the financial statements.

### **NOTE C – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used as of December 31, 2022:

- Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### NOTE D – INVESTMENT CONTRACT WITH INSURANCE COMPANY

Kaiser Foundation Health Plan Inc. entered into a group annuity contract with MetLife. MetLife maintained the contributions in separate accounts. These accounts were credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan.

Contract value, as reported to the Plan by MetLife, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants should have ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate was based on a formula agreed upon with the issuer, but should not be less than 1.00%.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the prohibition competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under Employee Retirement Income Security Act of 1974.

#### NOTE E – TAX STATUS

The Plan met the qualification requirements under Section 403(b) and was tax exempt under provisions of the IRC. The Plan was required to operate in conformity with the IRC to maintain its qualifications. The Plan administrator believes the Plan was being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan, as restated, as qualified and the related trust was tax exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **NOTE F – PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments were managed by an affiliate of Vanguard. Vanguard was the trustee of the Plan. An affiliate of Vanguard also served as the recordkeeper. Transactions with the trustee and recordkeeper qualified as party-in-interest transactions.
