INDEPENDENT AUDITORS' REPORT

To The Plan Administrative Committee
Reliant Funding 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Reliant Funding 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of November 3, 2023 and December 31, 2022 (in liquidation), and the related statement of changes in net assets available for benefits for the period from January 1, 2023 to November 3, 2023 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Reliant Funding 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from John Hancock Life Insurance Company as of November 3, 2023 and December 31, 2022, and for the period from January 1, 2023 to November 3, 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Reliant Funding 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Plan Termination and Basis of Accounting

As discussed in Notes 1, 2, and 3 to the financial statements, the plan sponsor formally approved the termination of the Plan effective on September 15, 2023 with final liquidation of all Plan assets occurring on November 3, 2023. As a result, the Plan has used the liquidation basis of accounting in presenting the 2023 and 2022 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Reliant Funding 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Reliant Funding 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Reliant Funding 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1 - Description of Plan

The following description of Reliant Funding 401(k) Plan (the “Plan”) provides only general information of the profit-sharing plan and related trust. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan, which was established on September 1, 2017, is a defined contribution plan covering the employees of Reliant Services Group, LLC DBA Reliant Funding Company (“Reliant Funding”) who have completed three months of employment and are age 21 or older. The Plan was later amended to cover employees of Merchant Capital Access, LLC (Reliant Funding and Merchant Capital Access, LLC are collectively referred to as the “Sponsor”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Reliant Funding is the plan administrator and is responsible for oversight of the Plan. The Benefit Practice is the Plan's third-party administrator. The custodian of the Plan is John Hancock Life Insurance Company (the “Custodian”). John Hancock Insurance U.S.A. is the recordkeeper of the Plan.

In August 2023, the Plan was amended, and the plan sponsor approved the termination of the Plan effective as of September 15, 2023 (the “effective date”) (Note 3). As a result, the Plan has used the liquidation basis of accounting in presenting the 2023 and 2022 financial statements (see Note 2).

As of the effective date, there was no benefit accruals permitted and no participants were permitted to enter the Plan after September 15, 2023. All participants in the Plan became 100% vested as of the effective date and their account balances will be distributed as lump-sum distributions. As of the report date, participant account balances have been distributed, with full liquidation of the Plan being completed on November 3, 2023.

Contributions

Each year, participants may contribute up to 100% of their pre-tax compensation, as defined in the Plan, provided that such contributions do not exceed the limitations under the Internal Revenue Code (the “Code”) for 2023 of \$22,500, plus a maximum of \$7,500 in catch-up contributions for participants who have attained age 50 before the end of the Plan year. Contributions may be made as a pre-tax deferral or after-tax (Roth) deferral. Highly compensated employees are subject to additional limits set forth in the Code. Participants may also contribute amounts representing rollover distributions from other qualified defined benefit or defined contributions plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Contributions (cont'd.)

Effective January 1, 2022, the Plan added a safe harbor enhanced matching contribution wherein the Sponsor will make a safe harbor matching contribution equal to 100% of the participant's salary deferral, not to exceed 5% of eligible compensation. The safe harbor matching contribution is 100% vested. Participants are eligible to participate in the matching contribution when they have completed one year of service and have attained age 21. The matching contributions are invested as directed by the participant. For the period from January 1, 2023 to November 3, 2023, the Sponsor made matching contributions of \$130,584.

Beginning on the effective date of the Plan's termination of September 15, 2023, the Plan no longer will provide the safe harbor matching contribution and any other matching contributions provided by the Plan.

Participant Accounts

Each participant account is credited with the participant's contributions and rollover contributions and an allocation of the Sponsor's contributions, if any, as well as an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Sponsor's contribution portion of their accounts is based on years of continuous service as follows:

<u>Years of Service</u>	<u>Vesting Percentage</u>
At least 1 but less than 2	20%
At least 2 but less than 3	40%
At least 3 but less than 4	60%
At least 4 but less than 5	80%
5 or more years	100%

In addition, a participant becomes 100% vested in all allocated Sponsor contributions upon death, disability or the attainment of age 65 while employed by the Sponsor.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account. A participant requesting a Plan loan must have a minimum vested account balance of \$2,000 to be eligible. The loans are secured by the balance in the participant's account and bear interest at one percentage point above the prime rate, as defined by the Plan. The interest rate is determined as of the date of origination and is fixed for the loan term. Principal and interest is paid ratably through monthly payroll deductions over a period not to exceed five years, unless the funds are used to acquire a principal residence, in which case the maximum repayment period is thirty years. At November 3, 2023, the balance of notes receivable from participants totaled \$0.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or partial withdrawals or installments but only with respect to minimum required distributions, over a period of not more than assumed life expectancy. For termination of service for other reasons, a participant may elect a rollover or a direct transfer.

Note 2 - Summary of Significant Accounting Policies

Forfeitures

At November 3, 2023 and December 31, 2022, forfeited nonvested accounts totaled \$0 and \$63,812, respectively. These accounts will be used first to pay Plan expenses, with any remaining amounts to be used to reduce future employer contributions. In 2023, the Plan did not use any forfeited nonvested accounts to pay Plan expenses.

Basis of Accounting

Due to the termination of the Plan on September 15, 2023, the accompanying financial statements as of November 3, 2023, for the period from January 1, 2023 to November 3, 2023, and as of December 31, 2022, have been prepared using the liquidation basis of accounting. This basis of accounting is appropriate for a terminating plan and requires Plan assets to be reported at their current market values, reflecting the amounts expected to be realized upon final disposition.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Note 2 - Summary of Significant Accounting Policies (cont'd.)

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisers. See Note 5 for a discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of November 3, 2023. Delinquent notes receivable from participants are reclassified as distributions once the participant is no longer employed by the Sponsor. At November 3, 2023, the balance of notes receivable from participants totaled \$0.

Payment of Benefits

Benefit payments are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation or depreciation in fair value of investments. Certain administrative functions are performed by officers or employees of the Sponsor. No such officer or employee receives compensation from the Plan.

Note 3 - Termination of Plan

On August 9, 2023, the plan sponsor approved an amendment to terminate the Plan as of September 15, 2023. On September 15, 2023, the Company sent out an announcement to all participants notifying them of the expected termination date. As a result, the liquidation basis of accounting was adopted by the Plan during the year ended December 31, 2022.

After the effective date of plan termination, the remaining assets were to be distributed to the participants and beneficiaries within a reasonable time period. Upon termination of the Plan, all affected participants' accrued benefits became fully vested. The Plan did not pay any fees in relation to the plan termination. Final liquidation of all Plan assets occurred on November 3, 2023.

Note 5 - Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) Topic 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Note 5 - Fair Value Measurement (cont'd.)

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at November 3, 2023 and December 31, 2022.

Pooled separate accounts: The fair values of the underlying mutual funds are publicly quoted pricing inputs and are used in determining the net asset value of the pooled separate accounts, which are publicly quoted.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of difference methodologies or assumptions to determine the fair value of certain financial instruments could result in a different estimate of fair value at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value at December 31, 2022. Classification within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Since all Plan assets were liquidated as of November 3, 2023, there were no assets at fair value held at November 3, 2023. For the period from January 1, 2023 to November 3, 2023, there were no transfers between Levels 1 and 2 and no transfers in or out of Level 3.

Note 6 - Related Party Transactions and Party-In-Interest Transactions

Certain Plan investments are managed by John Hancock Life U.S.A., which is the recordkeeper of the Plan and an affiliate of the custodian; therefore, transactions related to this entity qualify as party-in-interest transactions. Amounts paid to the recordkeeper were \$36,056 during the period from January 1, 2023 to November 3, 2023.

Notes receivable from participants also qualify as party-in-interest transactions.

Note 7 - Tax Status

The underlying volume submitter plan has received an opinion letter from the Internal Revenue Service dated March 31, 2014, stating that the written form of the underlying document is qualified under Section 401(a) of the Code. Any employer adopting this form of the plan will be considered to have a plan qualified under Section 401(a) of the Code. Therefore, the related trust is tax-exempt. Once qualified, the plan is required to operate in conformity with the Code to maintain its qualified status. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes the Plan is being operated, in all material respects, in compliance with the applicable requirements of the Code, and therefore believes the Plan, as amended, is qualified and the related trust is tax-exempt. The Sponsor has indicated that it will take the necessary steps, if any, to maintain the Plan's qualified status.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that at November 3, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or require disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2020.

Note 8 - Subsequent Events

The Plan administrator has evaluated all events or transactions that occurred after November 3, 2023 through September 5, 2024, which is the date that these financial statements were available to be issued. During this period, there were no material subsequent events requiring disclosure.
