## Independent Auditor's Report

To the Plan Administrator  
The Americas 403(b) MEP as adopted by The Joseph P. Addabbo Family Health Center, Inc.

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We were engaged to perform audits of the financial statements of The Americas 403(b) MEP as adopted by The Joseph P. Addabbo Family Health Center, Inc. (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of October 31, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period from January 1, 2023 to October 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of October 31, 2023 and December 31, 2022, and for the period from January 1, 2023 to October 31, 2023, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

### *Disclaimer of Opinion*

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matters described in the *Basis for Disclaimer of Opinion* section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

### *Basis for Disclaimer of Opinion*

The Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financials may have been affected by these conditions.

Further, as described in Note 2 to the financial statements, the Plan has excluded from investments in the accompanying statements of net assets available for benefits certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have also been excluded in the accompanying statement of changes in net assets available for benefits. The amount of these excluded annuity contracts and custodial accounts and the related income and distributions are not reasonably determinable. Accounting principles generally accepted in the United States of America require that these accounts and related income and distributions be included in the accompanying financial statements.

#### *Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting*

As further discussed in Note 1 to the financial statements, the Board of Directors of the Plan approved a plan of liquidation on August 15, 2023, and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2022 financial statements to the liquidation basis of accounting used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

#### *Responsibilities of Management for the Financial Statements*

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

#### *Auditor's Responsibilities for the Audit of the Financial Statements*

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue our auditor's report. However, because of the matters described in the *Basis for Disclaimer of Opinion* section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

*Other Matter*

*Supplemental Schedule Required by ERISA*

The supplemental Schedule of Delinquent Participant Contributions (Schedule H, Line 4a) for the period from January 1, 2023 to October 31, 2023 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matters described in the *Basis for Disclaimer of Opinion* section of our report, it is inappropriate to and we do not express an opinion on this supplemental schedule.

October 31, 2023**

**Note 1 - Description of Plan**

The following description of The Americas 403(b) MEP as adopted by The Joseph P. Addabbo Family Health Center, Inc. (the "Plan") provides only general information. Participants should refer to the Plan document, and any amendments thereto, for a more complete description of the Plan's provisions.

**General**

The Plan, which was adopted on January 1, 1998, is a contributory Internal Revenue Code ("IRC") Section 403(b) defined contribution retirement plan covering all eligible employees of The Joseph P. Addabbo Family Health Center, Inc. (the "Center"). On August 1, 2021, the Center executed a participation agreement to become a participating employer in The Americas 403(b) MEP, an open multiple employer plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Center's Board of Directors is responsible for oversight of the Plan. Plan management determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Center's Board of Directors.

In August 2023, the Center made the decision to terminate the Plan and executed a participation agreement to become a participating employer in the newly formed Americas 403(b) PEP, a pooled employer plan. All contributions to the Plan ceased in August 2023 and participants became eligible to participate in the Americas 403(b) PEP on September 1, 2023. The Plan subsequently transferred all investment assets to the Americas 403(b) PEP.

**Contributions**

Each year, participants may make salary deferral contributions to the Plan equal to a percentage of their pre-tax annual compensation, as defined by the Plan. The Plan also allows participants to designate all or a portion of their salary deferral contributions as Roth deferral contributions. Eligible employees may begin to make salary deferral contributions to the Plan immediately following their date of hire. Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan includes an Automatic Contribution Arrangement where all newly eligible employees and existing employees without a current salary deferral election will be automatically enrolled in the Plan at a pre-tax deferral rate of 1%. Automatically enrolled participants will have their contributions invested in a default investment option until changed by the participant. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a variety of pooled separate accounts, mutual funds, a stable value fund and fully benefit-responsive investment contracts as investment options for participants.

The Center may make discretionary nonelective contributions to the Plan. Any discretionary nonelective contributions made to the Plan will be allocated pro-rata in the ratio that each participant's compensation bears to the total compensation of all eligible participants, as defined by the Plan. Participants must complete at least 1,000 hours of service during the Plan year and be actively employed on the last day of the Plan year to share in an allocation of the Center's discretionary nonelective contributions. Collective bargaining (union) employees are excluded from receiving any discretionary nonelective contributions. The Center elected to not make any discretionary nonelective contributions to the Plan for the period from January 1, 2023 to October 31, 2023. Participants also direct the investment of the Center's contributions. All contributions are subject to certain IRC limitations.

**Participant accounts**

Each participant's account is credited with the participant's contributions, as well as an allocation of the Center's discretionary nonelective contributions and Plan earnings. Participant accounts are also charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in all contributions to their account plus actual earnings thereon.

**Notes receivable from participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their elective deferral account balance. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates for similar loans from commercial lending institutions as approved by the Plan administrator at the time the note is issued. Principal and interest are paid ratably through payroll deductions.

**Payment of benefits**

The Plan's policy for the payment of benefits is as follows: (1) on termination of service for any reason, participants with a vested account balance less than \$1,000 will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, (2) for terminated participants with a vested account balance greater than \$1,000, but less than \$5,000, the Plan administrator will make a direct rollover of the participant's account to an individual retirement account designated by the Plan administrator unless the participant makes an affirmative election, and (3) participants with a vested account balance greater than \$5,000 may receive their benefits in the form of a lump-sum distribution, substantially equal installments, in the form of an annuity or defer payment of benefits to a later date, as outlined in the Plan.

Participants who have reached age 59½ may withdraw all or a portion of their vested balance in their account prior to termination for any reason. Withdrawals from the vested portion of a participant's account may also be made in the event of a financial hardship, in accordance with the provisions specified in the Plan. Participants may make withdrawals from the rollover contribution portion of their account at any time.

**Note 2 - Summary of accounting policies**

**Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

The Plan was established in 1998 and was historically viewed as an amalgamation of individual annuity and custodial accounts, and the Plan administrator and its service providers did not maintain financial information at a Plan level. Because historical records were not maintained or were not available at the Plan level, the Plan may have excluded from the accompanying statements of net assets available for benefits certain annuity and custodial accounts, and related activity, issued to current and former employees prior to January 1, 2009. In recognition of these recordkeeping matters, the Department of Labor ("DOL") released Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements 403(b) Plans* ("FAB 2009-02"), as transitional relief to address situations where a Plan's management is not able to obtain historical records. If FAB 2009-02 is implemented, the DOL has indicated that they will not reject the Form 5500 where contracts are excluded, as long as certain conditions were met. Further, FAB 2009-02 suggests that plan administrators make good faith efforts to include known contracts. While the Plan administrator has, in good faith, included all known contracts, because of certain incomplete records, there is uncertainty that all contracts have been included. However, the Plan administrator believes that excluded annuity or custodial accounts, if any, would meet the conditions of FAB 2009-02. As discussed in Note 8, the Plan has received certified statements of completeness and accuracy from the Plan's custodians as of October 31, 2023 and December 31, 2022 and for the period from January 1, 2023 to October 31, 2023.

As part of historical records not being maintained since the Plan was established in 1998, participants may have individual balances with legacy custodians which are not reflected in the net assets as of January 1, 2009.

**Use of estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition**

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Notes receivable from participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of October 31, 2023 and December 31, 2022.

**Payment of benefits**

Benefits are recorded when paid.

**Administrative expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Center. Expenses that are paid by the Center are excluded from these financial statements. Fees related to the administration of notes receivable from participants, annual record-keeping charges and overnight mailing fees are charged directly to the participant's account and are included in administrative expenses. Certain indirect investment-related expenses are included in the net appreciation in fair value of investments.

**Subsequent events**

The Plan has evaluated subsequent events through August 28, 2024, the date the financial statements were available to be issued.

**Note 3 - Fair value measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820, *Fair Value Measurement*, are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value as of December 31, 2022.

*Mutual funds:* Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The funds held by the Plan are deemed to be actively traded.

*Pooled separate accounts:* Valued using the accumulation unit value, which is based on the fair value of the underlying assets of the account. The accumulation unit value is deemed equivalent to NAV, which is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchase and sales) may occur daily.

*Stable value fund:* Valued at the NAV of units of the stable value fund. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the stable value fund, the issuer of the fund reserves the right to temporarily delay withdrawal from the fund in order to ensure that securities liquidations will be carried out in an orderly business manner.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2022. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

As a result of the Plan termination, all investment assets were subsequently transferred to the Americas 403(b) PEP. Therefore, there were no assets remaining in the Plan as of October 31, 2023.

**Note 4 - Investment contracts with insurance company**

The Plan has entered into fully benefit-responsive guaranteed investment contracts with Voya Retirement Insurance and Annuity Company ("VRIAC") totaling \$14,520,395 as of December 31, 2022. VRIAC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The issuer of the guaranteed investment contracts is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note 2, because the guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contracts. The guaranteed investment contracts are presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by VRIAC, represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rates are based on a formula agreed upon with the issuer, but they may not be less than the guaranteed minimum interest rate of 4.0%. Such interest rate is reviewed on a periodic basis for resetting.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers, and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

There were no changes in the value of participant accounts as a result of the Plan termination and subsequent transfer of assets to the Americas 403(b) PEP.

**Note 5 - Related party transactions and party-in-interest transactions**

Plan assets include investments in pooled separate accounts and fully benefit-responsive investment contracts held by VRIAC. Plan assets also include mutual funds and a stable value fund held by Reliance Trust Company. VRIAC and Reliance Trust Company are the custodians as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Indirect fees incurred by the Plan for certain investment management services are included in the net appreciation in fair value of investments. Fees paid directly by the Plan to the custodians for administrative expenses and other investment management fees amounted to \$18,929 for the period from January 1, 2023 to October 31, 2023. The Center pays directly any other fees related to the Plan's operations. The Plan allows participants to take loans against their account balances, which are also considered party-in-interest transactions.

**Note 6 - Tax status**

The Plan has been designed using a volume submitter 403(b) plan document sponsored by Pentegra Services, Inc. Pentegra Services, Inc. received an advisory letter dated March 31, 2017, in which the Internal Revenue Service ("IRS") stated that the volume submitter 403(b) plan document, as then designed, satisfies the applicable requirements of the IRC. Although the Plan itself has not received a determination letter from the IRS, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, the Plan is deemed to be qualified and tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7 - Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 8 - Certified investments**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at October 31, 2023 and December 31, 2022, and investment income and interest income on notes receivable from participants for the period from January 1, 2023 to October 31, 2023, that are disclosed in the accompanying financial statements were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by VRIAC and Reliance Trust Company, the custodians of the Plan.

**Note 9 - Nonexempt transactions**

As reported on the supplemental Schedule of Delinquent Participant Contributions (Schedule H, Line 4a), certain participant contributions were not remitted to the Plan within the time frame specified by the DOL's Regulation 29 CFR 2510.3-102, thus constituting nonexempt transactions between the Plan and the Center for the period from January 1, 2023 to October 31, 2023. The supplemental schedule includes delinquent participant contributions of \$2,912 and \$3,835 pertaining to payroll periods for the year ended December 31, 2022 and 2021, respectively.

Delinquent participant contributions pertaining to the year ended December 31, 2021 have been fully corrected through a corrective contribution of lost earnings of approximately \$6 that was deposited into the Plan and allocated to affected participants in August 2023. The Center is still in the process of correcting the delinquent participant contributions pertaining to the year ended December 31, 2022.
