Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

### **Auditor’s Responsibilities for the Audit of the Financial Statements**

Except as described in the “Scope and Nature of the ERISA Section 103(a)(3)(C) Audit” section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor’s report that includes our opinion. *Reasonable assurance* is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with U.S. GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- We evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, and we evaluate the overall presentation of the financial statements.
- We conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Supplemental Schedules Required by ERISA**

### **Note A - Description of the Plan**

The following description of the Strategic Staffing Solutions, Inc. 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### *General*

The Plan, established on January 1, 1991 and restated as of January 1, 2016, is a defined contribution plan covering essentially all employees of Strategic Staffing Solutions, Inc. (a Michigan corporation), Strategic Staffing Solutions, LC and Strategic Staffing Solutions Management, LLC (collectively known as the “Company” or “Employer”). All employees who have completed 90 days of employment and have attained age 21 are eligible to participate in the Plan on the first day of the month after the employee meets the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act (“ERISA”).

The trustees of the Plan are certain officers of the Company and have discretionary authorization over the investment of Company contributions.

#### *Contributions*

Each participant may elect to contribute up to 100 percent of total compensation not to exceed annual limitations established by the Internal Revenue Code (“IRC”).

Eligible employees who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions in accordance with, and subject to limitations of, IRC Section 414(v).

The Employer match is discretionary. The Company elected not to contribute to the Plan for the years ended December 31, 2023 and 2022.

#### *Transfers from Qualified Plans*

Participants may transfer amounts from other qualified plans, provided that such transfer does not affect the tax exempt status of the Plan.

#### *Participant Accounts*

Each participant’s account is credited with the participant’s contributions and allocations of plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### *Vesting*

Participants are immediately vested in their voluntary contributions and transfers from other qualified plans plus actual earnings thereon. Participants become fully vested in the Company's contribution portion of their accounts once they have completed three years of credited service with the Company.

#### *Payment of Benefits*

Benefits are distributable upon reaching normal retirement age of 65 or upon election at age of 59 ½ so long as the participant has not severed employment with the Company. Upon death or disability of a participant before retirement age or other termination of employment, all amounts vested in the participant's account, as defined by the Plan, shall become distributable. Benefits are payable in the form of lump-sum payments in accordance with the Plan.

Participants may apply for a distribution due to financial hardship, which may not exceed the lesser of the amount required to meet the financial need or the total of the participant's elective account.

#### *Notes Receivable from Participants*

Loans are available to Plan participants at the trustees' discretion. Participants may borrow the lesser of \$50,000 or 50 percent of the participant's vested account balance at the origination of the loan. The loans are secured by the balance in the participant's account and, generally, are to be repaid over a period not to exceed five years. The loans will bear interest at a rate comparable to prevailing interest rates charged on similar commercial loans under like circumstances by persons in the business of lending money, ranging from 4.25 percent to 9.5 percent for the year ended December 31, 2023. Principal and interest are paid ratably through payroll deductions.

### **Note B – Summary of Significant Accounting Policies**

A summary of the significant accounting policies applied in preparation of the accompanying financial statements follows.

#### ***Basis of Accounting***

The financial statements are prepared under the accrual method of accounting.

#### ***Use of Estimates***

In preparing financial statements in accordance with accounting principles generally accepted in the United States of America, management and the plan administrator are required to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities, if any. Actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. Quoted market prices are used to value investments. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year end. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

#### ***Notes Receivable from Participants***

Notes receivable from participants are recorded at cost, plus accrued interest. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be a distribution, the participant note receivable balance is reduced and a benefit payment is recorded. A valuation allowance for credit losses is not considered necessary as of December 31, 2023 and 2022.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### *Fair Value Measurements*

The Plan uses fair value measurements in the preparation of its financial statements, which utilize various inputs, including those that can be readily observable, corroborated, or are generally unobservable. The Plan utilizes market-based data and valuation techniques that maximize the use of observable inputs and minimize the use of unobservable inputs. Additionally, the Plan applies assumptions that market participants would use in pricing an asset or liability, including assumptions about risk.

The measurement of fair value includes a hierarchy based on the quality of inputs used to measure fair value. Financial assets and liabilities are categorized into this three-level fair value hierarchy based on the inputs to the valuation technique. The fair value hierarchy gives the highest priority to quoted prices in active markets for identical assets and liabilities and the lowest priority to unobservable inputs.

The various levels of the fair value hierarchy are described as follows:

- Level 1 - Financial assets and liabilities whose values are based on unadjusted quoted market prices for identical assets and liabilities in an active market that the Plan has the ability to access
- Level 2 - Financial assets and liabilities whose values are based on quoted prices in markets that are not active or model inputs that are observable for substantially the full term of the asset or liability
- Level 3 - Financial assets and liabilities whose values are based on prices or valuation techniques that require inputs that are both unobservable and significant to the overall fair value measurement

The use of observable market data, when available, is required in making fair value measurements. When inputs used to measure fair value fall within different levels of the hierarchy, the level within which the fair value measurement is categorized is based on the lowest level input that is significant to the fair value measurement.

#### *Administrative Expenses*

Expenses in connection with administering the Plan are paid from the respective fund assets and charged to the participants' accounts. Other administrative expenses associated with the Plan are paid by the Company.

#### *Subsequent Events*

The Plan's management has evaluated subsequent events through August 15, 2024, the date that the accompanying financial statements were available to be issued.

### **Note C - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right at any time to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants would be fully vested in their employer contributions.

### **Note D – Income Tax Status**

The Plan is utilizing the Volume Submitter Profit Sharing Plan with Cash or Deferred Arrangement prototype plan document. Wells Fargo has received an opinion letter from the Internal Revenue Service, dated March 31, 2014, stating that the written form of the underlying prototype plan document is qualified under section 401(a) of the IRC and that any employer adopting this form of the Plan will be considered to have a plan qualified under IRC section 401(a). The Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. In addition, the Plan administrator is not aware of any uncertain tax positions or unrecognized tax benefits as of December 31, 2023 or 2022. Therefore, no provision for income taxes has been included in the Plan's financial statements.
