INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator
USA Environment LP 401(k) Profit Sharing Plan and Trust:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements

We have performed an audit of the financial statements of USA Environment LP 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

1. Description of Plan

The following description of the USA Environment LP (the "Company") 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, effective May 20, 2011, covering all full-time employees of the company, except for union employees and nonresident aliens. Employees are eligible to participate in the Plan on the first day of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Plan Merger

On September 27, 2023, USA Environment LP was acquired by ENTACT, LLC. Effective January 1, 2023, the Plan was merged into ENTACT, LLC Savings Plan, an existing plan administrated by ENTACT, LLC and no additional contributions allowed to the plan. The accounts of all plan participants transferred out of the Plan to ENTACT, LLC Savings plan, no balances remained in the Plan as of March 2, 2023.

Administration

The Plan is administered by the Company (the "Plan Administrator"). John Hancock Trust Company (the "Trustee") serves as the Plan's trustee. John Hancock Retirement Services ("John Hancock") served as the Plan's custodian and recordkeeper.

Contributions

Each year participants may contribute a portion of their pretax annual compensation not to exceed the limitation (\$20,500 in 2022), set forth in Section 402(g) of the Internal Revenue Code ("IRC"). Participants may also rollover amounts representing distributions from other qualified plans. Participants may make catch-up contributions, pre-tax contributions that exceed the annual elective deferral limit, during any calendar year ending on or after the participant's 50th birthday. Participants' total catch-up contributions for the year 2022 cannot exceed \$6,500.

The Company matched 100% of the 4% of base compensation that employees contribute to the plan. The Plan also provides for discretionary employer contributions and Qualified Non-Elective Contributions ("QNEC") to be contributed at the option of the Company. During the year ended December 31, 2022, the Company made matching contributions of \$465,781. No discretionary employer contributions were made in 2022.

Participant Accounts

Each participant's account is credited with the participant's contribution, Plan earnings, the Company's matching contribution and allocations of any discretionary employer contributions. Allocations of net Plan earnings are based on the ratio of the participant's account balance to all participant account balances within each fund, as defined by the Plan.

Upon the occurrence of a distribution event, the benefit to which a participant is entitled is the benefit that can be provided from the participant's vested interest in his or her account.

Notes Receivable from Participants

Participants may borrow from their fund accounts at a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance. Loan terms range from 1 to 5 years or up to 10 years for the purchase of a primary residence. The loans are secured by up to 50% of the vested balance in the participant's account and bear interest at the prime rate plus 1% as determined by the Plan documents. As of December 31, 2022, interest rates on participant loans were ranging from 4.25% to 8.00%. Principal and interest payments are made by means of payroll withholdings according to the terms of the respective promissory note. Under the terms of the Plan, a participant may have only one loan at any given time. Participant notes receivable outstanding at March 2, 2023 and December 31, 2022 totaled \$0 and \$582,596, respectively.

1. Description of Plan, continued

Payment of Benefits

Upon termination of employment due to death, disability, or retirement, a participant (or his/her designated beneficiary in the event of death) may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Instead of a lump-sum amount, a participant may elect to receive his or her vested account balance in monthly, quarterly, semiannual, or annual installments. For termination of employment due to other reasons, the vested interest in his or her account may be distributed as a rollover to another plan or a lump-sum distribution.

In-Service withdrawals are allowed by the Plan from the participant's fully vested account balance after the participant has attained age 59 1/2. Prior to age 59 1/2 and subject to guidelines set forth in the Internal Revenue Code, a participant may request a hardship withdrawal.

Forfeited Accounts

All employer contributions credited to a participant's account, but not vested, are forfeited by the participant upon termination. Such forfeited balances are used to reduce employer contributions. As of March 2, 2023 and December 31, 2022, forfeited non-vested accounts totaled \$0 and \$1.50, respectively. During the period from January 1, 2023 through March 2, 2023 and year ended December 31, 2022, the Plan used \$0 and \$40,584, respectively, forfeitures to reduce employer contributions.

Administrative Expenses

Trustee and administrative fees are the responsibility of the Plan. These fees may be paid by the Company, at its discretion. Expenses incurred for transfer and loan transactions are deducted from the participant's account.

Expense Offset Arrangements

Fees incurred by the Plan for the investment management services, trustee fees and recordkeeping are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results may differ from these estimates.

Risks and Uncertainties

The Plan provides for various investment options which are exposed to various risks, such as interest rate risk, market risk and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and Statements of Changes in Net Assets Available for Benefits.

Investment Valuation and Revenue Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Net appreciation in fair value of investments includes realized gains and losses on investments sold during the year and unrealized net appreciation of investments held at the end of the year. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of March 2, 2023 and December 31, 2022 as the Plan determined the notes receivable had adequate collateral. If a participant ceases to make loan payments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Benefit Payments

Benefits are recorded when paid.

3. Fair Value Measurements

ASC 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

3. Fair Value Measurements, continued

In determining the fair value of the assets and liabilities, the Plan generally uses two approaches, the market approach and the cost approach. The market approach uses prices and other relevant data based on market transactions involving identical or comparable assets. The cost approach is the amount that would be currently required to replace an asset and indicates the cost to the Plan to require a substitute asset.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. (Market approach)

Money market fund: Valued at amortized cost, which approximates fair value and is classified within level 2 of the valuation hierarchy. (Cost approach)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan held no investment at March 2, 2023. The following tables set forth by level, within the fair value hierarchy, the Plan's assets measured at fair value on a recurring basis as of December 31, 2022:

4. Information Certified by the Trustee (Unaudited)

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participant at March 2, 2023 and December 31, 2022, and net appreciation in fair value of investments, interest income from notes receivable from participant and interest and dividends for the period from January 1, 2023 through March 2, 2023 and year then ended December 31, 2022, was obtained or derived from the information supplied to the Plan administrator and certified as complete and accurate by John Hancock Trust Company.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

5. Tax Status

The Plan is based on a non-standardized prototype plan. The prototype plan received an opinion letter dated May 18, 2015, in which the Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan Trustee and Administrator believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, accordingly, that the trust maintained in connection with the Plan is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if Plan management has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of March 2, 2023 and December 31, 2022, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Party-In-Interest Transactions

The Plan allows participants to borrow from their vested balances. These transactions qualify as party-in-interest transactions, as defined by ERISA. However, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA.

7. Subsequent Events

The Plan management has evaluated subsequent events through August 19, 2024, which is the date the financial statements were available to be issued, and noted no other significant events to be reported.
