## **1. Description of Plan**

The following description of the Buckley LLP Profit Sharing and Section 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the provisions of the Plan.

### **General**

The Plan was a defined contribution plan covering all eligible employees and partners of Buckley LLP (the Firm). The Plan was amended and restated effective January 1, 2015. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The asset custodian and record keeper of the Plan was Vanguard Fiduciary Trust Company (Vanguard).

### **Plan Merger**

Effective January 31, 2023, the Firm merged with Orrick, Herrington & Sutcliffe LLP. As of the merger date, the Plan was amended to be closed to new employees and rehires; service requirements for eligible Firm employees who had not satisfied the service requirements prior to the merger date were waived; and the Plan was closed to ineligible employees who transferred to an eligible employee position after the merger date. Effective April 30, 2023, the Plan was frozen for the Firm's eligible current and former employees or partners (Pre-Merger Employees). Pre-Merger Employees were made eligible to actively participate in the Orrick, Herrington & Sutcliffe Plans (Orrick Plans) beginning May 1, 2023, subject to the terms of the Orrick Plans. Effective for the plan year beginning on or after January 1, 2023, profit sharing contributions were discontinued. The net assets of the Plan were transferred to the Orrick, Herrington & Sutcliffe LLP Retirement Plan on November 14, 2023, resulting in the termination of the Plan.

### **Eligibility**

All nonpartner employees were eligible to participate in the Plan and to make employee contributions on the first day of the month following the date in which they first perform services. All partners were eligible to participate and to make elective deferral contributions on the first day of the month coincident with or the next following date in which they have completed a one month period of service.

### **Employees' and Partners' Contributions**

Participants could elect to have any amount of their compensation withheld from their pay as a dollar or percentage election and contributed to the Plan as either a pre-tax contribution or an after-tax Roth contribution. Participants age 50 or older could make pre-tax or Roth catch-up contributions. Participants' pre-tax and Roth contributions were limited to a combined \$22,500 and combined pre-tax and Roth catch-up contributions were limited to \$7,500 for the period from January 1, 2023 to November 14, 2023. Participants also could contribute rollover amounts, which represent distributions from other tax-qualified plans or individual retirement accounts.

### **Employer Profit Sharing Contributions**

The Plan provided for discretionary profit sharing contributions. Employees became eligible for profit sharing contributions on the first day of the month coincident with or following the date the employees complete six consecutive months of service. Employees had to be employed as of the last day of the plan year and be credited with at least 800 hours in order to be eligible for the profit sharing contribution. Contributions allocated to nonpartner employees were 5% or 7.5% of compensation depending on employee classification. Contributions allocated to partners were determined annually based on the maximum allowable contributions subject to Internal Revenue Code (IRC) limits. During 2023, there was \$13,484 in annual employer profit sharing contributions made to one partner related to the 2022 annual employer profit sharing contribution which was not accrued for as of prior year-end, December 31, 2022. There were no other employer profit sharing contributions for nonpartner employees or partners made in 2023.

## **Participant Accounts**

Individual accounts were maintained for each participant. Participants could direct their investments through a pre-selected group of mutual funds offered by the trustee. Alternatively, participants could direct their investments through individual self-directed brokerage accounts held by the trustee. The account of each participant was credited with (a) the participant's contributions and rollovers; (b) an allocation of any applicable Firm contributions, if eligible; and (c) an allocation of plan earnings or losses, based on the participant's investments. The account balances could be charged for fees related to transactions and loans. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

## **Vesting**

Participants were fully and immediately vested in their before-tax and after-tax contributions as well as their employer profit sharing contributions, plus actual earnings thereon. Therefore, participants would not have forfeitures related to these contributions if they terminated from the Plan.

## **Notes Receivable From Participants**

Active participants could borrow from their accounts, in accordance with the loan policy established in accordance with the Plan. Participants could borrow between \$1,000 to a maximum equal to the lesser of 50% of their vested account balances or \$50,000, less their highest outstanding loan balances within the last 12 months. General loans were available for terms of up to five years. Loans for the purchase of a primary residence could have terms beyond five years. The interest rate on loans was fixed at the time of the loan application and was equal to the prime rate quoted in The Wall Street Journal plus 1.00%. As of December 31, 2022, interest rates on outstanding loans ranged from 4.25% to 8.00%. Loans were secured by the participants' account balances and became due and payable upon termination of employment.

## **Payment of Benefits**

A participant was entitled to receive a distribution of his/her vested benefits upon termination of service with the Firm. Certain hardship and in-service withdrawals by active employees or partners were allowed, as determined by the plan administrator, to the maximum amount available for hardship and in-service distribution in the account of the participant.

## **Administrative Expenses**

Partners and employees of the Firm provided services to the Plan. None of these individuals or the Firm received compensation from the Plan. Substantially all administrative expenses were paid by the Firm for the period from January 1, 2023 to November 14, 2023. Recordkeeping and investment management fees are offset against net appreciation or depreciation in fair value of investments on the accompanying statement of changes in net assets available for benefits.

## **2. Summary of Significant Accounting Policies**

### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

### **Investment Valuation and Income Allocation**

The investments of the Plan were stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Refer to Note 3 for details on inputs, valuation techniques and fair value measurement levels within the fair value hierarchy.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis, and dividends are recorded on the ex-dividend date.

Net appreciation or depreciation of investments included in the accompanying statement of changes in net assets available for benefits includes realized gains or losses from the sale of investments and unrealized appreciation or depreciation in fair value of investments. Net unrealized appreciation or depreciation in fair value of investments represents the net change in the fair value of the investments held during the year. The net realized gains or losses on the sale of the investment represent the difference between the sale proceeds and the fair value of the investment as of the beginning of the year or the cost of the investment if purchased during the year.

The Plan held assets in a common collective trust (CCT). The fair value of this fund was determined using the net asset value (NAV) of the fund. The NAV was determined by the fund's trustee using the fair value of the underlying securities within the fund at year end.

### **Use of Estimates**

The preparation of financial statements, in conformity with U.S. GAAP, requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results may differ from those estimates.

### **Payment of Benefits**

Benefits were recorded when paid.

### **Notes Receivable From Participants**

Notes receivable from participants were measured at their unpaid balances plus any accrued but unpaid interest. Delinquent participant loans were reclassified as distributions based upon the terms of the plan document.

### **Subsequent Events**

In preparing the accompanying financial statements, the Firm has evaluated events and transactions for potential recognition or disclosure through August 28, 2024, the date the accompanying financial statements were available to be issued.

### **3. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets for liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022.

The fair values of the Plan's investments in mutual funds were based on quoted market prices of the shares held by the Plan at year end. Accordingly, these fair value measurements are classified as having used Level 1 inputs.

The CCT represented the Plan's stable value product. The CCT's portfolio invested in a variety of investment contracts, including traditional guaranteed investment contracts (GICs), security backed investment contracts (also known as synthetic GICs) and separate account GICs, cash or cash equivalents and other collective investment trusts. Interest was credited to the portfolio under "wrapper" contracts. The CCT was valued using the NAV provided by the administrator of the fund. The NAV was based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. As the NAV of the funds is a practical expedient, these investments are not included in the fair value hierarchy.

Self-directed brokerage accounts consisted of investments in cash and cash equivalents, common stock and mutual funds. The investments in cash and cash equivalents, common stock and mutual funds accounts are based on quoted market prices. Accordingly, these fair value measurements were classified as having used Level 1 inputs.

The plan sponsor is responsible for the determination of fair value. Accordingly, the plan sponsor performed periodic analysis on the prices received from the pricing services used to determine whether the prices are reasonable estimates of fair value. As a result of these reviews, the plan sponsor has not historically adjusted the prices obtained from the pricing services.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 4. Information Certified by Trustee

### **5. Related-Party and Party in Interest Transactions**

Certain investments were managed by affiliates of the trustee as defined by the Plan, and therefore, these transactions are considered party in interest transactions. Fees paid by the Plan for the investment management services are with the trustee and are party in interest transactions. These fees are included in net appreciation in fair value of investments.

### **6. Tax Status**

The Internal Revenue Service (IRS) has determined and informed the Firm by a letter dated February 22, 2016, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan was qualified, and the related trust is tax-exempt.

U.S. GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **7. Concentrations**

As of December 31, 2022, 17% of the Plan's net assets available for benefits were concentrated in one individual investment.
