Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Chicago Parts & Sound, LLC 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 14, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period from January 1, 2023 to December 14, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (a qualified institution).

Management has obtained certifications from the qualified institution as of December 14, 2023 and December 31, 2022, and for the period from January 1, 2023 to December 14, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by the qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

As described in Note 1, the Plan merged into the Choice Pooled Employer Plan I ("PEP") effective October 1, 2023. All assets of the Plan, amounting to \$2,222,683, were transferred to the PEP. As a result, the Plan ceased to exist as of December 14, 2023. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of Plan

The following description of the Chicago Parts & Sound, LLC 401(k) Profit Sharing Plan (the "Plan") is provided for general information only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution profit sharing plan covering all eligible employees of Chicago Parts & Sound, LLC, (the "Employer" or the "Company"). Employees were not eligible to participate in the Plan if they were: union employees, nonresident aliens, or employees acquired in a 410(b)(6)(C) transaction. For purposes of employee deferrals and matching contributions, employees were eligible for participation upon attainment of 21 years of age and completion of two months of service. For purposes of profit sharing contributions, employees were eligible for participation if the employee: attained 21 years of age, was employed on the last day of the Plan year, and completed six months of service during the Plan year. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan merged into a pooled employer plan named Choice Pooled Employer Plan I ("PEP") effective October 1, 2023. All assets of the Plan, amounting to \$2,222,683, were transferred to the PEP. As a result, the Plan ceased to exist as of December 14, 2023. The following attributes of the Plan were based on the plan document prior to the transfer.

Contributions

Each year, eligible employees could elect to contribute a portion of their eligible compensation on a pre-tax or Roth basis, subject to limitations established by the Internal Revenue Code ("IRC"). The Plan included an auto enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default rate set at 4% of eligible compensation on a pre-tax basis. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified retirement plans.

The Employer could make a discretionary matching and/or profit-sharing contribution in an amount determined by the Employer for those eligible employees. For the period from January 1, 2023 to December 14, 2023, no discretionary matching or profit-sharing contributions were made to the Plan.

Participant Accounts

Each participant's account was credited with the participant's contributions and allocations of (a) the Employer's contribution and (b) Plan earnings (losses) thereon. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that can be provided from a participant's vested account.

Vesting

Participants were vested immediately in their contributions plus actual earnings thereon. Vesting in Employer matching and profit-sharing contributions is as follows:

Forfeitures

At December 14, 2023 and 2022, forfeited non-vested accounts totaled \$0 and \$0. These accounts could be used to reduce administrative expenses or Employer contributions. During 2023, \$13,276 of forfeitures were used to reduce administrative expenses and none were used to reduce Employer contributions.

Notes Receivable from Participants

Participants could borrow from their accounts a minimum amount of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, whichever is less. The loans were secured by the balance in the participant's account and bear interest at rates equal to 1% above the prime rate. Principal and interest was paid ratably through payroll deductions. The loan had to be repaid within a period not to exceed five years from the date the participant receives the loan, unless the loan was for the purchase of the participant's principal residence, in which case the loan could be repaid within a longer repayment term.

Payment of Benefits

Upon termination of service due to death, disability, retirement or other reason, a participant was entitled to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

Benefits could also be distributed in the event of a participant's immediate and heavy financial need. Such distributions, which were considered hardship withdrawals, cannot exceed the amount required to relieve the financial need.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”), which requires management to make estimates and assumptions that affect assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value was measured using the net asset value (“NAV”) per share as a practical expedient were not categorized within the fair value hierarchy.

Investment Valuation and Income Recognition

All of the Plan’s investments were stated at fair value. Mutual funds held by the Plan were valued at fair value based on the daily closing price as reported by the funds. All of the mutual funds were registered with the Securities and Exchange Commission. The funds were required to publish their daily net asset value and to transact at that price. These funds were deemed to be actively traded. The common/collective trust was valued at the NAV of units held by the Plan. The NAV, as provided by the trustee, was used as a practical expedient to estimate fair value. The NAV was based on the fair value of the underlying investments held by the fund less its liabilities.

Purchases and sales of securities are recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation in fair value of investments included the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceased to make loan repayments and the plan administrator deemed the participant loan to be in default, the participant loan balance was reduced and a benefit payment was recorded.

Payments of Benefits

Benefits were recorded when paid.

Expenses

Certain expenses of maintaining the Plan were paid by the Employer and were excluded from these financial statements. Investment related expenses were included in net appreciation in fair value of investments.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is August 22, 2024.

3. Information Certified (Unaudited)

Certain information related to investments disclosed in the accompanying financial statements including investments held at December 31, 2022, and net appreciation in fair value of investments, and interest and dividends for the period from January 1, 2023 to December 14, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, a qualified institution.

(*) As discussed in Note 2, investments that were measured using the practical expedient were not classified within the fair value hierarchy.

Common/Collective Trust

The Plan invested in the MetLife Stable Value Fund (the "Fund") which was a collective investment trust that was formed for the purpose of allowing plan sponsors of defined contribution plans qualified under Sections 401(a) and 501(a) of the IRC, to invest in the MetLife Group Annuity Contract 25053 and MetLife Group Annuity Contract 37000. The contracts were issued by Metropolitan Life Insurance Company to Reliance Trust Company, who was the trustee of the Fund.

Units of the Fund were valued daily. Unit purchases and redemptions were transacted at the NAV determined as of the close of business each day. The NAV per unit was computed by dividing the total assets of the Fund, less its liabilities, by the total number of units outstanding at the time of such computation. Investment income earned was reinvested in the Fund and included in the determination of unit values.

5. Party-in-Interest Transactions

Participants who were active employees could borrow from their accounts and such loans qualified as exempt party-in-interest transactions under ERISA. These loans were recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain employees of the Employer performed administrative services related to the Plan; the Employer paid the salaries of these individuals and no costs were charged to the Plan.

Reliance Trust Company was the trustee of the common/collective trust and the trustee and custodian of the Plan. Therefore, these transactions qualified as exempt party-in-interest transactions.

6. Tax Status

The Plan's prototype document preparer has obtained an opinion letter dated June 30, 2020 from the Internal Revenue Service ("IRS") stating that the Plan is designed in accordance with applicable sections of the IRC. The plan administrator believed that the Plan was operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by the taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.
