Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Curative 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of January 01, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period ended January 01, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Note 1 – Description of the Plan

The following description of the Curative 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of Plan provisions.

General

Effective January 1, 2023, the Company became a participating employer in the TriNet Select 401(k) Plan and during 2023, the Plan assets were transferred to the TriNet Select 401(k) Plan. The provisions below describe the Plan prior to the merger.

The Plan is a defined contribution plan covering substantially all employees of Curative Inc. and Curative Health Holdings Inc. (collectively the Company) who have completed 2 months of service and are 18 years of age or older. Excluded employees include employees whose employment is governed by a collective bargaining agreement under which retirement benefits were subject to good faith bargaining, nonresident aliens with no US source income, residents of Puerto Rico, and leased employees. Employees can enter the Plan immediately upon meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to 100% of their annual compensation, as defined in the Plan, into a pre-tax or after-tax deferral account, subject to limits of the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions (rollovers) from other qualified plans. Participants are automatically enrolled in the Plan at a 1% deferral rate unless they affirmatively elect not to participate in the Plan.

The Company makes a safe-harbor matching contribution equal to 100% of the participant's deferrals up to 3% of eligible compensation. The Plan also allows the Company to make discretionary matching and profit sharing contributions. To be eligible for the discretionary profit sharing contribution, a participant must be employed at year end. There are no additional allocation requirements for participants to receive a discretionary matching contribution. No discretionary matching or profit sharing contributions were made during the periods presented.

Investment Elections

Participants direct the investment of their and the Company's contributions into various investment options offered by the Plan that are designated by the Plan's Administrative Committee. Participants can change their investment elections daily.

Participant Accounts

Each participant's account is credited with the participant's contribution, allocations of the Company's contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses and any related transaction fees for loans and distributions that are paid by the Plan. Allocations are made based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are always 100% vested in their deferrals and Company contributions, plus actual earnings thereon.

Payment of Benefits

On termination of service due to any reason, participants with vested account balances of \$1,000 or less receive an automatic lump-sum distribution, unless the participant requests that it be rolled-over to an Individual Retirement Account (IRA) provider or another qualified retirement plan. Participants with vested account balances of less than \$5,000 and more than \$1,000 receive a lump sum distribution or an automatic distribution to an IRA. Participants with vested account balances of \$5,000 or more may leave their balance in the Plan, elect to receive a single lump-sum amount, or choose to rollover their balance into another qualified retirement plan or IRA. Participants may also take in-service or hardship distributions subject to the terms of the Plan and IRS regulations.

Notes Receivable from Participants

The Plan allows participants to borrow against their vested account balances. Loans may not be made for less than \$1,000 and may not exceed the lesser of \$50,000 or 50% of a participant's vested account balance. The loans are secured by the balance in the participant's account and bear interest at the Wall Street Journal prime rate plus 1%. Participants may have one loan outstanding at a time. Principal and interest are paid ratably through payroll deductions not to exceed 5 years.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income (if applicable) is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed as they are incurred. No allowance for credit losses has been recorded as of January 01, 2023 and December 31, 2022. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Administrative Expenses

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. The Plan permits the payment of Plan expenses to be made from the Plan's assets. Fees are charged to participants on a pro rata basis, equally to participant accounts, or to a participant's account for transactions specifically related to that participant.

Certain investment management fees and other charges paid to the Custodian are offset against fund performance in the net depreciation in fair value of investments on the statement of changes in net assets available for benefits and are not, therefore, separately reflected as administrative expenses. Certain Plan expenses are paid directly by the Company and therefore are excluded from these financial statements.

Risks and Uncertainties

The Plan holds various investments. Investments are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Subsequent Events

The Plan has evaluated subsequent events through August 29, 2024, the date the financial statements were available to be issued.

Contributions

Contributions from Plan participants and the Company, when applicable, are recorded in the year in which the employee contributions are withheld from compensation.

Note 3 – Certified Information

Certain information disclosed in the accompanying financial statements, including investments and notes receivable from participants held at January 01, 2023 and December 31, 2022, and net depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period ended January 01, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Transamerica Life Insurance Company, Inc., the Custodian of the Plan.

Note 4 – Tax Status

The IRS has determined and informed by a letter for the prototype plan adopted by the Plan, dated June 30, 2020 that the prototype plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has not requested its own determination letter from the IRS. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 – Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: 1) quoted prices for similar assets or liabilities in active markets; 2) quoted prices for identical or similar assets or liabilities in inactive markets; 3) inputs other than quoted prices that are observable for the asset or liability; 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at January 01, 2023, and December 31, 2022.

Pooled Separate Accounts (PSA): PSAs invest in a variety of domestic stock, international stocks, mutual funds, bonds and other securities. The majority of the underlying securities have observable level 1 quoted pricing inputs. While the underlying asset values are generally based on publicly quoted prices, the net asset value (NAV) of each separate PSA is not valued using publicly quoted prices. The NAV provided by the fund managers is used as the practical expedient to estimate fair value. PSAs can be redeemed on a daily basis and each PSA has its own investment strategy. Participants should refer to the individual PSA's prospectus for a more complete description of the PSA and its investment strategy.

In accordance with Subtopic 820-10, certain investments listed above that were measured at NAV per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line item presented in the statements of net assets available for benefits. There are no unfunded commitments or redemption restrictions related to the PSAs. Participants can redeem their investments in the PSAs daily.

Note 6 – Guaranteed Investment Contract

The Plan invested in a stable value fund, the Transamerica Stable Value Advantage Option, issued by Transamerica Life Insurance Company (Transamerica). The stable value fund was considered to be a fully benefit-responsive investment contract and was therefore reported at contract value. Contract value was the relevant measurement attribute for that portion of the net assets available for benefits because that was the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported by Transamerica, was the beginning balance plus any deposit and credited interest, less any withdrawals, charges or expenses, a measurement, which approximates fair value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract value of the investment contract at January 01, 2023 and December 31, 2022 was \$0 and \$171,491, respectively.

The Transamerica Stable Value Advantage Option is an investment choice held by the general account of Transamerica. The assets in the general account were supported by the financial stability of Transamerica. While Transamerica declares interest rates and backs the principal and interest of this investment choice, any guarantees are subject to the claims paying ability of the insurance company. There were no reserves against the contract value for credit risk of Transamerica or otherwise. The effective credited interest rate is set semi-annually and effective on January 1st and July 1st of each year. Contract charges may reduce this return.

Certain events might have limited the ability of the Plan to transact at contract value with Transamerica. Such events include the following: (1) the Plan is changed so as to significantly affect Transamerica's obligations to the contract, (2) the contract can no longer be treated as a pension plan contract, (3) the Plan is terminated, (4) failure to comply with the contract's requirements, (5) failure to provide information, (6) the sum of the contract account values at any time equals \$20,000 or less, or (7) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator was not aware of any events, which would limit the Plan's ability to transact at contract value with participants that are probable.

Note 7 – Related-Party and Party-in-Interest Transactions

Certain Plan investments are managed by Transamerica Life Insurance Company, Inc., the Custodian as defined by the Plan, and therefore, these transactions qualify as exempt party-in-interest transactions. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to service providers. Loans to participants also qualify as party-in-interest transactions.

Note 8 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would remain 100% vested in their Company contributions.

Note 9 – Delinquent Employee Deferral Transmittals

During the year ended December 31, 2022, the Company erroneously failed to remit certain employee deferrals and loan repayments totaling \$364,541 to the Plan in the time period described in 29 CFR 2510.3-102. All contributions and loan repayments have since been remitted to the Plan. After the period ended January 01, 2023, the Company made a corrective contribution for lost earnings and completed the other corrections needed for the late contributions into the TriNet Select 401(k) Plan.

Note 11 – Self-Correction Program

The Company corrected certain operational errors related to the Plan's definition of compensation under the IRS's Employee Plan Compliance Resolution System using the Self-Correction Program.

During 2023, it was discovered that compensation provisions for the Plan were not properly applied in calculating employee deferrals and the Company's safe-harbor matching contribution. Certain eligible compensation was improperly excluded and did not result in a participant contribution or safe-harbor match. The Plan Administrator identified the affected participants and deposited a QNEC and lost earnings of \$383,481 for the year ended December 31, 2022, and \$224,245 for the year ended December 31, 2021, into the TriNet Select 401(k) Plan during 2024 to make the affected participants and the Plan whole. These amounts are included in the financial statements in the employer contribution receivable as of December 31, 2022 and in the Transfers from the Plan for the period ended January 01, 2023.
