### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Avenues Schools 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

### 1. Description of the Plan

The following description of Avenues Schools 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement or Summary Plan Description for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan, established by Avenues World Holdings LLC (the Company). The Plan was established on July 1, 2012, and subsequently restated September 1, 2015. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

In 2024, an amendment was made to the Plan to retroactively include Silicon Valley School, LLC (formerly Avenues Silicon Valley School, LLC), which has participated in the Plan since July 1, 2019.

#### *Trustee (Custodian) and Administration of the Plan*

The trustee and recordkeeper of the Plan is Fidelity Management Trust Company (Fidelity or Trustee). The administrator of the Plan is the Company. The Trustee holds all assets of the Plan in accordance with the service provider contract with the Company. The Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### *Eligibility*

All employees of the Company, except nonresident aliens and specialty instructors as defined by the Plan, are eligible to participate in the Plan upon attaining the age of 21. Participants enter the Plan on the first day of the month coinciding with or following the date eligibility requirements are met.

#### *Participant Contributions*

Participants may contribute up to the maximum amount allowed by law of their eligible annual compensation, subject to certain limitations, with the contributions and earnings thereon, being nontaxable until withdrawn from the Plan. Participants may also contribute amounts representing distributions from other qualified plans. Roth contributions and catch-up contributions for those aged 50 and older during the Plan year, subject to limitations, are allowed as well.

#### *Company Safe Harbor Contributions*

The Plan is a safe harbor 401(k) plan. To satisfy the safe harbor rules, the Company commits to making a contribution equal to 3% of each participant's annual compensation to the Plan on a per pay basis. This safe harbor election allows the Company to ensure that nondiscrimination regulations are met. All participants eligible for participant contributions are eligible for the safe harbor contribution.

### ***Company Profit-Sharing Contributions***

The Company may also make a discretionary profit-sharing contribution to the Plan on behalf of eligible participants, as defined by the Plan agreement. The discretionary profit-sharing contribution is to be allocated to each participant's account based on a ratio of each participant's eligible compensation to total eligible compensation for the period. The Company did not make any discretionary profit-sharing contributions for the years ended December 31, 2023 or 2022.

### ***Participant Accounts***

Each participant's account is credited with the participant's contributions, the Company's contributions, and earnings thereon. Participants are entitled to the benefit that can be provided from the participants' vested account. Participants may direct the investment of their account balances into various investment options offered by the Plan.

### ***Notes Receivable from Participants***

Participants may, under certain circumstances as defined by the Plan document, borrow up to the lesser of \$50,000 or 50% of their vested balance. The minimum note amount is \$1,000, and a participant may have no more than one note outstanding at any time. Notes are secured by the balance in the participant's account and bear interest at the prevailing rate charged by other lenders for similar notes. Interest rates on notes receivable were 5.25% to 10.50% at December 31, 2023. The notes are repaid ratably through payroll deductions over a period of five years or less, unless the note proceeds are used for the purchase of a principal residence. Notes become due immediately upon termination of a participant's employment.

### ***Payment of Benefits***

Upon termination of service, death, disability, retirement, or attainment of age 59½, a participant is entitled to a distribution of their vested account balance. Distributions are made in either a lump-sum equal to the value of the participant's vested interest in their account or a single sum distribution of a portion of their vested balance. If the vested account balance is less than \$1,000, the total balance will be paid in a lump-sum as soon as administratively feasible following a participant's termination. If the vested account balance is between \$1,000 and \$5,000, the balance will be distributed to an Individual Retirement Account (IRA) if a single lump-sum payment is not initiated by the participant. Hardship withdrawals, as defined by the Plan, are allowed from participants' elective accounts only.

### ***Vesting***

Participants are immediately vested in their contributions and in the Company's safe harbor contributions, plus earnings thereon. Vesting in the discretionary profit-sharing contribution and actual earnings thereon is based on years of continuous service. Participants begin vesting after one year of continuous service at a rate of 20% per year and become 100% vested after five years of credited service. Upon death, disability, or normal retirement (age 65), a participant becomes 100% vested in their Company discretionary profit sharing contributions.

### ***Forfeitures***

All forfeitures resulting from the withdrawal of participants prior to vesting are retained in the Plan and may be used to reduce Company contributions and administrative expenses. During the years ended December 31, 2023 and 2022, \$0 and \$7,324, respectively, were used to reduce Company contributions or administrative fees. There were \$1,080 and \$829 forfeitures available for such reductions as of December 31, 2023 and 2022, respectively.

## **2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements have been prepared on an accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

### ***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in the principal or most advantageous market for the asset in an orderly transaction between market participants on the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisor and Trustee. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2023 or 2022. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### ***Payment of Benefit***

Benefits are recorded when paid.

### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of the Plan, notes receivable from participants, and payment of benefits are charged directly to the participant's account and are included in administrative expenses. Total administrative expenses paid by the Plan for the years ended December 31, 2023 and 2022 were approximately \$145,000 and \$133,000, respectively.

### **3. Fair Value of Investments**

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for asset measurement at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

*Mutual Funds* - These assets are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at the price. The mutual funds held by the Plan are deemed to be actively traded, and therefore, considered to be Level 1 investments.

#### **4. Certified Investment Information**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2023 and 2022, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2023 and 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity, a qualified institution.

#### **5. Related Party and Party-in-Interest Transactions**

Certain Plan investments are units of mutual funds managed by Fidelity. Fidelity is the trustee, as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Plan investments include notes receivable from participants. These investments are also considered party-in-interest transactions. During the years ended December 31, 2023 and 2022, the Company paid approximately \$81,000 and \$76,000, respectively, for services provided to Fidelity.

#### **6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. All participants would become fully vested in their accounts.

#### **7. Income Tax Status**

The Plan adopted the Fidelity Management & Research Company volume submitter defined contribution plan. The volume submitter defined contribution plan received an opinion letter, dated June 30, 2020, in which the Internal Revenue Service (IRS) stated that the Plan, as designed, was in compliance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has

been amended since receiving the opinion letter, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and tax-exempt.

GAAP requires the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there currently are no audits for any tax periods in progress.

### **8. Risks and Uncertainties**

The Plan provides for investments in assets that are exposed to risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities may occur and materially affect participant account balances and the amounts reported in the accompanying statements of net assets available for benefits.

### **9. Late Remittances**

During the Plan year ended December 31, 2023 employee withholdings for deferred compensation and loan remittances in the amount of \$16,812, were not remitted within the normal remittance time period by the Company. The Company normally remits withholdings no later than one day after payroll date but due to the Company opening a new bank account this was delayed. These transactions constitute prohibited transactions, as defined by ERISA. The Company has taken the appropriate steps to correct the situation and has further implemented a procedure to ensure all future remittances are done within the normal remittance time period.

### **10. Subsequent Events**

The Plan's administrator has evaluated subsequent events through September 11, 2024, the date the financial statements were available to be issued. There were no other subsequent events requiring adjustments to the financial statements or disclosures as stated herein, except as follows:

In November 2023, the Company sold Avenues New York LLC to Nord Anglia Education. In April 2024, Avenues New York LLC established Avenues Schools 401(k) Plan (New Plan) and employees of Avenues New York LLC became participants of the New Plan. As a result, account balances in the Plan, of employees of Avenues New York LLC, amounting to \$30,562,536 were transferred to the New Plan. The remaining employees from the Company will continue to participate in the Plan. The Plan amended its Plan document effective July 11, 2024 to change the Plan name to Aeon School 401(k) Plan and Plan sponsor to Online Education Platform, LLC.

In 2024, an amendment was made to the Plan to retroactively include Silicon Valley School, LLC (formerly Avenues Silicon Valley School, LLC), which has participated in the Plan since July 1, 2019.
