We have performed audits of the financial statements of the Hammond School Defined Contribution Retirement Plan (the “Plan”), an employee benefit plan subject to ERISA, as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for Plan benefits as of November 30, 2023 and December 31, 2022, and the related statements of changes in net assets available for Plan benefits for the period from January 1, 2023 to November 30, 2023 and year ended December 31, 2022, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of and for the period from January 1, 2023 through November 30, 2023, and as of and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

As described in Note 1 to the financial statements, the Plan was merged into another qualified plan effective November 30, 2023. All assets were transferred to the other qualified plan on November 30, 2023.

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are issued.

1. Description of Plan

The following description of the Hammond School (the “School”) Defined Contribution Retirement Plan (the “Plan”) provides only general information. Participants may refer to the Plan’s documents for a more complete description of the Plan's provisions.

Plan Merger

During 2023, the Plan merged into a qualified pooled employer plan effective November 30, 2023. All plan assets were transferred to the other qualified plan in 2023.

General

The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the requirements of Section 403(b) of the Internal Revenue Code (“IRC”). Employees became participants in the Plan immediately. Employees became eligible for employer matching contributions on the first day of the month following the date on which they complete one year of service and attain age 21.

Contributions

The Plan allowed contributions of any portion of a participant’s pre-tax annual compensation, as defined in the Plan. Participants who had attained age fifty before the end of the plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing rollover distributions from other qualified benefit plans. Participants could direct the investment of their contributions into various investment options offered by the Plan. The Plan offered various registered investment companies, traditional benefit and non-benefit responsive annuity contracts, and a pooled separate account as investment options for participants.

In accordance with the Plan, the School contributed 5% of the participant’s pretax compensation to an employee’s account if the employee contributed at least 2%. If the employee elected a deferral percentage greater than 2%, they would not receive additional contributions from the School other than the 5% discussed above.

Participant Accounts

Individual accounts were maintained for each participant reflecting employee and employer contributions, investment income or losses, distributions, and an allocation of administrative expenses paid by the Plan. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant’s vested account.

1. Description of Plan (continued)

Vesting

Participants were immediately vested in their participant contributions, employer matching contributions, and actual earnings or losses thereon.

Payment of Benefits

Upon severance from employment, a participant could elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a specified period. Additionally, participants could elect to receive installments through insurance contracts (annuity settlements) directly from Teachers Insurance and Annuity Association, FSB ("TIAA"). Upon incurring a disability, attainment of 59½ years of age and at any time with respect to pre-1989 deferrals, a participant could receive distributions from his or her elective deferrals. Also subject to certain conditions, a participant could receive hardship withdrawals from his or her balance in the Plan while employed.

2. Basis of Presentation and Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared in accordance with accounting principles generally accepted in the United States ("US GAAP").

Estimates

The preparation of financial statements in conformity with US GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. See Note 4 for discussion of fair value measurements.

Investment Valuation and Income Recognition (continued)

The Plan's fully benefit-responsive fixed interest investment option with TIAA is maintained by TIAA. The account is credited with earnings (losses) on the underlying investments and charged for participant withdrawals and administrative expenses. The fixed interest investment option is contractually obligated to repay the principal and specific interest rate that is guaranteed to the Plan.

As the fixed interest investment option is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for plan benefits attributable to the fixed interest investment option. Contract value, as reported to the Plan by TIAA, represents contributions made under the contract, plus interest credited, plus any transfers in, less participant withdrawals and any transfers out. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with TIAA. Such events include the following: (1) amendments to the Plan documents, (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibition transaction exception under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at a different amount than contract value. The Plan administrator does not believe the occurrence of any such events is probable.

Traditional benefit and non-benefit responsive annuity contracts guarantee a minimum interest rate during the accumulation phase – generally 3%, but between 1% and 3% for some contracts. These guarantees of principal and minimum interest rates ensure that each participant's accumulation is protected from loss and will always increase in value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Gains and losses (realized and unrealized) included in the statements of changes in net assets available for plan benefits for the 11-month period from January 1, 2023 to November 30, 2023 and year ended December 31, 2022 are reported in the net appreciation (depreciation) in fair value of investments.

Payment of Benefits

Benefits were recorded when paid.

3. Trustee Certification

Information presented in the accompanying financial statements as of and for the 11-month period ended November 30, 2023 and the year ended December 31, 2022 related to investments, net appreciation (depreciation) in fair value of investments, interest and dividends, and notes receivable from participants was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by TIAA, the trustee of the Plan.

4. Fair Value Measurements

The Plan's investments in registered investment companies and the pooled separate accounts are valued at net asset value ("NAV"). The NAV, as provided by the issuer, is used as a practical expedient to estimate fair value. The NAV of each account is based on the fair value of the underlying investments held, less the account's liabilities. This practical expedient is not used when it is determined to be probable that the registered investment companies or pooled separate accounts will sell the investments for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

The Plan's investments are participant directed. The methods used to measure fair value may produce amounts that may not be indicative of net realizable values or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Plan Loans

Prior to December 2020, participants could borrow directly from TIAA using a portion of their plan accounts as collateral for any such loan ("collateralized loan"). Such loans are not recorded in the financial statements as they are not receivables to the Plan. The Plan's collateralized loan balances as of November 30, 2023 and December 31, 2022 were \$5,049 and \$13,784, respectively. The notes were collateralized by the balance in the participant's account and had an interest rate of 5.73% as of November 30, 2023 and December 31, 2022. Under the borrowing terms, 110% of outstanding loan balances must serve as collateral. Collateral balances as of November 30, 2023 and December 31, 2022, respectively, were \$5,554 and \$15,162.

5. Plan Loans (continued)

In the event of default, loans were reportable to Plan participants as taxable income but remained outstanding and accrued interest until the participant left the Plan. No Plan loans went into default during the 11-month period ended November 30, 2023. One Plan loan went into default during the year ended December 31, 2022.

6. Notes Receivable from Participants

Participants could borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000, or 50% of the participant's vested account balance. Both Plan loans and notes receivable from participants were required to be repaid within one to five years, except for loans made for the purchase of a primary residence, which had to be repaid within a period of no more than ten years. The participant's retirement account balance was reduced by the loan amount, and the proceeds were sent to the participant. The participant loan was collateralized by the remaining amount in the participant's account. Principal and interest were paid back to the participant's retirement account based on the investment allocation for contributions. Participant notes receivable as of November 30, 2023 and December 31, 2022 were \$0 and \$11,073, respectively, and had interest rates ranging from 4.25%.to 9.25%.

7. Party-in-Interest Transactions

Certain fees incurred during the year for legal, accounting and other services were paid by the School on behalf of the Plan. Certain Plan investments are shares of registered investment companies managed by affiliates of the trustee. These transactions, which qualify as party-in-interest transactions, are exempt from the prohibited transaction rules of ERISA.

8. Income Tax Status

No determination letter has been received for the Plan as it operated under a volume submitter plan document. The IRS issued an opinion letter for the volume submitter on August 7, 2017, stating that the form of the volume submitter plan was acceptable under Section 403(b) of the IRC for use by employers for the benefit of their employees. Through the date of plan merger, the Plan administrator believes the Plan was designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

US GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain tax position that more likely than not would not be sustained upon examination by the IRS. No such liabilities are recognized at November 30, 2023 and December 31, 2022. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.
