## Independent Auditor's Report

To the Plan Sponsor and Participants  
FirstService Residential Minnesota 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of FirstService Residential Minnesota 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of January 20, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period from January 1, 2023 through January 20, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the FirstService Residential Minnesota 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of January 20, 2023 and December 31, 2022, and for the period from January 1, 2023 through January 20, 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

# Independent Auditor's Report

## Emphasis of Matter

As discussed in Note 1 of the Plan's financial statements, all of the assets and liabilities of the FirstService Residential Minnesota 401(k) Plan were transferred to the FirstService Residential 401(k) Plan. The Plan was then terminated.

## Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about FirstService Residential Minnesota 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



### 1. Description of Plan

The following brief description of the FirstService Residential Minnesota 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more complete information regarding the Plan's definitions, benefits, eligibility requirements, and other matters.

#### **General**

The Plan was a defined contribution plan sponsored by FirstService Residential Minnesota, Inc. (the "Company" or "Plan Administrator"). The Company had appointed Associated Trust Company, N.A. (the "Trustee") to be the Trustee of the Plan. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"), and the Internal Revenue Code ("IRC"). The Plan also covered Gittleman Construction and Maintenance Corporation employees, a related employer.

#### **Termination of the Plan**

Effective January 20, 2023, all of the Plan assets of approximately \$13,725,000 were transferred into the FirstService Residential 401(k) Plan. Plan assets were distributed according to the provisions of the Plan documents. The Plan was then terminated.

#### **Eligibility**

Non-union employees were eligible to participate in the Plan immediately upon employment, which was the effective date. A participant had to complete and sign an application form authorizing contributions to the Plan from the participant's pay.

To be eligible for discretionary matching contributions, a participant had to complete one hour of service during the first two months of employment and be 21 years of age. After satisfying the service and age requirement, a participant would qualify for the match on the first day of each calendar month coinciding with the satisfaction of the service and age requirements.

#### **Contributions**

Participating employees could have contributed a percentage of their pretax annual compensation as defined in the Plan. Participants were also allowed to make Roth 401(k) deferrals. Participants could have contributed up to 100% of annual compensation.

Participants could have also contributed amounts representing distributions from other qualified plans (rollover contributions). The Plan also allowed catch-up contributions.

The Company could have made discretionary matching contributions. The Plan did not make any discretionary matching contributions during the period from January 1, 2023 through January 20, 2023.

All contributions were subject to certain limitations under the IRC.

#### **Participant Accounts**

Each participant's account was credited with the participant's contribution, rollover contributions, the Company's matching contributions, and an allocation of the Company's discretionary profit sharing contribution, and Plan earnings (losses). Allocation of profit sharing contributions was based on compensation. Earnings (losses) were allocated based on participants' account balances, as set forth in the Plan. Participants were also charged with an allocation of administrative expenses either proportionately based on the value of the account or as an equal amount based on number of participants in the Plan. The benefit to which a participant was entitled was the benefit that could have been provided from the participant's vested account.

#### **Investment Allocation**

Assets of the Plan were held in various funds as determined by the Plan. All accounts were participant-directed. Participants may change their investment allocation daily.

### 1. Description of Plan (Continued)

#### Vesting

Participants were immediately vested in their voluntary contributions plus actual earnings thereon. The Company's contributions were subject to a graded vesting schedule and were fully vested after three years of service. The vesting schedule was only applied to those participants entered into the Plan on or after January 1, 2020. Participants entered into the Plan before January 1, 2020 were fully vested in all employer matching contributions. Effective with the transfer of assets, all participants were 100% vested in their account balances.

#### Payment of Benefits

Distributions to terminated, disabled, or retired participants were made in the form of a single lump sum or installment payment to the participant (or in the case of death, to the participant's beneficiary) equal to the value of the participant's vested account. Distributions could have been made in the form of hardship withdrawals that could have been subject to early withdrawal penalties. In-service distributions were allowed under the Plan upon attainment of age 59½. Certain mandatory distribution provisions could have applied for smaller account balances of terminated employees.

#### Notes Receivable From Participants

Participants could have borrowed from their fund accounts a minimum of \$1,000 to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms were generally for up to five years unless the loan was for the purchase of a primary residence, in which case the term can be up to fifteen years. The loans were secured by the balance in the participant's account and bore interest at a rate of 2% above prime rate as determined by the Plan Administrator. Principal and interest were paid ratably through payroll deductions. The loans were transferred out of the Plan to the FirstService Residential 401(k) Plan.

### 2. Summary of Significant Accounting Policies

#### Accounting Estimates

Management uses estimates and assumptions in preparing these financial statements in accordance with accounting principles generally accepted in the United States of America. Those estimates and assumptions affect the reported amounts of assets and liabilities, and the changes therein, and the disclosure of contingent assets and liabilities. The most significant estimate relates to the valuation of investments. Actual results could differ from those estimates; the effects could be material.

#### Basis of Accounting

The financial statements of the Plan were prepared under the accrual method of accounting.

#### Investment Valuation and Income Recognition

The Plan's investments were stated at fair value. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants (in other words, not a forced liquidation or distressed sales) at the measurement date.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Realized gains and losses on investments bought and sold during the period, as well as unrealized gains and losses on investments held during the period, were presented in the net appreciation in fair value of investments.

#### Payment of Benefits

Benefit payments were recorded when paid.

#### Contributions

Employee contributions were recorded by the Plan in the period the employer makes the payroll deductions. Discretionary employer match contributions were recorded in the same period as the participant contributions. Other discretionary employer contributions were recorded in the period the Company authorizes the contribution. No contributions were recorded by the Plan during the period from January 1, 2023 through January 20, 2023.

#### Administrative Expenses

The Plan was responsible for paying administrative expenses.

#### Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. The Plan would treat any notes receivable from participants as delinquent if any scheduled payments remained unpaid beyond the last day of the calendar quarter following the calendar quarter in which the participant missed the scheduled payment. Delinquent notes receivable from participants were reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses had been recorded as of January 20, 2023 and December 31, 2022.

#### Fair Value of Financial Instruments

The Plan's accounting for fair value measurements of assets and liabilities that were recognized or disclosed at fair value in the financial statements on a recurring or nonrecurring basis adheres to the Financial Accounting Standards Board (FASB) fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.
- Level 2 Inputs are inputs other than quoted prices included in Level 1 inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3 Inputs are unobservable inputs for the asset or liability used to measure fair value to the extent that observable inputs are not available, thereby allowing for situations in which there is little, if any, market activity for the asset or liability at measurement date.

The level in the fair value hierarchy within which a fair measurement in its entirety falls is based on the lowest level input that is significant to the fair value measurement in its entirety. The Plan uses valuation techniques in a consistent manner from year to year.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at January 20, 2023 and December 31, 2022.

- Shares of registered investment companies - mutual funds were valued at the net asset value of shares held by the Plan at year end using quoted market prices.
- The investments in common collective trust funds were stated at fair value based on the fair market value of the underlying investments. The underlying investments were primarily domestic and international stocks, U.S. Treasuries, and bonds. Net asset value (NAV) practical expedient was determined each business day by the Trustee. Participant redemptions can be transacted daily with a one day redemption notice period. There were no unfunded commitments.

#### Fair Value of Financial Instruments (Continued)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Securing Strong Retirement Act

In December 2022, Securing a Strong Retirement Act (SECURE 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2020 CARES Act. Most of the provisions of SECURE 2.0 will become effective in 2024 and beyond. Therefore, there was no current impact to the Plan. Due to the Plan's merger into the FirstService Residential 401(k) Plan in January 2023, the provisions in SECURE 2.0 will not be adopted and will have no effect on the Plan.

#### Subsequent Events

The Plan has evaluated subsequent events for recording or disclosure in the financial statements through February 12, 2024, the date which the financial statements were available to be issued.

### **4. Certification of Information From Plan Trustee**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan's Trustee, Associated Trust Company, N.A., has certified that the following data included in the accompanying financial statements and supplemental schedule was complete and accurate:

- Investments, at fair value and notes receivable from participants, as shown in the accompanying statements of net assets available for benefits as of January 20, 2023 and December, 2022.
- Net appreciation in fair value, interest and dividends, and other income, as shown in the statement of changes in net assets available for benefits for the period from January 1, 2023 through January 20, 2023.
- Schedule H, Line 4a – Schedule of Delinquent Participant Contributions for the period from January 1, 2023 to January 20, 2023.

At the direction of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

### **5. Party-In-Interest Transactions**

Certain Plan investments (primarily the common collective trust funds) were issued by Associated Trust Company, N.A. Associated Trust Company, N.A. was the Trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees paid to the Trustee by the Plan for investment management services amounted to approximately \$0 and \$114,000 for the period from January 1, 2023 through January 20, 2023, and for the year ended December 31, 2022, respectively. Notes receivable from participants also qualified as party-in-interest transactions. The ERISA of 1974 provides an exemption for such transactions.

### **6. Tax Status**

The Plan adopted a pre-approved profit sharing plan of the Trustee which obtained an opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the pre-approved profit sharing plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan had been amended since the pre-approved profit sharing plan received the opinion letter. However, the Plan Administrator believes the Plan was currently designed and was being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America required Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan had taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan was subject to routine audits by taxing jurisdictions; however, there were currently no audits for any tax periods in progress.

### **7. Risks and Uncertainties**

The Plan invests in various investment securities. The Plan's investments were exposed to various risk factors, such as interest rates, market conditions, and credit risk. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investment securities, it was possible that changes in risk factors in the near term could have materially affected the amounts reported in the financial statements.

### **8. Timely Remittance of Employee Contributions**

During the year ended December 31, 2022, the Company was untimely in remitting certain contributions in the amount of approximately \$54,000 to the Plan. The late remittances were not fully corrected as of January 20, 2023.
