Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Brewster 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Notes to Financial Statements December 31, 2023

Note 1 - Description of Plan

The following description of the Brewster 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established for all eligible employees of Brewster Home Fashions, LLC (the "Company"), as defined. Nonresident aliens, leased employees, independent contractors and residents of Puerto Rico are not eligible to participate. The Plan allows for eligible participants to contribute to the Plan pre-tax or after-tax to receive Company matching contributions immediately upon their date of hire, which are allocated based on participant investment elections. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan administrator is responsible for oversight of the Plan. The Plan administrator determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Company's Board of Directors.

Effective December 31, 2023, all remaining assets of \$18,022,222 were transferred to the York Design Group 401(k) Plan and the Plan was terminated.

Contributions

Participants may elect to contribute up to 100% of their annual compensation through pre-tax or after-tax Roth deferrals up to annual regulations, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation, which is increased annually by 1%, up to a maximum deferral percentage of 10%, and their contributions are invested in a designated balanced fund until changed by the participant.

The Company may, at its discretion, make matching contributions equal to a percentage of the deferral elected by eligible participants as defined by the Plan. During the year ended December 31, 2023, the Company made matching contributions for employees with five years of service or less of 25% of the first 6% of their eligible compensation, and for employees with greater than five years of service of 37.5% of the first 6% of eligible compensation. Participants also direct the investment of their employer matching contributions into various investments offered by the Plan. The Company may also make discretionary non-elective contributions to the Plan; however, none were elected for the year ended December 31, 2023. Participants also direct the investment of Company contributions. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Participant accounts

Each participant's account is credited with the participant's contributions and Company contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and Company matching contributions plus actual earnings thereon. Vesting in the Company discretionary contribution portion of their account plus actual earnings thereon is based on years of service, as defined by the Plan, and participants are 100% vested after six years of service as indicated in the following schedule:

In the event of death, total and permanent disability or normal retirement, participants shall become 100% vested in the remaining unvested employer contribution portion of their account.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. Loan interest rates are charged based on rates available for similar loans from commercial lending institutions, which historically has been considered *The Wall Street Journal* prime rate plus 1%. Principal and interest are paid ratably through monthly payroll deductions.

Payment of benefits

On termination of service due to death, disability or retirement, a participant may elect to receive a lump sum or payments in installments in the amount equal to the value of the participant's vested interest in his or her account. For terminated participants with a vested account balance greater than \$1,000, but less than \$5,000, the Plan administrator will make a direct rollover of the participant's account to an individual retirement account designated by the Plan administrator unless an election is made by the participant to receive the payment directly. Participants with a vested account balance greater than \$5,000 may receive benefits in the form of a lump sum, in installments, or defer payment of benefits until a later date.

Participants who are at least 59 and a half years of age may withdraw all or a portion of the balance in their account prior to termination for any reason. Withdrawals from a participant's account balance may also be made in the event of a financial hardship, in accordance with the provisions specified in the Plan.

Forfeited accounts

Forfeited non-vested amounts may be used to pay administrative expenses or offset employer contributions in accordance with the Plan. At December 31, 2023 and 2022, there were \$0 and \$1, respectively, of forfeited non-vested amounts available. During 2023, no forfeitures were used to offset employer contributions.

Note 2 - Summary of accounting policies

Basis of accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting, consistent with accounting principles generally accepted in the United States of America ("GAAP").

Use of estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from these estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023 or 2022.

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Subsequent events

The Plan has evaluated subsequent events through September 11, 2024, the date the financial statements were available to be issued.

Note 3 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest

priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820, *Fair Value Measurement*, are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust: Valued at the NAV of units of a bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

Pooled separate accounts: Valued using the accumulation unit value, which is based on the fair value of the underlying assets of the account. The accumulation unit value is deemed equivalent to NAV, which is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. In accordance with Subtopic 820-10, investments measured at NAV per share (or its equivalent) are not classified in the fair value hierarchy.

Note 4 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. Effective December 31, 2023, the Plan was merged into the York Design Group 401(k) Plan and the Plan was terminated.

Note 5 - Income tax status

The prototype plan document, which the Plan has adopted via a non-standardized adoption agreement, obtained its latest opinion letter dated June 30, 2020 in which the Internal Revenue Service ("IRS") stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 - Related-party and party-in-interest transactions

Certain Plan investments in pooled separate accounts and common collective trusts are managed by Principal Trust Company ("Principal") and its affiliates. Principal is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan allows participants to take loans against their account balances, which are also considered party-in-interest transactions. The Plan Sponsor pays directly any other fees related to the Plan's operations. Total administrative fees paid directly by the Plan to Principal were \$4,802.

The Plan entered into a revenue sharing agreement with Principal to establish an expense budget account for purposes of paying certain Plan expenses. The expense budget account totaled \$0 and \$2,074 as of December 31, 2023 and 2022, respectively. The Plan did not receive any revenue sharing credits from Principal during the year ended December 31, 2023. No amounts were used to offset Plan expenses during the year ended December 31, 2023.

Note 7 - Certified investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2023 and 2022 and investment income and interest income on notes receivable from participants for the year ended December 31, 2023, that are disclosed in the accompanying financial statements, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, the trustee of the Plan.
