Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Pacific Northwest College of Art Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of November 27, 2023 (in liquidation) and June 30, 2023 (ongoing), and the related statement of changes in net assets available for benefits for the period from July 1, 2023 through November 27, 2023 (the period ended November 27, 2023) (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Pacific Northwest College of Art Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of November 27, 2023 and June 30, 2023, and for the period ended November 27, 2023, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Pacific Northwest College of Art Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Pacific Northwest College of Art Retirement Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- exercise professional judgment and maintain professional skepticism throughout the audit.
- identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Pacific Northwest College of Art Retirement Plan's internal control. Accordingly, no such opinion is expressed.
- evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Pacific Northwest College of Art Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As further discussed in Note 1 to the financial statements, the Board of Trustees of Willamette University (on behalf of Pacific Northwest College of Art Retirement Plan), the Plan's sponsor, adopted a resolution to terminate Pacific Northwest College of Art Retirement Plan effective September 30, 2023. In accordance with accounting principles generally accepted in the United States of America, Pacific Northwest College of Art Retirement Plan has changed its basis of accounting from the ongoing basis of accounting used in presenting the financial statements to the liquidation basis of accounting used in presenting the financial statements. Our opinion is not affected with respect to this matter.

Pacific Northwest College of Art Retirement Plan Notes to the Financial Statements

Note 1 – Description of Plan

The following description of the Pacific Northwest College of Art Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement, as amended, for a more complete description of Plan provisions.

General – The Plan is a 403(b) defined contribution plan covering substantially all employees of Pacific Northwest College of Art and is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Pacific Northwest College of Art (the College) is the Plan's sponsor and serves as Plan administrator. The custodians of the Plan are TIAA and CREF and The Variable Life Insurance College (VALIC), collectively the custodians. All participant account balances are held by the custodians.

The College merged with Willamette University effective June 30, 2021, with Willamette University as the surviving corporation. Employees who were employed by the College on June 30, 2021, and continued to be employed by Willamette University on September 30, 2021, became eligible to participate in the Willamette University Defined Contribution Retirement Plan, sponsored by Willamette University, as of October 1, 2021.

Effective September 30, 2021, the Plan was permanently frozen whereby employees were not eligible to continue participating, become eligible to participate, or resume participation in the Plan, and no elective deferrals were permitted with respect to any compensation earned by an employee after September 30, 2021.

The Board of Trustees of Willamette University adopted a resolution to terminate the Plan effective September 30, 2023. See Note 9 for additional information regarding the Plan termination.

Participant accounts – Each participant's account is credited with allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account into various investment options offered by the Plan.

Vesting – Participants are immediately vested in their prior elective deferrals and employer contributions and actual earnings thereon.

Payment of benefits – On termination of service other than death, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, substantially equal installments, a continuous right of withdrawal pursuant at participant's discretion, or any form of payment required or permitted under the applicable funding vehicle. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or in substantially equal installments.

Pacific Northwest College of Art Retirement Plan Notes to the Financial Statements

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements as of and for the Plan year ended November 27, 2023 have been prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP), using the accrual method of accounting.

Liquidation basis of accounting – The financial statements as of and for the period ended November 27, 2023 were prepared in accordance with Financial Accounting Standards Board (FASB) Accounting Standards Update (ASU) 2013-07, Presentation of Financial Statements: Liquidation Basis of Accounting. Liquidation basis of accounting requires reporting of resources that will be available for distribution.

ASU 2013-07 requires a plan to prepare its financial statements using the liquidation basis of accounting when liquidation of a plan is deemed imminent, rather than when the decision to terminate a plan is made. ASU 2013-07 is effective for plans that determine liquidation is imminent during the annual reporting period.

Use of estimates – The preparation of financial statements in conformity with U.S. GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment valuation – The investments are reported at fair value and contract value. The Plan's custodians certify the contract value of the fixed annuity contracts and the fair value of all other investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the "exit price") in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Contract value is the relevant measurement for assets invested in fixed annuity contracts that are fully benefit-responsive because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Payment of benefits – Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid directly by Willamette University and are excluded from these financial statements. Administrative expenses paid by the Plan may include distribution fees charged to participants' accounts and administrative Plan fees. Investment related expenses are included in net appreciation in fair value of investments.

Pacific Northwest College of Art Retirement Plan Notes to the Financial Statements

Subsequent events – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through September 9, 2024, which is the date the financial statements were available to be issued.

Note 3 – TIAA Traditional Annuity

The TIAA Traditional Annuity is a guaranteed fixed annuity contract available as an investment option to Plan participants that is fully and unconditionally guaranteed by TIAA. The TIAA Traditional Annuity is offered through a variety of contract types including both Group Retirement Annuities (GRA) and Group Supplemental Retirement Annuities (GSRA). The type of contract through which a participant invests in the TIAA Traditional Annuity determines the applicability of certain account features such as the guaranteed minimum interest rate, additional interest declarations, degree of liquidity of the participant's account, and options for receiving income upon retirement.

When participants choose to allocate a portion of their retirement savings to the TIAA Traditional Annuity during the accumulation phase of the contract, their contributions purchase a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. The participant's principal plus a specified minimum rate of interest is guaranteed by TIAA's claims-paying ability. The guaranteed annual interest rate is 3.0% for all premiums remitted under all accumulating contracts. The TIAA Traditional Annuity also provides the potential for additional interest if declared by TIAA's Board of Trustees. Additional interest, when declared, remains in effect for the declaration year, which begins each March 1 for accumulating annuities and January 1 for lifetime payout annuities. Additional interest is not guaranteed for future years. Together, the guaranteed minimum and additional amounts make up the crediting interest rate.

The GRA contract allows for lump-sum withdrawals within 120 days after termination of employment and are subject to a 2.5% surrender charge. All other withdrawals and transfers from GRA contracts must be spread over 10 annual installments (or a fixed period annuity of 5-30 years after termination). The GSRA contracts provide for full participant-directed liquidity.

When a participant's accumulation in the TIAA Traditional Annuity is converted to a lifetime payout annuity, the present value of the stream of payments is equal to the accumulated balance, and the entire amount is recorded as a distribution in the statement of changes in net assets available for benefits.

Note 4 – Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at November 27, 2023 and June 30, 2023.

Registered investment companies (mutual funds) and money market mutual funds

Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

The College Retirement Equities Fund (CREF) Portfolios – The CREF Portfolios consist of eight investment portfolios which are only available as investment options in TIAA Variable Annuity Contracts: Stock, Global Equities, Growth, Equity Index, Core Bond, Inflation Linked Bond, Social Choice and Money Market Accounts. Units held in the CREF portfolios are valued using the NAV of the fund, based on the fair value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding. The NAV of the portfolio is calculated based on a compilation of primarily observable market information. The number of units of the fund that are outstanding on the calculation date is derived from observable purchase and redemption activity in the fund. The Plan may redeem units at NAV on any day the New York Stock Exchange is open for business. Participants cannot redeem units from CREF Accounts (with the exception of the Money Market Account) for 90 days if a purchase, sale and/or repurchase is made within that account within a 60-day period.

Non-fully benefit-responsive investment contracts

TIAA Traditional Group Retirement Annuity – The TIAA Traditional Annuity contract (GRA) is non-fully benefit-responsive and is presented at estimated fair value on the statements of net assets available for benefits. The guaranteed interest rate at November 27, 2023 and June 30, 2023, was 3% plus declared dividends for the years then ended.

Fair value is based upon a discounted cash flow value calculated using an appropriate risk-adjusted market discount rate which correlates closely with TIAA Traditional Annuity's historical crediting rates. Interest rates used to discount cash flows range between 4.00% to 6.75% for the types of contracts held by the Plan. Under TIAA Traditional Annuity contracts, the minimum guaranteed interest rate during the accumulation phase is generally 3%, but between 1% and 3% for some contracts, and is 2.5% during the payout phase.

VALIC Fixed Account Plus – The VALIC Fixed Account Plus is also non-fully benefit-responsive and measured at fair value which approximates contract. Fair value is based upon a discounted cash flow value calculated using an appropriate risk-adjusted market discount rate and is 3% as of November 27, 2023 and June 30, 2023.

The TIAA Traditional Group Retirement Annuity contract and VALIC Fixed Account Plus contract are classified within Level 3 of the valuation hierarchy.

Pooled separate accounts

Units held in pooled separate accounts (PSAs) are valued using the NAV practical expedient of the PSA as reported by the account managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the PSA, minus its liabilities, and then divided by the number of units outstanding. Units held in PSAs are valued using the net asset value practical expedient (NAV practical expedient) of the PSA as reported by the account managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the PSA, minus its liabilities, and then divided by the number of units outstanding.

TIAA Access Annuity Separate Accounts – The TIAA Access pooled separate accounts are proprietary mutual funds maintained by TIAA, as trustee, which correspond to target retirement dates between 2015 and 2060. These Lifecycle Funds seek high total return over time through a combination of capital appreciation and income. Each fund is designed to provide a single diversified portfolio managed with a target retirement date in mind. Each of the Lifecycle portfolios invest in several underlying equity, fixed income, and direct real estate funds. Participants can purchase and sell units of the sub-accounts daily and there are no notice or redemption restrictions.

VALIC Pooled Separate Accounts – The VALIC pooled separate accounts investment objective is to lower the costs to investors through economies of scale available by combining the assets of multiple investors, to provide daily liquidity, and to provide better diversification. Each investor owns a participating interest that is calculated in units and represents its portion of the holdings of the fund. Participants can purchase and sell units of the sub-accounts daily and there are no notice or redemption restrictions.

TIAA Real Estate Account – The TIAA Real Estate Account, which is a PSA, is a single account that invests primarily in real estate holdings and is only available as an investment option in TIAA Variable Annuity Contracts. Participants redeeming units from the TIAA Real Estate Account may only do so once per calendar quarter. Units of the PSA are valued using the NAV of the shares held by the Plan and are valued at the closing price reported on the active market on which the individual securities are traded.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Fully Benefit-Responsive Fixed Annuity Contract

The Plan holds a TIAA Traditional Annuity Group Supplemental Retirement Annuity (GSRA) that is a fully benefit-responsive investment contract (FBRIC). TIAA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.0% or 3.0% depending on individual contract terms. The crediting rate is reviewed annually for resetting.

The contract meets the FBRIC criteria and is therefore reported at contract value. Contract value is the relevant measure for FBRICs because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by TIAA, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations, which may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following: (1) An uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreements without the consent of the issuer.

Note 6 – Tax Status

The Plan document is a volume submitter defined contribution plan that received a favorable opinion letter from the Internal Revenue Service on March 31, 2017, which stated that the Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 – Information Certified by the Custodians

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the custodians of the Plan, have certified to the completeness and accuracy of the following:

- Investments reflected on the accompanying statements of net assets available for benefits as of November 27, 2023 and June 30, 2023.
- Net appreciation in fair value of investments and interest reflected on the accompanying statement of changes in net assets available for benefits for the period ended November 27, 2023.

Note 8 – Party-In-Interest Transactions

Certain Plan investments are managed by the custodians of the Plan; therefore, transactions with these entities qualify as exempt party-in-interest transactions. Fees paid by the Plan for transaction fees are netted against investment earnings.

Note 9 – Plan Termination

On September 6, 2023, the Board of Trustees of Willamette University adopted a resolution to terminate the Plan effective September 30, 2023. All accounts held by participants immediately became 100% vested, with distributions made as soon as administratively feasible in the form of qualifying annuity contracts or cash unless otherwise elected by the participant. The plan assets were fully distributed as of November 27, 2023. The TIAA annuity contracts remaining as of November 27, 2023 were distributed in-kind at the direction of Willamette University in accordance with the Internal Revenue Code effective as of November 27, 2023, at which point the annuity contracts are enforceable by the participant.

Note 10 – Reconciliation to Form 5500

The Form 5500 has certain items that differ from amounts shown on the accompanying financial statements. These differences relate to classification only and have no effect upon net assets available for benefits for either period.
