## INDEPENDENT AUDITORS' REPORT

To the Board of Directors and Plan Administrator  
Harborwalk Hospitality 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Harborwalk Hospitality 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of April 28, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period from January 1, 2023 through April 28, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of the period from January 1, 2023 through April 28, 2023 and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

**1. DESCRIPTION OF THE PLAN**

The following description of the Harborwalk Hospitality 401(k) Plan (the Plan) provides only general information. Participants should refer to the summary plan description of the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a voluntary defined contribution plan available to certain employees of Harborwalk Hospitality (the Company or Employer). Employees must be age 21 or older and have completed one year of service in order to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Participants may contribute up to 88% of compensation, as defined in the Plan, not to exceed the maximum allowed under Internal Revenue Service (IRS) Code 415(d). Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers), and those who have reached age 50 or more during the calendar year may make "catch-up" contributions to the Plan. Matching contributions made by the Company are at the option of the Board of Directors. Matching contributions are limited to 50% of employee deferral amounts not to exceed 4% of the employee's eligible pay. The Employer may make additional discretionary contributions allocations to active participants. There were no discretionary contributions during 2023.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contribution, if any, and (b) Plan net earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Notes Receivable from Participants**

Notes receivable from participants represent loans to participants and are measured at the unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of April 28, 2023 or December 31, 2022. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Participants are allowed two outstanding notes at any one time from their account. The note amount is allowed at a minimum of \$500 and a maximum of 50% of the participant's vested balance up to \$50,000. Notes are available only from the participant's 401(K) nonforfeitable accrued benefit. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 5.25% to 10.00%, which are commensurate with local prevailing rates as determined at the time of the note issuance. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits**

On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum distribution, or in monthly installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Funds may also be accessed prior to the date they become distributable by way of a financial hardship withdrawal. Hardship withdrawals are allowable in accordance with current IRS guidelines.

**Vesting**

Participants are immediately vested in their contributions and earnings on those contributions. Vesting in the Company's matching contributions, however, is based on years of continuous service, as follows:

Less than 2 years	0%
2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 years	100%

**Forfeitures**

Forfeited balances of terminated participants' nonvested accounts are used to offset the Plan's administrative expenses and/or offset the Employer's matching contribution. Forfeitures of \$19,466 and \$12,253 respectively were used to offset the Employer's matching contribution during 2023 and 2022. As of April 28, 2023 and December 31, 2022, there were unallocated forfeitures of \$29,540 and \$7,570, respectively.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Presentation**

The financial statements of the Plan have been prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value based on quoted market prices. The Plan presents in the statement of changes in net assets available for benefits, the net appreciation (depreciation) in the fair value of its investments, which consists of the realized gains or losses on investments sold during the year and the unrealized appreciation (depreciation) on investments held at year-end. Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income are recorded on the accrual basis.

**Contributions**

Contributions from participants and the Company's matching contributions are recorded in the period in which the Company makes the deductions from the employees' payroll. Rollover contributions are recorded as Plan contributions during the period in which the funds are received by the Plan.

**Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

**Payment of Benefits**

Benefits to participants are recorded when paid.

**Administrative Expenses**

The Company serves as the administrator for the Plan and has sole responsibility for the administration of the Plan. Those services are provided without charge to the Plan. Fees related to the administration of benefit payments and notes receivable from participants are charged directly to the participant's account. Investment related expenses are calculated based on the net appreciation in fair value of investments as they are paid from the participants' accounts. Administrative expenses for 2023 totaled \$9,234. Other administrative expenses, such as accounting and legal fees, are paid by the Company rather than the participants.

**3. INFORMATION CERTIFIED BY TRUSTEE**

Certain investment information regarding the Plan, as of April 28, 2023 and December 31, 2022, and for the period from January 1, 2023 through April 28, 2023 and the year ended December 31, 2022, included in the Plan's financial statements, was prepared by or derived from information provided by the Trustee of the Plan and furnished to the Plan administrator. The Plan administrator has obtained certifications from the Trustee that the following information is complete and accurate:

**4. FAIR VALUE MEASUREMENTS**

The Financial Accounting Standards Board's (FASB) framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2022.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/Collective Trusts (CCT):* Valued at the NAV of units held by the Plan at year-end. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. There were no redemption restrictions or unfunded commitments relative to the CCTs.

Gains and losses (realized and unrealized) included in the statement of changes in net assets available for benefits for the period from January 1, 2023 through April 28, 2023, are reported in net appreciation in fair value of investments.

## **5. TAX STATUS**

The Plan has adopted a prototype nonstandardized preapproved profit-sharing plan, which received an opinion letter from the IRS dated December 31, 2018, that the Plan was designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **6. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

## **7. PLAN TERMINATION**

On April 28, 2023, the Plan was terminated. The termination was approved by the Plan sponsor and all necessary regulatory approvals were obtained. As a result of the termination, the Plan's assets were transferred to Legendary SVS, LLC 401(k) Plan.

The following steps were taken during the termination process:

- All Plan participants were notified of the termination and provided with information regarding the rollover of their balances into the new plan.
- The Plan's assets were fully transferred into Legendary SVS, LLC 401(k) Plan.
- All required regulatory filings, including the final Form 5500, were completed and submitted to the appropriate authorities.

As of the termination date, the Plan had no remaining assets or liabilities. Due to the termination of the plan, the supplementary Schedule of Assets (Held at Year End) has been omitted as there are no remaining assets to report.

**8. SUBSEQUENT EVENTS**

Management has evaluated events and transactions that occurred between April 28, 2023 and August 26, 2024, which is the date the financial statements were available to be issued for possible recognition or disclosure in the financial statements.

Effective April 28, 2023, the Plan merged into Legendary SVS, LLC 401(k) Plan. As a result, all investments were transferred from the Plan into Legendary SVS, LLC 401(k) Plan on that date.
