As further discussed in Note 1 to the financial statements, the Board of Directors of Serv IT, Inc., the plan's sponsor, voted on October 2, 2023 to terminate the plan and management determined liquidation is imminent. As a result, Serv IT, Inc. 401(k) Retirement Plan changed its basis of accounting from the on going-concern basis of accounting used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Serv IT, Inc. 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for more complete descriptions of the Plan's provisions.

General

The Plan was a defined contribution plan covering substantially all eligible employees of Serv IT, Inc. (the "Company" or "Plan Sponsor"). The Plan provided eligible employees a means of regular and systematic savings with several investment options. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Termination

On October 2, 2023, the Plan Sponsor voted to liquidate and merge the assets of the Plan into the Aprio Advantage Pooled Employer Plan – Serve IT, Inc. On December 29, 2023 the Plan's investments were liquidated and transferred to the Aprio Advantage Pooled Employer Plan – Serv IT, Inc. Assets were received by the Aprio Advantage Pooled Employer Plan – Serv IT, Inc. on January 4, 2024. In accordance with generally accepted accounting principles in the United States of America, the Plan changed its basis of accounting used to value the plan assets from the ongoing basis to the liquidation basis for twelve month period ended December 29, 2023.

Plan Administration

The Company is the Plan sponsor and Ascensus Trust Company is the Plan recordkeeper. Assets of the Plan are managed by Ascensus Trust Company, referred to as the "Trustee" of the Plan.

Eligibility

Employees were eligible to participate in the Plan by completing 90 days of consecutive employment with no age requirement. Employees were also eligible to receive employer contributions as of the eligibility date. Employees, once meeting the service requirement, were eligible to participate in the Plan as of the first available entry date per the Plan provisions.

Contributions

Each year, participants could contribute pretax annual compensation, as defined in the Plan. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Contributions were subject to certain Internal Revenue Service (IRS) limitations. For the twelve month period ended December 29, 2023, the maximum contribution allowed by an employee under 50 years of age was \$22,500. For an employee at or over 50 years of age, the maximum contribution allowed was \$29,000.

Employer discretionary matching and profit sharing contributions were permitted per plan guidelines and were determined by the Plan Sponsor.

Investment Options

Participants directed the investment of their accounts into various investment options offered by the Plan.

NOTE 1 – DESCRIPTION OF PLAN (CONTINUED)

Participant Accounts

Each participant's account was credited with the participant's voluntary contribution, any employer discretionary contributions and allocation of Plan earnings (losses) reduced by administrative expenses which were allocated proportionately among all participants based on their investment in each fund. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

Each participant was 100% vested at all times in his or her salary reduction contributions plus actual earnings thereon. Effective August 15, 2021, the Plan was amended and all participants were vested in employer matching and profit-sharing contributions plus actual earnings thereon as noted in the vesting schedule below:

Notes Receivable from Participants

Participants could borrow from their fund accounts up to the lesser of \$50,000 or 50% of the vested portion of their account balance. Individual loans were secured by the balance in the participant's account and bore interest at the Wall Street Journal's prime rate plus 2%. Principal and interest were paid through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant could elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Additionally, if the vested account was \$5,000 or less, the vested account would be paid in a lump-sum.

Forfeitures

Participants who terminated employment before they were fully vested forfeited all rights to any non-vested portion of their account. The Plan Agreement allowed for forfeitures to be used to pay administrative expenses under the Plan, restore forfeitures for rehired participants, or reduce the Company's future contributions. There were \$0 and \$871 in forfeited non-vested accounts during the twelve month period ended December 29, 2023 and year ended December 31, 2022, respectively.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan terminated on October 2, 2023. At that time, management considered liquidation imminent and converted from the ongoing basis of accounting to the liquidation basis of accounting, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP required the plan administrator to make estimates and assumptions which affected certain reported amounts and disclosures. Accordingly, actual results may have differed from those estimates.

Investment Valuation and Income Recognition

Investments were reported at fair value. Fair value is the price which would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on an accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Company were recorded in the year in which the employee contributions were withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans were reclassified as distributions based upon the terms of the Plan Agreement.

Payment of Benefits

Benefits were recorded when paid.

Administrative Expenses

Administrative expenses of the Plan were the responsibility of the Plan, but may have been paid by the Company. These expenses included, but were not limited to, legal, accounting and recordkeeping fees, and investment expenses. For administrative expenses not paid by the Company, a proportionate share of the expenses paid by the Plan was charged to each participant's account.

NOTE 3 – CERTIFIED INVESTMENT INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 29, 2023 and December 31, 2022, and net appreciation in fair value of investments, interest, and dividends, for the twelve months ended December 29, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus, LLC, an affiliate of Ascensus Trust Company acting as agent for Ascensus Trust Company (the Trustee of the Plan). This information was not audited by the Plan's independent auditors.

NOTE 4 – FAIR VALUE MEASUREMENT

The Plan utilized Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements*. ASC 820 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have highest priority, Level 2 inputs consist of quoted prices for similar assets or identical assets that are not active, and Level 3 inputs are unobservable and have lowest priority. The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include: a) quoted prices for similar assets or liabilities in active markets; b) quoted prices for identical or similar assets or liabilities in inactive markets; c) inputs other than quoted prices which are observable for the asset or liability; and d) inputs derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input which is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in methodologies from those used at December 31, 2022:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trusts: Common collective trust funds have the characteristics of a structure similar to a mutual fund and are valued based on the readily determinable quoted market price that each fund publishes at the end of each day. While the underlying assets are actively traded on an exchange, the common collective trust funds are not and, therefore, are classified as Level 2 assets in the fair value hierarchy.

No investments were held as of December 29, 2023 due to the termination of the Plan, as described in Note 1. The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2022:

NOTE 5 – TAX STATUS

The Plan sponsor had adopted a prototype non-standardized profit sharing plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020, which stated that the Plan was designed in accordance with the applicable sections of the Internal Revenue Code (IRC) and was, therefore, not subject to tax under present income tax law. The Plan had been amended since receiving the opinion letter. The Plan was required to operate in conformity with the IRC to maintain its qualification. Management was not aware of any course of action or series of events that had occurred that might have adversely affected the Plan's qualified status.

NOTE 6 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were managed by Ascensus Trust Company, the Trustee for the Plan, and therefore, transactions involving the Ascensus Trust Company qualified as exempt party-in-interest transactions. Additionally, notes receivable from participants are defined by ERISA as party-in-interest.

The Plan paid certain administrative fees to Ascensus Trust Company, the Plan's recordkeeper. These fees were considered exempt party-in-interest transactions. Other administrative expenses of the Plan were paid by the Plan sponsor; therefore, those expenses are not reflected in these statements.

NOTE 7 – RISKS AND UNCERTAINTIES

The Plan invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
