### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of QuestX, Inc. 401(k) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of November 3, 2023 (in liquidation), and the related statement of changes in net assets available for benefits for the period from January 1, 2023 to November 3, 2023 (in liquidation), and the statement of net assets available for benefits as of December 31, 2022 (ongoing) and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of November 3, 2023 and December 31, 2022, and for the period from January 1, 2023 to November 3, 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Emphasis of Matter – Basis of Accounting**

As discussed in Note 6 to the financial statements, the governing body of QuestX, Inc. 401(k) Plan approved a plan of liquidation on April 30, 2023, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements. Our opinion is not modified with respect to that matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

**Note 1 – Description of the Plan**

The following description of the QuestX, Inc. 401(k) (Plan) provides only general information. Participants should refer to the plan agreement for a complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering substantially all employees of QuestX, LLC and Quest Towing Services, LLC (collectively the Company). The Plan was established effective January 1, 1994 and was most recently restated effective August 15, 2022, and amended April 30, 2023. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

During 2023, the Company voted to enter into an asset purchase agreement. As a result, the plan was terminated effective April 30, 2023. See Note 6 regarding plan termination.

**Eligibility**

Employees are eligible for plan participation in all contributions after completing two months of service and attainment of age 18. Upon becoming eligible, employees will enter the Plan on the first day of the start of the following month. In order to share in Company profit sharing contributions, eligible participants must be credited with 1,000 hours of service during the plan year and be employed on the last day of the plan year.

**Contributions**

Each year, participants may contribute a percentage of their annual compensation, not to exceed the limits of the Internal Revenue Code (IRC). Participants who were age 50 or older are eligible to make catch up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated age-based target date fund until changed by the participant.

The Company may elect to make a matching contribution and a discretionary employer contribution; however, for 2023, no such contributions were made.

**Participant Accounts**

Each participant's account is credited with the participant's and Company contributions, as well as allocations of plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are 100% vested in their voluntary and rollover contributions, including any earnings thereon, immediately upon their effective date of participation. Participants are vested in Company contributions as follows:

Participants are credited with a year of service for vesting purposes upon completion of 1,000 hours of service during the year. Upon notice of plan termination all participants were 100% vested in all balances.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and must bear reasonable rates of interest which are generally consistent with local borrowing rates as of the date of each loan. Principal and interest are paid ratably through payroll deductions over the term of the loan.

**Payment of Benefits**

The Plan provides for payment of 100% of the account balance to participants upon normal retirement (age 59½), death, or total and permanent disability. Participants terminating employment for any other reason are entitled to receive 100% of their vested account balances and any remaining non-vested portions would be forfeited. Participant distributions from the Plan can be made in a single lump payment. If the participant's vested benefit under the Plan exceeds \$1,000, then the participant must consent to the distribution before it is made. However, if the participant's vested benefit under the Plan does not exceed \$1,000, then the benefit may be distributed as soon as possible following the event that entitles the participant to a distribution. There are minimum distribution requirements once a participant reaches a certain age as defined in the plan agreement. Generally, a participant may receive a distribution from the Plan prior to termination of employment if certain conditions are satisfied. A participant may be entitled to receive an in-service distribution from their vested account balance if they have reached the age of 59½. Participants may also request financial hardship distributions from elective deferral accounts if they meet certain conditions defined in the plan agreement.

**Forfeited Accounts**

At November 3, 2023 and December 31, 2022, forfeited non-vested accounts totaled \$0 and \$993, respectively. These accounts are used first to pay certain administrative expenses of the Plan and any remaining funds are applied to reduce employer contributions made to the Plan. The amount of forfeitures used to pay administrative expenses in 2023 was \$1,153.

**Note 2 – Summary of Significant Accounting Policies**

**Basis of Accounting**

The Plan has changed its basis of accounting from the going concern basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements. There were no material adjustments to the 2022 financial statements as a result of the change under the liquidation basis of accounting. See details regarding the plan termination at Note 6.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United

States of America (US GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the Plan's trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance has been recorded as of November 3, 2023 and December 31, 2022, as the full outstanding balance is deemed collectible (all notes receivable from participants were disbursed from the Plan by November 3, 2023, due to the plan termination). If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and recorded in the statement of changes in net assets available for benefits as a deemed distribution of participant notes receivable.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements, unless paid from the Plan's forfeiture account. Fees related to the processing and administration of notes receivable from participants, benefit payments, general administration, recordkeeping and investment advice are charged directly to the participant's account and are included in administrative expenses on these financial statements. Certain other expenses are included in investment income and paid through revenue sharing (indirect compensation). Investment-related expenses are included in investment income.

**Date of Management's Review**

Management has evaluated subsequent events through September 4, 2024, which is the date the financial statements were available to be issued.

**Note 3 – Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under US GAAP are described as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the assets or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Classification within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There were no changes in the methodologies used at December 31, 2022. All plan assets were distributed by November 3, 2023 due to plan termination.

Mutual funds – valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common trust funds – valued at the net asset value (NAV) of units held by the Plan at year end. The NAV, as provided by Fidelity Management Trust Company, is used as a practical expedient to estimate fair value and is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. The NAV is not a publicly-quoted price in an active market.

The common trust funds are comprised of a stable value fund composed primarily of fully benefit-responsive benefit contracts. The stable value fund seeks to provide reservation of capital and relatively stable returns regardless of the volatility of the financial markets.

**Note 4 – Related-Party Transactions and Party-In-Interest Transactions**

Certain plan investments are managed by Fidelity. Fidelity Management Trust Company is the trustee and record-keeper of the Plan. The Plan also holds notes receivable representing participant loans. These transactions qualify as party-in-interest transactions.

The Plan made payments to Fidelity Management Trust Company, third party administrator and record-keeper, relating to participant loan processing/maintenance, withdrawals, record-keeping, and general plan administration. Direct fees incurred by the Plan for these services totaled \$12,592 during the period from January 1, 2023 to November 3, 2023 and additional fees are netted with investment income and paid through revenue sharing (indirect compensation).

The Plan made payments to OneDigital Investment Advisors LLC for investment advisory services. Direct fees incurred by the Plan for these services totaled \$1,064 during the period from January 1, 2023 to November 3, 2023.

**Note 5 – Certified Investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at November 3, 2023 and December 31, 2022, and net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants for the period from January 1, 2023 to November 3, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

**Note 6 – Plan Termination**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. The Board of Directors of QuestX, LLC, the Plan's sponsor, adopted a resolution to terminate the Plan effective April 30, 2023, and determined liquidation was imminent. Final distributions were determined based on all participants being 100% vested and were made as soon as possible following the termination date. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2022 financial statements to the liquidation basis. All participants and beneficiaries with an account balance were notified of the plan termination. By November 3, 2023, all assets were distributed from the Plan.

**Note 7 – Tax Status**

The Plan adopted a prototype plan, which received a favorable opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, indicating that the prototype plan is designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the letter, however, the plan administrator believes that

the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits. All Plan investment assets were distributed by November 3, 2023 due to plan termination.
