INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of the

Opinion

We have audited the accompanying financial statements of Independent Meat Company Union Employee 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for benefits as of March 25, 2024 (in liquidation), and the related statement of changes in net assets available for benefits for the year then ended (in liquidation), and the statement of net assets available for benefits as of August 31, 2023 (ongoing), and the related notes to the financial statements.

In our opinion, the financial statements referred to in the first paragraph present fairly, in all material respects, the net assets available for benefits of Independent Meat Company Union Employee 401(k) Profit Sharing Plan as of March 25, 2024 (in liquidation) and August 31, 2023 (ongoing), and the changes in its net assets available for benefits for the year ended March 25, 2024 (in liquidation), in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Independent Meat Company Union Employee 401(k) Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Emphasis of Matter—Basis of Accounting

As discussed in Note 5 to the financial statements, the governing body of Independent Meat Company Union Employee 401(k) Profit Sharing Plan approved a plan of merger and consolidation on December 13, 2023, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the August 31, 2023 financial statements to the liquidation basis used in presenting the March 25, 2024 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. NOTE 1 - DESCRIPTION OF PLAN

The following description of the Independent Meat Company (“Company”) Union Employee 401(k) Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General:

The Plan is a defined contribution plan covering all full-time union employees of the Company who have completed at least one year of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employee Contributions:

Participants may contribute up to \$22,500 of pretax annual compensation (as defined in the Plan) for calendar year 2023, and up to \$23,000 for calendar year 2024. (\$30,000 for participants aged 50 or over for 2023, \$30,500 for 2024) Participants may also contribute amounts representing rollover distributions from other qualified defined benefit or defined contribution plans.

Participant Accounts:

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Each participant directs the investment of his or her account to options offered by the Plan. The Plan currently offers investment options through Principal Financial Group.

Company Contributions:

The Company matches participant contributions up to \$75 per month for each participating employee. The Company made contributions to the Plan of \$42,775 for the year ended March 25, 2024.

The Company pays the audit and legal fees incurred in administering the Plan.

Vesting:

Participants are immediately vested in their elective deferral contributions, plus actual earnings thereon. Participants are also immediately vested in qualified nonelective and qualified matching employer contributions. Vesting in other employer contributions is based on years of continuous service. A participant is 20% vested after two years of service and receives an additional 20% of vesting in the Company’s contributions for each year of service. Participants are 100% vested after six years of credited service.

Participant Loans:

The plan does not allow participants to borrow from their accounts.

Payment of Benefits:

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account or an elective transfer to another qualified deferral plan.

Forfeited Accounts:

As of March 25, 2024 and August 31, 2023, forfeited non-vested accounts totaled \$0 and \$30, respectively. Forfeitures of non-vested accounts are allocated among remaining plan participants in the same manner as the Employer's contributions from which the forfeiture occurred.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting:

The trust maintains its records in accordance with generally accepted accounting principles. Income is recognized when earned and expenses are recognized when incurred. Net unrealized gains and losses are recognized as defined below.

Use of Estimates:

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions which affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reported period. Actual results could differ from those estimates.

Subsequent Events:

Subsequent events have been evaluated through August 23, 2024, which is the date the financial statements were available to be issued. See Note 5 on Plan Termination.

Fair Value Measurements:

Financial Accounting Standards Board ASC 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of March 25, 2024 and August 31, 2023.

- Guaranteed interest accounts: Valued at fair value by the insurance company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer.
- Securities held in pooled separate accounts: Valued at the net asset value ("NAV") of shares held by the plan as of the financial statement date.
- Registered investment company mutual funds: Valued at the daily closing price as reported by the fund.
- Common/collective trusts: Valued at the net asset value ("NAV") of units of the collective investment trust. The NAV is used as a practical expedient to estimate fair market value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The net asset value assigned to the plan for each investment is identified in the supplemental schedule of assets held. There are no redemption restrictions for the mutual funds, common/collective trusts, or pooled separate accounts.

NOTE 4 - PARTY IN INTEREST TRANSACTIONS

The Plan has contracted with the Principal Financial Group to be the trustee of the plan assets. Principal Financial Group manages plan assets, receives participant and employer contributions, offers investment options to plan participants through Pooled Accounts, Common/Collective Trusts, and Registered Investment Companies, allocates plan earnings, accounts for each participant account, and disburses benefit payments or transfers plan assets. These transactions qualify as exempt party-in-interest transactions. Fees paid by the Trust for the investment management services of Principal Financial Group amounted to \$22,265 for the year ended March 25, 2024.

NOTE 5 - PLAN TERMINATION

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in any otherwise unvested employer contributions.

During the current plan year, the Plan was amended for a merger and consolidation with the Independent Meat Company Non-Collectively Bargained 401(k) Profit Sharing Plan. All assets of the Plan were transferred out of the Plan on March 25, 2024 pursuant to the merger, and this Plan was terminated.

NOTE 6 - TAX STATUS

The Internal Revenue Service has determined and informed the Company that the Plan and related trust were in accordance with applicable sections of the Internal Revenue Code (IRC) when originally established. Subsequent to the original letter of determination, the Plan has executed amendments to ensure compliance with current laws and regulations. In a letter dated March 31, 2014 the Internal Revenue Service confirmed that the form of the Plan is acceptable under section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. Subsequent to the most recent IRS letter, amendments have been made, the most recent of which was effective March 4, 2022. Although a determination has not been made by the IRS following the most recent amendments, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or Department of Labor. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - INVESTMENT CONTRACT WITH PRINCIPAL FINANCIAL GROUP

The Plan has entered into an investment contract with Principal Financial Group. Principal Financial Group maintains contributions in pooled accounts. The accounts are credited with actual earnings on the underlying investments and charged for participant withdrawals and administrative expenses charged by Principal Financial Group. The contract is included in the financial statements at fair value because it does not meet the criteria to be considered fully benefit-responsive. There are no reserves against contract value for credit risk of Principal Financial Group or otherwise. The fair value of the investment contract as of March 25, 2024 August 31, 2023 was \$0 and \$85,162, respectively. The average yield and crediting interest rates are approximately 1.75%. The crediting interest rate is based on an agreed-upon formula with Principal Financial Group, but cannot be less than zero.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
