In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting from the ongoing plan basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements. Our opinion is not modified with respect to that matter.

### **Responsibilities of Management for the 2023 Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

United States of America, and (b) the information in the 2022 financial statements (ongoing) related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). ### NOTES TO FINANCIAL STATEMENTS

#### (1) Description of plan

The following description of Matthews-Vu Medical Group 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan's provisions, which are available from the plan administrator.

**General** - The Plan was a defined contribution plan sponsored by Matthews-Vu Medical Group (the "Company") for the benefit of its full-time employees who have three months of service and are age 18 years or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan is administered by the Plan Administrator ("Administrator"). The Administrator has overall responsibility for the operation and administration of the Plan. The Administrator determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees.

On April 13, 2023, the Trustees of the Plan voted to terminate the plan effective November 21, 2023. Participants account balances were either distributed to participants or rolled over to the Pooled Employer Plan.

**Contributions** - Prior to termination, participants may contribute up to 90% of eligible compensation each year not to exceed the maximum allowed by law. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan. Participants direct the investment of all contributions into various investment options offered by the Plan.

The Company contributed 100% on the first 3% of eligible compensation, and 50% of the next 2% of eligible compensation that a participant contributes to the Plan. Additional amounts may be contributed at the option of the Company. Contributions are subject to certain IRC limitations.

The Company may also make discretionary nonelective contributions. A participant must be employed by the Company on the last day of the Plan year and have completed at least 1,000 hours of service during the Plan year to be eligible to receive any discretionary nonelective contributions. For the period and year ended November 21, 2023, and 2022, the Company did not make any discretionary nonelective contributions, respectively.

**Participant investment account options** - Prior to termination the plan offered various mutual funds, money market, and similar funds as investment options for participants. Each investment option has its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants may change their investment options at any time.

**Participant accounts** - Each participant's account is credited with the participant's contribution and allocations of (a) the Company matching contributions, as well as profit sharing contribution and (b) plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### NOTES TO FINANCIAL STATEMENTS

#### ( 1 ) Description of plan (continued)

**Vesting** - Participants were immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is 100% vested in those contributions when made.

**Notes receivable from participants** - Prior to termination, participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

**Payment of benefits** - Benefits may be paid to the participant or beneficiary upon death, disability, retirement, or termination as defined in the plan agreement. The plan provides for normal retirement at age 65. Additionally, participants may request an in-service withdrawal of their vested account balance upon attainment of age 59 ½. On termination of service due to death, disability or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account. Terminated participants are eligible to withdraw any portion of his or her vested balance once they have terminated their employment, as defined in the Plan.

**Forfeited accounts** - At November 21, 2023 and December 31, 2022, forfeited nonvested accounts totaled \$0 and \$0, respectively.

#### ( 2 ) Summary of significant accounting policies

**Basis of accounting** - The financial statements of the Plan are prepared on the accrual method of accounting. As described in Note 6, the Trustees of the Plan voted on April 13, 2023, to terminate the plan effective November 21, 2023, and as a result, the Plan changed its basis of accounting from an ongoing basis to the liquidation basis. The liquidation basis of accounting causes little or no change in the value of the Plan assets carried at current market values that could be received in an "orderly transaction". Accordingly, the accompanying 2022 financial statements prepared on the liquidation basis do not require any such adjustment.

**Use of estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investment valuation and income recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held as of the reporting date.

#### ( 2 ) Summary of significant accounting policies (continued)

**Notes receivable from participants** - Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of November 21, 2023 and December 31, 2022.

**Payment of benefits** - Benefits are recorded when paid.

**Administrative expenses** - Certain expenses of the Plan are paid by the Company and are not included in the statements of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

#### ( 3 ) Information prepared and certified by the trustee

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company ("Fidelity"), the trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate with respect to investments:

- Investments at fair value
- Notes receivable from participants
- Net appreciation (depreciation) in fair value of investments
- Interest and dividends
- Interest income on notes receivable from participants

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

#### ( 4 ) Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification (ASU) Topic 820 are described below:

*Level 1*            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 21, 2023 and December 31, 2022.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

There were no investments held by the Plan as of November 21, 2023, due to the plan termination.

(5) Related party transactions and party-in-interest transactions

Certain Plan investments are shares of mutual funds managed by Fidelity. Fidelity is the trustee (or custodian) and recordkeeper for the Plan and therefore, these transactions qualify as party-in-interest transactions.

( 5 ) **Related party transactions and party-in-interest transactions (continued)**

Fidelity provides certain administrative services to the Plan pursuant to a Master Plan Services Agreement (MAS) between the Company and Fidelity. Fidelity receives revenue from mutual fund service providers for services Fidelity provides to the funds. This revenue is used to offset certain amounts owed to Fidelity for its administrative services to the Plan. Spring Wealth is the investment advisor for the Plan and therefore, any transactions qualify as party-in-interest transactions. Fees paid by the Plan for recordkeeping services were \$2,380 and \$1,736 for the period ended November 21, 2023 and year ended December 31, 2022, respectively. The Company pays directly, and other fees related to the Plans operations.

( 6 ) **Plan termination**

On April 13, 2023, the Board of Trustees of the Plan, voted to merge the Plan on November 21, 2023, into the Standard Pooled Employer Plan with Standard Retirement Services, Inc., which is the successor plan. As a result, effective November 21, 2023, participant accounts totaling \$4,566,176 were transferred from the Plan to the Pooled Employer Plan. In connection with the merger and immediately prior to the transfer of plan assets to the successor plan, all participants' account balances became 100% vested.

( 7 ) **Tax status**

The Plan has adopted the Fidelity Volume Submitter Defined Contribution Plan. The Internal Revenue Service ("IRS") has determined that the volume submitter 401(k) savings plan is designed in accordance with applicable sections of the IRC and informed the trustee of such in a letter dated June 30, 2020. Although the Plan has been amended since receiving the opinion letter, the Administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

( 8 ) **Risks, uncertainties and concentrations**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Plan held concentrations in twelve investment securities, approximately 64% of the Plans investments, as of December 31, 2022.

**( 9 ) Delinquent participant contributions**

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. While the Company remitted all employee contributions to the Plan, contributions of \$738 were not remitted within the required time period for the period ended November 21, 2023. The Company has remitted these delinquent employee contributions in 2023.

**( 10 ) Subsequent events**

The Plan has evaluated subsequent events through September 12, 2024, which is the date the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.
