To the Plan Administrator of

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Ian Martin PBC 401k Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **1. Description of Plan**

The following description of the Ian Martin PBC 401k Plan (the Plan) is intended to provide only general information regarding the Plan. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

***General***

The Plan is a participant-directed defined contribution 401k plan covering substantially all employees of Ian Martin PBC (the Employer or the Company) and was established as of January 1, 2019. Employees become eligible upon hire and can enter the Plan immediately. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Employer is also the administrator of the Plan. As administrator, the Employer has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan. Reliance Trust Company (Reliance) is the appointed trustee of the Plan and acts at the direction of the Plan Administrator.

***Contributions***

Participants may elect to contribute up to 90% of their annual pretax compensation, as limited by the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (Rollovers). The Plan also provides for participant catch-up and Roth contributions. Participants must be 21 years of age to make elective deferrals. However, there is no minimum service requirement for a participant to make elective deferrals.

As of April 1, 2022, The Plan includes an automatic enrollment provision whereby all newly eligible employees and employees who have not made an elective deferral election will be enrolled in the Plan unless they affirmatively elect not to participate. An initial pre-tax deferral election of 1% beginning with the first pay period of the month following the participant's hire date will be made for newly eligible employees. The automatic enrollment provisions apply to all employees who did not make a timely election to not contribute elective deferrals in connection with the implementation. The deferral is invested in a designated target date fund until changed by the participant.

The Company may decide to make a matching contribution to the Plan, although the Company is not required to do so. Participants must make elective deferrals to the Plan to receive this matching contribution. The percentage of elective deferrals to be matched will be determined by the Company and allocated to participants at the end of the plan year. The Company has not made any matching contributions to the Plan.

The Company may decide to make a nonelective contribution to the Plan, although the Company is not required to do so. The nonelective contribution will be allocated to all employees eligible to participate in the Plan.

Eligible employee shares of the nonelective contribution is integrated with the Company's contributions to Social Security. A certain amount is contributed to the Plan based upon eligible earnings not in excess of the Taxable Wage Base under Social Security, and a certain amount is contributed to the Plan in excess of the Taxable Wage Base. The nonelective contribution will be determined by the Company and allocated to participants at the end of the plan year based on eligible earnings within the computation period.

***Participant Accounts***

Each participant's account is credited with the participant's contribution and their allocation of Plan earnings/losses and any expenses incurred. Allocations are based on participant compensation or individual participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their contributions plus the allocation of Plan earnings on those contributions, at the time of allocation. Participants become vested in the Employer's contributions and the allocation of Plan earnings on those contributions as follows: 20% after 2 years, 40% after 3 years, 60% after 4 years, 80% after 5 years and 100% after 6 years. Participants are immediately vested in all accounts upon death, disability, or attainment of retirement age.

***Payment of Benefits***

The Plan allows for in-service distributions of the participant's vested accounts upon reaching the age of 59-1/2 or due to hardship, as defined by the Plan. In-service withdrawals are also permitted for Rollover and Roth Rollover account balances at any time.

Upon termination of employment for any reason, a participant or beneficiary will be entitled to the value in their vested account balance. If a participant's vested balance is equal to or less than \$1,000, the participant will receive an immediate cash-out of their vested account balance, and the non-vested portion shall be treated as a forfeiture. If a participant's vested balance exceeds \$1,000 and is equal to or less than \$5,000, the amount will be rolled over to an individual retirement plan designated by the trustee, unless otherwise directed by the participant. Participants with vested balances exceeding \$5,000 may choose lump sum, direct rollover, installment payments, partial withdrawal, or to defer receiving payments until age 70 1/2.

***Forfeitures***

Participants in the Plan who leave the employment of the Employer before completing the applicable vesting requirements forfeit the non-vested portion of their accounts. Forfeitures will be used to reduce any Employer contribution. At December 31, 2023 and 2022, there were no forfeited nonvested accounts.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The Plan's financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

***Valuation of Investments and Income Recognition***

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note 3).

The Plan's Administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Contributions***

Participant and Employer matching contributions are recorded weekly and bi-weekly, as applicable, when the Employer remits the contributions for investment into the Plan.

***Payment of Benefits***

Benefits are recognized when paid to participants or their designated beneficiaries.

***Administrative Expenses***

Certain administrative expenses of the Plan are paid by the Employer, unless the Employer directs that the expenses be paid by the Plan. Expenses that are paid by the Company are excluded from these financial statements. Investment management and recordkeeping fees, if applicable, are paid by the Plan through revenue sharing as a reduction of investment income (net appreciation or depreciation) from the related investment fund.

***Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported changes in net assets. Accordingly, actual results may differ from those estimates.

***Risks and Uncertainties***

The Plan provides for various investment options with various investment objectives. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

***Financial Instruments with a Concentration of Credit Risk***

The Plan's investments are held by a single trustee. The Plan's exposure to credit risk is associated with the outside entity's non-performance of their fiduciary responsibilities relating to these amounts as specified in the agreements. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

**3. Fair Value Measurements**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of fair value hierarchy and inputs to the valuation methodologies are described as follows:

Level 1 inputs are unadjusted quoted prices in active markets for identical assets the Plan has the ability to access.

Level 2 inputs are other than quoted prices in active markets that are observable either directly or indirectly for the asset. Such inputs are derived principally from or corroborated by observable market data for similar assets by correlation or other means, over substantially the full contractual term of the asset, if applicable.

Level 3 inputs are unobservable and significant to the fair value measurement. Such inputs generally rely on the Plan's own assumptions about the assumptions that market participants would use in pricing the asset.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

As of December 31, 2023 and 2022, the Plan's investments in mutual funds are reported at level 1 within the fair value hierarchy.

**4. Plan Termination**

The Employer expects to continue the Plan indefinitely. However, the Employer reserves the right to amend the Plan or contributions thereto, at any time and in any manner that it deems advisable, provided that no amendment shall have the effect of diverting Plan assets for purposes other than for the exclusive benefit of the Plan participants and any Plan termination would be subject to the provisions of ERISA. In the event of Plan termination, the participants would become fully vested and entitled to receive all amounts credited to their accounts.

**5. Income Tax Status**

The Plan is operating under a prototype plan sponsored by ADP, which obtained its latest determination letter on October 6, 2020, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**7. Differences from Form 5500**

Differences between the Annual Return/Report of Employee Benefit Plan, Form 5500, and these financial statements are a result of different classifications between line items. Total Plan assets are in agreement.

**8. Related Party Transactions and Party-in-Interest Transactions**

Plan investments are held and managed by Reliance Trust Company, the trustee of the Plan. ADP Retirement Services is the recordkeeper of the Plan. Therefore, transactions with these parties qualify as party-in-interest transactions. The Plan made direct payments of \$2,722 to ADP for recordkeeping services and \$7,822 to Ellison Kibler and Associates at Merrill Lynch for outside consulting fees for the year ended December 31, 2023.

**9. Subsequent Events**

Effective June 1, 2024, the Plan was amended to no longer include an automatic salary deferral feature. Post amendment, participants must make a deferral election to make salary deferrals to the Plan.

Effective July 1, 2024, the name of the Plan was changed to Raise Group PBC 401k Plan in conjunction with the plan sponsor changing their name to Raise Group PBC.

Management has evaluated subsequent events through August 23, 2024, which is the date these financial statements were available to be issued.
