### NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Cornerstone Residential Management, L.L.C. 401(k) Profit Sharing Plan (the Plan) provides only general information. For more comprehensive information, participants should refer to the Plan instrument, a copy of which is on file in the office of the Plan sponsor.

#### *General*

The Plan is a defined contribution 401(k) profit sharing retirement plan covering all eligible employees from Cornerstone Residential Management, L.L.C. (Cornerstone). Cornerstone is the Plan's sponsor and participating employer. The Plan commenced on January 1, 2003. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### *Eligibility*

In order to be eligible to participate in the Plan, an employee must be at least 21 years old, have 1,000 credited service hours and have completed one year of service with the company. Employees that are either non-resident aliens, in a collectively bargained group or housekeepers, porters or leasing agents are not eligible for participation. On April 1, 2012, the Plan was amended so that all employees who become eligible to participate in the Plan after January 1, 2013 will be deemed to have entered into a salary deferral election of 3% of compensation unless the employee completes a salary deferral election form indicating otherwise.

#### *Funding*

Effective January 1, 2018, participants may contribute up to 100% of annual pretax compensation, as defined in the Plan. Prior to that date, the maximum contribution was 75% of annual pretax compensation. According to the Internal Revenue Service (IRS) rules, the deferral may not exceed \$22,500 in 2023 and \$20,500 in 2023 and 2022, respectively. Participants who have reached at least age 50 may contribute an additional \$7,500 and \$6,500 during 2023 and 2022, respectively.

The employer shall match this contribution at a rate of 50% of the employee's contribution limited to 6% of total compensation. All contributions are invested in mutual funds (see Note 3). Contributions are subject to certain limitations.

Participants may also rollover amounts representing distributions from other qualified benefit or contribution plans. Employees are fully vested for rollover amounts received. Additionally, effective January 1, 2018, the Plan was amended to authorize in-Plan Roth conversion.

#### *Participant Accounts*

Each participant's account is credited with 1) employee contributions, 2) the employer's matching contribution and 3) a ratable portion of investment gain or loss, net of Plan expenses. Each participant's account is also charged with any distributions made to that participant.

#### NOTE 1. DESCRIPTION OF THE PLAN (Continued)

##### *Vesting*

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the employer's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Beginning on the second year of service, the vesting percentage increases by 20% after each year of service. A participant is 100% vested after 6 years of credited service.

##### *Investment Options*

Upon enrollment in the Plan, a participant may direct contributions to be allocated among a selection of securities provided by the Plan administrator (see Note 3).

##### *Payment of Benefits*

On termination of service due to death, disability or retirement, a participant or beneficiary may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

##### *Forfeitures*

Forfeitures may be used to reduce future employer contributions. For the Plan year ended December 31, 2023, \$94,637 in forfeitures were used to reduce employer contributions.

##### *Notes Receivable from Participants*

Participants may borrow from their fund accounts up to a maximum of \$50,000 or 50% of their account balance, whichever is less. Loan terms may range from 1 - 5 years unless the loans were for the purchase of a primary residence. The loans would be secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates provided by local lending institutions. Principal and interest would be paid ratably through biweekly payroll deductions. For the year ended December 31, 2023, the interest rate on notes receivable from participants ranged from 5.25% to 10.50% with maturities through 2049. Participants had outstanding loan balances totaling \$166,276 and \$221,650 as of December 31, 2023 and 2022, respectively, and were recorded as notes receivable from participants in the accompanying statements of net assets available for benefits.

##### *Termination*

Although there is no intent to do so, the Plan document provides for termination of the Plan subject to the provisions of the agreement and ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### *Basis of Accounting and Use of Estimates*

The accompanying financial statements have been prepared using the accrual basis of accounting. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### *Investment Valuation and Income Recognition*

Investments are reported at fair value (see Note 3). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants (see Note 4 for discussion of fair value measurements).

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### *Concentration of Credit Risk*

Financial instruments which potentially expose the Plan to concentrations of credit risks, as defined by GAAP, consist primarily of investments and receivables. The Plan invests in mutual funds which, inherent in the fair market value determination, include the risk factor of credit worthiness for each individual debt security.

#### NOTE 3. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN

Empower Trust Company, LLC held the Plan's investments as of December 31, 2023 and 2022. The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Retirement has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2023 and 2022, the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2023, and the information reflected on the schedule of Form 5500 - Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2023.

Allocations among the underlying investments are participant directed. The accounts are credited with earnings on the underlying investments (principally mutual funds) and charged for Plan withdrawals and administrative expenses.

During the year ended on December 31, 2023, the Plan's underlying mutual fund and guaranteed insurance contract investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$1,139,985. This was reported as net appreciation in fair value of investments in the statement of changes in net assets available for benefits.

#### **NOTE 4. FAIR VALUE MEASUREMENTS**

GAAP provides a framework for measuring fair value, expands disclosures about fair value measurements, and establishes a fair value hierarchy which prioritizes the inputs used in measuring fair value summarized as follows:

Level 1: Inputs using the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used to measure fair value as of December 31, 2023.

The following is a description of the valuation methods used for assets measured at fair value:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 5. FULLY BENEFIT-RESPONSIVE INSURANCE CONTRACT**

The Plan has a traditional benefit-responsive guaranteed insurance contract, which was reported at a contract value of \$931,946 and \$905,618 as of December 31, 2023 and 2022, respectively. The Empower Investments Fixed Account - Series Class I is a general account product offered through the group annuity contract with principal and interest being fully guaranteed by the entire general account assets of Empower Annuity Insurance Company of America. Interest is credited daily to the group contract holder on a portfolio basis. The crediting interest rate may change or stay the same quarterly. The annualized crediting rate for the quarter ended December 31, 2023 was 1.30%.

**NOTE 6. RELATED PARTIES**

Cornerstone is the Plan's employer and sponsor. They absorb virtually all administrative expenses of the Plan.

**NOTE 7. PARTY-IN-INTEREST TRANSACTIONS**

The Empower Investments Fixed Account is a general account product of Empower Annuity Insurance Company of America (EAICA). Participant principal and interests are backed by the entire general account of EAICA who serves as Plan custodian and has fiduciary responsibility. This makes transactions between the Plan and EAICA party-in-interest transactions.

Additionally, the Plan pays Empower Annuity Insurance Company for record-keeping fees and Empower Advisory Group for investment management fees. For the year ended December 31, 2023, these expenses amounted to \$30,371. They have been included in the accompanying statement of changes in net assets available for benefits as part of administrative expenses.

**NOTE 8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

#### **NOTE 9. TAX STATUS**

The Plan is exempt from Federal income taxes under Internal Revenue Code (IRC) and, therefore, no provision for Federal income taxes has been made. In addition, the Plan is required to operate in conformity with the IRC to maintain the tax-exempt status. The Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore believes that the Plan is tax-exempt. Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Management believes no such positions have been taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Management believes that the Plan is no longer subject to such audits for tax periods prior to 2020.

#### **NOTE 10. SUBSEQUENT EVENTS**

Plan management has evaluated subsequent events for the Plan through July 23, 2024, the date the financial statements were available to be issued.

Effective January 1, 2024, the name of the plan was changed to CRM Management, LLC 401(k) Profit Sharing Plan. This follows the name of the plan sponsor, which became CRM Management, LLC during 2023.
