Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of EZ Loader Boat Trailers, Inc. Amended and Restated Employee's 401(k) Profit Sharing Plan & Trust ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) Audit]. The financial statements are comprised of the statements of net assets available for benefits as of November 2, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period ended November 2, 2023, and the related notes to the financial statements.

Notes to Financial Statements

1. Description of the Plan

The EZ Loader Boat Trailers, Inc. Amended and Restated Employee's 401(k) Profit Sharing Plan and Trust (the Plan) is a defined contribution plan which covers all eligible employees of the Plan Sponsor. In 1991, the Plan was amended to include a 401(k) salary deferral arrangement.

As discussed in Note 8, effective November 2, 2023, the Plan's assets were transferred to Voya Financial, the trustee of a pooled employer plan (PEP). Concurrent with the transfer of the assets, the Plan was terminated.

The following brief description of the Plan is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established by a resolution of the Board of Directors of EZ Loader Boat Trailers, Inc. (the Plan Sponsor) on May 27, 1969. The Plan and Trust agreement was subsequently amended and restated effective July 1, 2015, and again effective July 1, 2022. The Plan was created to provide certain benefits to employees in the event of retirement, permanent disability, death, or termination of employment. The Trust is designed to constitute a part of the EZ Loader Boat Trailers, Inc. Amended and Restated Employee's 401(k) Profit Sharing Plan, which qualifies for tax exemption under Section 401(a) of the Internal Revenue Code.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and all subsequent statutory revisions thereto.

The Plan is administered by members of the Plan Sponsor's management. The Plan assets were held and invested by the Plan's custodian, John Hancock Life Insurance Company (John Hancock), in accordance with Plan and Trust agreement with the Plan. Records of participant account activity are processed and maintained by the custodian who also performs other administrative support services for the Plan.

Eligibility

Except for collectively bargained employees, non-resident aliens who receive no compensation from the Plan Sponsor which constitutes U.S. source income, and leased employees, all employees who are employed by the Plan Sponsor or any affiliate who has adopted the Plan are eligible to be enrolled in the Plan upon the date of hire. Through November 2, 2023, employees were eligible for employer matching and profit-sharing contributions after one year of service as long as they were employed on the last day of the Plan year (December 31). Exceptions for the year end requirement include termination due to death, disability, and attainment of the age of 65.

Employee Contributions

Participants of the Plan may make elective deferrals up to 100% of their W-2 compensation, consisting of both pre-tax deferrals and Roth deferrals, not to exceed annual limitations prescribed by the Internal Revenue Service. For 2023, the elective deferral limit is \$22,500 for individuals under the age of 50 and \$30,000 for individuals who attained the age of 50 prior to or during 2023. Participants may also contribute amounts representing rollover contributions from other qualified defined benefit or defined contribution plans. Participants can change their salary deferral elections at any time during the Plan year.

1. Description of the Plan, Continued

Employer Contributions

The Plan's provisions permit the Plan Sponsor to make two types of employer discretionary contributions. The first is an Employer Discretionary Matching Contribution, which may be made each Plan year to eligible participants. The formula for the Employer Discretionary Matching Contribution is determined annually by the Plan Sponsor, and is based on employee elective deferral contributions.

The second type of employer discretionary contribution is an Employer Profit-Sharing Contribution. The Employer Profit-Sharing Contribution is determined annually by the Plan Sponsor.

During 2023, the Plan Sponsor authorized matching contributions of \$78,460 for the Plan year ended December 31, 2022, which were included as employer contributions receivable at December 31, 2022. During 2023, the Plan Sponsor elected not to make any matching contributions through the date of the Plan termination. Accordingly, there were no amounts included as employer contributions receivable at November 2, 2023.

Participant Accounts

Individual accounts are maintained for each participant of the Plan. Each participant's account is credited with the participant's rollover contributions, the participant's elective deferral contributions, the Plan Sponsor's employer contributions, and an allocation of Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. Participants may direct the investment of their account balances into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting of Contributions

Participants are immediately 100% vested in their elective deferral contributions to the Plan, plus earnings thereon. The Plan Sponsor's contributions plus actual earnings thereon vest at the graduated rate of 20% per year beginning with the second year of service, and become 100% vested after five years of service, as follows:

All Company contributions and earnings thereon, become 100% vested upon a participant being employed on or after their Normal Retirement Age, or upon death or disability. Normal Retirement Age is 65, as defined in the Plan document.

Forfeitures

The non-vested portion of a participant's account is forfeited upon termination of employment. Forfeitures are retained in the Plan and may be used to reinstate forfeited balances of re-hired employees, pay Plan administrative expenses, or reduce future employer contributions.

For the period ended November 2, 2023, the Plan had forfeitures of \$518. In addition, during 2023, no forfeitures were used to pay administrative expenses and forfeitures of \$203 were used to reduce employer contributions. In conjunction with the termination of the Plan, unallocated forfeitures of \$8,922 were transferred to Voya on November 2, 2023. At November 2, 2023 and December 31, 2022, there were remaining unallocated forfeitures of \$0 and \$8,607, respectively.

Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum of the lesser of \$50,000 or 50% of the participant's vested account balance. The minimum loan amount is \$1,000. Loan terms cannot exceed five years except for the purchase of a primary residence which cannot exceed fifteen years. The loans are secured by the balance in the participant's account and bear interest at 1% above the prime rate in effect as of the date of the loan application. Principal and interest payments are paid through periodic payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive the value of the vested interest in his or her account in a lump-sum payment or installments over a period of not more than assumed life expectancy. If the vested amount in a participant's account does not exceed \$5,000, the payment must be a lump-sum distribution. Participants are eligible to receive 100% of their vested account balance at normal retirement (age 65), death, or permanent disability. Participants who terminate employment are eligible to receive their vested account balance after separation from service.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements have been prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

Investments are stated at fair value as certified by the Plan's custodian, John Hancock. Quoted market prices are used to value investments. Shares of registered investment company funds (mutual funds) are valued at the net asset value of shares held by the Plan at year end. However, as these investments are deemed to be actively traded at the publicly listed price, mutual funds are considered to be recorded at fair value. Interest-bearing cash equivalents, if any, are recorded at fair value, which approximates cost.

Investment Valuation and Income Recognition, Continued

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. The Plan presents in the Statement of Changes in Net Assets Available for Benefits the net appreciation or depreciation in the fair value of its investments, which consist of realized gains (losses) and unrealized appreciation (depreciation) on those investments, as well as interest and dividend income.

Notes Receivable from Participants

Notes receivable from participants are stated at their outstanding balances, including any accrued but unpaid interest, which approximates fair value. Interest income is recorded on the accrual basis, and related fees are recorded as administrative expenses as incurred. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of November 2, 2023 and December 31, 2022.

Benefit Payments to Participants

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. All other costs associated with administering the Plan are charged to all individual participant accounts, based on the individual participants' account balances at the date of payment.

Excess Contributions

Plan contributions are subject to certain discrimination testing and legislative limits. When contributions exceed the permitted limits, the affected participants receive a corrective distribution of the excess amounts that had been recorded as contributions. These corrective distributions are recorded as deductions from Plan assets when paid to the participants, which usually occurs in the year after the contributions were made.

Fair Value Measurements

ASC Topic 820, *Fair Value Measurements and Disclosures*, establishes a fair value hierarchy for those assets and liabilities measured at fair value, that distinguishes between assumptions based on market data (observable inputs) and the Plan's own assumptions (unobservable inputs). The hierarchy consists of: Level 1 – quoted market prices in active markets for identical instruments; Level 2 – inputs other than Level 1 inputs that are observable; and Level 3 – unobservable inputs developed using estimates and assumptions determined by the Plan.

Fair Value Measurements, Continued

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 2, 2023 and December 31, 2022.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and therefore are included in Level 1 of the hierarchy.

Stable value fund: The stable value fund invests in fully benefit-responsive guaranteed investment contracts (GICs), which are general obligations of insurance companies that issue the contracts, as well as synthetic GICs and other financial instruments. The stable value fund trades daily at its net asset value (NAV), which is based on the contract value of the underlying GICs and the fair values of other investments. Because the stable value fund is valued similarly to mutual funds, the Plan believes they should be Level 1 assets to allow for consistent disclosure.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates and affect the amounts reported in the financial statements.

Subsequent Events

The Plan's management has evaluated subsequent events through September 9, 2024, the date as of which these financial statements were available to be issued. No material subsequent events have occurred since November 2, 2023 that required recognition or disclosure in these financial statements.

3. Investments

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at November 2, 2023 and December 31, 2022, and net appreciation in the fair value of investments for the period ended November 2, 2023, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the custodian, John Hancock, as permitted by 29 CFR 2520.103-8 of the Department of Labor's *Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974*.

4. Risks and Uncertainties

The Plan invests in a combination of mutual and common/collective investment trust funds. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities may occur and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

5. Information Certified by the Custodian

The Plan administrator has received certification from John Hancock (see Note 3) that the following information is complete and accurate:

- Investments reflected on the accompanying Statements of Net Assets Available for Benefits as of November 2, 2023 and December 31, 2022.
- Notes receivable from participants reflected on the accompanying Statements of Net Assets Available for Benefits as of November 2, 2023 and December 31, 2022.
- Net appreciation in fair value of investments and interest and dividend income from investments reflected on the accompanying Statement of Changes in Net Assets Available for Benefits for the period ended November 2, 2023.
- Investments reflected on the supplemental Schedule H, line 4i – Schedule of Assets (Held at End of Year) as of November 2, 2023.

6. Related Parties and Parties-in-Interest Transactions

Plan investments are managed by John Hancock through participation units held in mutual funds and a stable value fund. John Hancock is the Plan's custodian and record keeper and, therefore, these investments and transactions qualify as party-in-interest transactions. For the period ended November 2, 2023, the Plan paid administrative expenses to John Hancock of \$484. As of November 2, 2023 and December 31, 2022, the Plan also had an interest-bearing cash account with John Hancock with a balance of \$0 and \$8,607, respectively.

Hunter Benefits Consulting Group (Hunter) provides third party administrative services to the Plan and is considered to be a party-in-interest to the Plan. Fees paid by the Plan to Hunter for plan administrative services totaled \$1,950 during the period ended November 2, 2023.

7. Transfer of Balances

During the period ended November 2, 2023, EZ Loader Boat Trailers, Inc., the sponsor of the Plan elected to terminate the Plan and transfer assets to Voya Financial, the trustee for Enterprise Select Pooled Employer Plan. In connection with the termination of the Plan, the investment balances and participant notes receivable balances as of November 2, 2023 were transferred from the Plan to Voya Financial (see Note 8).

8. Plan Termination

During 2023, a decision was made to terminate the Plan and transfer assets to the Enterprise Select Pooled Employer Plan (PEP) with Voya Financial. On November 2, 2023, investment balances (including unallocated forfeiture balances) and participant notes receivable balances totaling \$5,503,822 and \$66,124, respectively, were transferred from John Hancock to Voya Financial, the trustee for the PEP. The Plan assets were received and recorded by Voya effective November 2, 2023, and the Plan was terminated as of that date.

9. Plan Tax Status

The Plan Sponsor adopted a prototype plan whose most recent opinion letter from the Internal Revenue Service, dated March 31, 2014, stated that the Plan was designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended from the original prototype document, most recently effective July 1, 2022; however, the Plan Administrator believes the Plan is currently operated in compliance with the applicable requirements of the IRC.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of November 2, 2023 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

10. Reconciliation of Financial Statements to Form 5500

Form 5500, which is filed with the Department of Labor, has items that differ from the amounts shown on the accompanying Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits. These differences are classification differences only and have no effect upon net assets available for benefits or changes in net assets available for benefits.
