### Report on the Audit of the Financial Statements

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of The Wills Group, Inc. Employees' Pension Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of November 22, 2023 (in liquidation) and December 31, 2022 (ongoing), and the related statements of changes in net assets available for benefits for the period ended November 22, 2023 (in liquidation) and for the year ended December 31, 2022 (ongoing), the statement of accumulated plan benefits as of December 31, 2022 (ongoing) and the related statement of changes in accumulated plan benefits for the year then ended (ongoing) and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Wills Group, Inc. Employees' Pension Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of November 22, 2023 and December 31, 2022, and for the period ended November 22, 2023 and the year ended December 31, 2022, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

#### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting from the ongoing basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

***Auditors' Responsibilities for the Audit of the Financial Statements***

**NOTE 1 DESCRIPTION OF PLAN**

The following description of The Wills Group, Inc. Employees' Pension Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

**General**

The Plan is a noncontributory defined benefit plan, was established on September 1, 1974, and covers the employees of The Wills Group, Inc. and its subsidiaries (the Company). The Wills Group, Inc. Pension and Value Sharing Administration Committee (Pension Committee), which is appointed by the Board of Directors of the Company, administers the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Board of Directors of the Company voted on October 23, 2007 to freeze the Plan with regard to admittance and accrual of benefits effective March 31, 2008. Prior to March 31, 2008, each employee of the Company who attained age 18 and who completed 1,000 hours of service in a calendar year was eligible to participate in the Plan.

Effective April 1, 2008, no new employees have been permitted to enter the Plan. Except for certain "grandfathered" participants (described below), all accruals under the Plan were also frozen as of April 1, 2008, meaning that no service performed or compensation earned after April 1, 2008, shall be counted in calculating Plan benefits. The freeze does not apply to any participant who, as of December 31, 2007, had either (a) attained age 55 or older and completed at least ten years of service for vesting purposes, or (b) completed at least 20 years of service for vesting purposes. Such "grandfathered" participants will continue to accrue benefits under the Plan under the same terms as prior to the freeze until the Plan termination May 1, 2022. Effective May 1, 2014, the Plan was amended to freeze benefit accruals for all highly compensated employees.

Effective May 1, 2022, the Plan was approved for termination. During 2023, the Plan filed appropriate paperwork with the PBGC and notified all participants of their options for distribution. Participants could elect a lump sum distribution or continue to receive annuity payments through an annuity contract the Company purchased from an insurance company. The Plan paid out benefits to participants including \$55,063 in benefits for missing participants that were transferred to the PBGC. The Plan also purchased an annuity contract with Omaha to satisfy the remaining accumulated plan benefits. All plan assets were distributed and Management determined liquidation was deemed imminent as of and for the period ended November 22, 2023.

**Pension Benefits**

Under the Plan, upon normal retirement (age 65) and completion of five continuous Plan years, and deferred retirement, participants shall be eligible to receive benefits based on the value of their vested accrued benefit. The standard form of benefit payments is a lump sum and life annuity for single members of the Plan and 50% joint and survivor annuity for married members of the Plan. A participant's pension benefit is limited to a maximum amount under the terms of the Plan.

Participants who have completed at least ten years of service and who terminated participation before reaching age 60 may elect to commence receiving deferred vested retirement benefits on the first day of any month after their 60<sup>th</sup> birthday and prior to their normal retirement date. A participant may continue in the employment of the Company after his or her normal retirement date. In such event, the participant will receive, at actual retirement, the greater of the actuarial equivalent of his or her normal retirement benefit, or the benefit on service and compensation as of his or her actual retirement date.

**Death and Disability Benefits**

If an active employee dies at age 65 or older, a death benefit equal to the value of the employee's accumulated pension benefits is paid to the employee's beneficiary. If an active unmarried participant dies before the age of 65, no death benefits are paid to beneficiaries. If a vested participant who is married dies after the attainment of early retirement but before his or her annuity starting date, the participant's surviving spouse will receive the same benefit that would have been payable if the participant had retired with an immediate joint and 50% survivor spouse annuity on the day before death. If an active employee becomes totally and permanently disabled and they receive disability benefits from the Company-sponsored insured long-term disability program, they will receive disability benefits from the Plan when the long-term disability benefits from the insurance program ends or age 65, whichever is later. If an active employee becomes totally disabled and they are not eligible to receive disability benefits from a Company-sponsored insured long-term disability program, they may elect to receive a disability benefit from the Plan beginning immediately, which is based on their vested accrued benefit.

**Vesting**

Participants accrue benefits based on length of active service and vest 100% in the accrued benefits after five years of service. An employee who completes five consecutive years of employment with at least 750 hours each year is considered a full-time employee and becomes fully vested.

**Funding Policy**

The Plan Sponsor contributes such amounts as are deemed necessary on an actuarial basis to provide the Plan with assets sufficient to meet the benefits to be paid to members of the Plan and to meet minimum funding standards as required by law. Required contribution levels are based upon the payment of the current normal cost for each participant, as well as amortization of the total unfunded actuarial accrued liabilities. The Plan has met the minimum funding requirements established by ERISA for 2023 and 2022.

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. Effective May 1, 2022, the Plan froze all accrued participant benefits and no additional benefits will be accrued after this date.

**Purchase of Annuity Contract**

The Plan signed an agreement, dated September 6, 2023, with United of Omaha Life Insurance Company (Omaha) (the insurance company) to annuitize the remaining accumulated plan benefits and transfer liability to the insurance company effective November 1, 2023 (benefit commencement date). Annuities purchased and paid to the insurance company totaled \$6,344,319 for the period ended November 22, 2023.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Presentation**

As a result of Plan termination, Plan management has determined liquidation of the Plan is deemed imminent during 2023 upon distribution of all plan assets and completing the annuity purchase. In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting from the accrual basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements. Under the liquidation basis of accounting, assets are stated at their estimated net realized cash value expected to be collected in settling or disposing of assets during the liquidation process and liabilities are stated at their anticipated settlement amounts.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, disclosure of contingent assets and liabilities and the actuarial present value of accumulated plan benefits as of the date of the financial statements, and changes therein. Actual results could differ from the estimates. The Plan uses an actuary to determine the actuarial present value of accumulated plan benefits. A change in the actuarial assumptions used could significantly change the amount of the actuarial present value of accumulated plan benefits reported in the accompanying financial statements.

**Valuation of Investments and Income Recognition**

Investments are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Pension Committee determines the Plan's valuation policies utilizing information provided by its investment advisers and trustee and insurance company. See Note 5 for a discussion of fair value measurements. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Payment of Administrative Expenses**

The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as administrative expenses in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation (depreciation) of fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

**Subsequent Events**

The Plan has evaluated subsequent events through September 4, 2024, the date the financial statements were available to be issued.

**NOTE 3 ACTUARIAL PRESENT VALUE OF ACCUMULATED PLAN BENEFITS**

Accumulated plan benefits are those future periodic payments, including lump-sum distributions that are attributable under the Plan's provisions to the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to:

- a) retired or terminated employees or their beneficiaries,
- b) beneficiaries of employees who have died, and
- c) present employees or their beneficiaries.

Benefits under the Plan are accumulated based on employees' highest five complete consecutive credited years of service during his or her last ten-latest years prior to the normal retirement. Benefits payable under all circumstances are included, to the extent they are deemed attributable to employee service rendered to the valuation date. Benefits to be provided via annuity contracts excluded from Plan assets are excluded from accumulated plan benefits. The actuarial present value of accumulated plan benefits is determined by an independent actuary and is the amount that results from applying actuarial assumptions to adjust the accumulated plan benefits earned by participants to reflect the time value of money and the probability of payment between the valuation date and the expected date of payment.

The most significant actuarial assumptions used in the valuation as of December 31, 2022, were as follows:

- a) Life expectancy of Participants – Based on Pri-2012 Total dataset base rate mortality table projected generationally using MP-2021.
- b) Retirement Age Assumptions – All employees are assumed to retire at the later of age 65 or current age.
- c) Investment Return – 4.25%

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. The computations of the actuarial present value of accumulated Plan benefits were made as of January 1, 2023 after the decision to terminate the Plan. The Plan's accumulated plan benefits were adjusted as a result. Had the valuations been performed as of December 31, 2022 there would be no material differences. The investment return used at December 31, 2021 was 5.75%. Subsequent to the benefit information date, all accumulated benefits were either distributed to participants or transferred to an insurance carrier, as described in Note 1, thereby satisfying the benefit obligation in its entirety.

**NOTE 4 CERTIFICATION OF INVESTMENT INFORMATION**

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedules, including investments held at November 22, 2023 and December 31, 2022, and net appreciation (depreciation) in fair value of investments, interest, and dividends for the period ended November 22, 2023 and year ended December 31, 2022, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Principal Life Insurance Company, the qualified institution of the Plan.

**NOTE 5 FAIR VALUE MEASUREMENTS**

The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under this guidance are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the assets or liabilities;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

*Pooled Separate Accounts:* Valued at the NAV of the shares held by the Plan as determined by the insurance company or trust company. NAV is a readily determinable fair value and is the basis for current transactions.

**NOTE 6 PLAN TERMINATION**

Effective May 1, 2022, the Company approved the termination of the Plan. As of the effective date of termination, all participants became fully vested and the net assets of the Plan were allocated, as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

1. Annuity benefits that former employees or their beneficiaries have been receiving for at least three years, or the employees eligible to retire for that three-year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority amount is limited to the lowest benefit that was payable (or would have been payable) during those three years. The amount is further limited to the lowest benefit that would be payable under Plan provisions in effect at any time during the five years preceding Plan termination.
2. Other vested benefits insured by the Pension Benefit Guaranty Corporation (PBGC) (a U.S. government agency) up to the applicable limitation.
3. All other vested benefits (that is, vested benefits not insured by the PBGC).
4. All nonvested benefits.

Certain benefits under the Plan are insured by the PBGC. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination.

Whether all participants receive their benefits should the Plan terminate at some future time will depend on the sufficiency, at the time, of the Plan's net assets to provide for accumulated benefit obligations, and may also depend on the financial condition of the Plan's Sponsor and the level of benefits guaranteed by the PBGC. The Plan has filed a notice with the Internal Revenue Service (IRS) to fully terminate the Plan effective May 1, 2022 and is waiting for a favorable determination letter from the IRS for the termination.

**NOTE 7 PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are managed by Principal Life Insurance Company, who is the qualified institution, as defined by the Plan; therefore, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under ERISA.

**NOTE 8 TAX STATUS**

The Plan obtained its latest determination letter on August 10, 2017, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. The Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions.

**NOTE 9 RISKS AND UNCERTAINTIES**

The Plan invests in various types of investment securities, which are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is possible that changes in the values of investment securities may occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Plan contributions are made and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimates and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
