### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Anchor Insulation Co., Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of November 30, 2023 (in liquidation) and December 31, 2022 (ongoing), and the related statement of changes in net assets available for benefits for the period from January 1, 2023 through November 30, 2023 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of November 30, 2023 and December 31, 2022, and for the period from January 1, 2023 through November 30, 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Emphasis of Matter: Plan Termination**

As described in Note 1 to the financial statements, in March 2023 the Plan was amended to provide for termination of the Plan, and management determined liquidation was imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements. Our opinion is not modified with respect to that matter.

On November 30, 2023, the Plan terminated upon becoming fully liquidated.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. ## 1. DESCRIPTION OF THE PLAN

The following description of Anchor Insulation 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

### General

The Plan was a defined contribution plan covering substantially all employees of Anchor Insulation Co., Inc. (the Company) who had three months of eligible service and were the age of eighteen or older. Participants were able to enter the Plan on the first day of the month following the date of eligibility. The Plan was qualified under Section 401(k) of the Internal Revenue Code (IRC) and was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

### Plan Termination

In March 2023, the Plan was amended to provide for termination of the Plan. Effective March 10, 2023, participants became 100% vested in their employer contributions and actual earnings thereon. Each affected participant received the value of his or her account on or before November 30, 2023 in accordance with the plan agreement. All documents necessary to effectuate the termination of the Plan have been executed.

On November 30, 2023, the Plan terminated upon becoming fully liquidated.

### Automatic Enrollment

The Company elected to utilize an automatic enrollment policy. Participants became automatically enrolled into the Plan, after meeting eligibility requirements, unless the eligible participant specifically opted out of the Plan. Participants were automatically enrolled in the Plan at 4% of their eligible compensation, as defined in the plan agreement. Unless such participants affirmatively elected otherwise, their deferral rate increased annually by 1%, as a pre-tax deferral contribution, until a deferral rate of 10% was reached.

### Contributions

Each year, participants had the option to contribute up to 100% of their eligible compensation as defined in the plan agreement, not to exceed the dollar limitations as established by the Internal Revenue Service (IRS). Participants who attained age 50 before the end of the Plan year were also eligible to make catch-up contributions. Participants had the option to contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

In addition, participants had the option to make Roth (after tax) contributions to the Plan. The amount of Roth contributions a participant might have made was limited to the maximum allowed IRS contribution limit less any pre-tax contributions made. The Plan allowed in-plan Roth conversions under the current in-service withdrawal provisions, as defined in the plan agreement.

The Company had the option to make the following discretionary contributions to the Plan:

- A discretionary employer matching contribution. For the period ended November 30, 2023, the Company made a discretionary matching contribution equal to 50% of each participant's contribution. The employer match was limited to a maximum of 4% of the participant's eligible compensation.
- A prevailing wage contribution based on rates that satisfy the wage determination issued by the governmental agency responsible for certain contracts. For the period ended November 30, 2023, the Company did not make a prevailing wage contribution.
- An additional discretionary profit-sharing contribution to the Plan, which was allocated to eligible participants based on total compensation for the plan year. The Company did not make an additional discretionary profit-sharing contribution to the plan for the period ended November 30, 2023.
- A qualified non-elective contribution to the Plan to satisfy certain IRS testing provisions. Such contribution was allocated among all non-highly compensated participants of the Plan, as defined in the plan agreement. The Company did not make a qualified non-elective contribution to the plan for the period ended November 30, 2023.

Participants directed the investment of all contributions into various investment options offered by the Plan. The Plan offered various mutual funds and a common/collective trust as investment options for participants.

### Participant Accounts

Each participant's account was credited with the participant's contributions and allocations of (a) the Company's discretionary employer matching contributions, if any, (b) the Company's prevailing wage contributions, if any, (c) the Company's discretionary profit sharing contributions, if any, (d) the Company's qualified non-elective contributions, if any, and (e) plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan and included within plan earnings. Allocations were based on participant earnings, account balances, or specific participant transactions, as

defined in the plan agreement. The benefit to which a participant was entitled was the benefit that could have been provided from the participant's vested account.

### Vesting

Participants were vested immediately in their contributions and any employer contributions made to satisfy prevailing wage and IRS testing provisions plus actual earnings thereon. Vesting in the employer matching contributions and any additional Company discretionary profit-sharing contributions portion of their account plus actual earnings thereon, occurred in 20% increments commencing upon the completion of two years of service, with 100% vesting upon completion of six years of credited service, disability, normal retirement, or death, all as defined in the plan agreement. In connection with the Plan's termination, effective March 10, 2023, participants became 100% vested in their employer contributions and actual earnings thereon.

### Participants Loans

The Plan did not allow participant loans.

### Payment of Benefits

On termination of service due to death, disability, retirement or other termination of employment, a participant could have elected to receive their benefits in a lump-sum payment or periodic installments. If the participant's vested account balance did not exceed \$5,000, the distribution was paid in one lump-sum. If the participant's vested account balance was \$1,000 or less, the amount would have been automatically rolled over to an individual retirement account.

All participant account balances have been distributed as of November 30, 2023.

### Early Withdrawals

Participants who attained age 59 ½ had the option to make in-service withdrawals from their eligible account balance, as defined in the plan agreement, upon written request to the plan administrator. In the event of serious financial hardship, participants could have elected to withdraw up to 100% of the value of their eligible account balance, as defined in the plan agreement.

### Forfeited Accounts

Forfeited amounts could have been used to reduce future employer contributions or certain plan expenses. In 2023, employer contributions were reduced by approximately \$7,700 from the use of forfeited amounts. As of November 30, 2023, there were no unused forfeitures. In 2022, employer contributions were reduced by approximately \$34,000 from the use of forfeited amounts. As of December 31, 2022, there were no unused forfeitures.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### Basis of Accounting

The accompanying financial statements as of and for the period ended November 30, 2023 have been prepared on the liquidation basis of accounting. This basis of accounting is considered appropriate when, among other things, liquidation of an entity is probable and the net realizable value is determinable. Under the liquidation basis of accounting, assets are stated at their estimated net realized cash value and liabilities are stated at their anticipated settlement amounts. The estimated net realizable cash value for investments as of November 30, 2023 would be fair value.

The statement of net assets available for benefits as of December 31, 2022 has been prepared using the ongoing basis of accounting.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the Newport Trust Company (Newport Group), the Trustee of the Plan. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2022 excess contributions to the applicable participants prior to March 15, 2023.

### Payment of Benefits

Benefits are recorded when paid.

### Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

### Subsequent Events

The Plan has evaluated subsequent events through September 12, 2024, the date the financial statements were available to be issued.

## 3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/collective trust:* A Stable Value Fund that is composed primarily of group annuity contracts of Metropolitan Life Insurance Company that is valued daily at the net asset value of units of the collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the Stable Value Fund, the issuer reserves the right to require 60 days notification in order to ensure that securities liquidations will be carried out in an orderly business manner. (Further information regarding the common/collective trust may be obtained from its audited financial statements.)

### **5. TAX STATUS**

The Plan has adopted a prototype profit sharing plan of the Newport Group, which has received an opinion letter issued by the IRS dated June 30, 2020 that the Plan is qualified under IRC Section 401(k). The plan administrator believes that the Plan was designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or the DOL. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits in progress for any tax periods.
