Note 1. Description of the Plan

The following description of the Bradshaw Automotive Companies 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan which was established for the benefit of employees of Bradshaw Automotive Companies (the "Company"). The Plan covers all eligible employees of the Company who have completed at least sixty days of service and have attained the age of eighteen years. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The trustee of the Plan is Ascensus Trust Company (the "trustee").

Plan termination

In January 2023, the Company's business was sold to a third party. In connection with this sale, after May 19, 2023, contributions to the plan were no longer allowed. In October 2023, the Company voted to terminate the Plan effective January 2, 2023 and determined that liquidation was imminent. As of the effective date, all active participants became 100 percent vested. Participants were given the option to roll their balances into the third party's plan or receive a distribution under the terms of the Plan. Final distributions from the Plan were paid on December 7, 2023. The Plan paid \$18,780,030 in distributions for the period ended December 7, 2023, which composed 100 percent of the balances in the Plan.

Contributions

Each year, participants may contribute up to 100 percent of pretax or after tax annual compensation, as defined in the Plan. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Company contributes 60 percent of the first 4 percent of base compensation that a participant contributes to the Plan. Additional profit sharing amounts may be contributed at the discretion of the Company. There was no discretionary profit sharing contribution for the period ended December 7, 2023. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Note 1. Description of the Plan, Continued

Participant accounts

Each participant's account is credited with the participant's contributions, Company contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their voluntary contributions plus actual earnings thereon. Vesting in the Company's matching and profit sharing contribution portions of their accounts is based on years of continuous service. A participant is 100 percent vested after 6 years of credited service. Participants became 100 percent vested in all contributions upon the termination of the Plan.

Notes receivable from participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested balance. The loans are secured by the balance in the participant's account. The loans bear interest at the Wall Street Journal prime rate published on the date of the loan application plus 1 percent. Principal and interest is paid ratably through payroll deductions over a period not to exceed 5 years.

Payment of benefits

On termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or other installment options as provided by the Plan. Hardship distributions are permitted upon demonstration of a financial hardship. All fully vested balances are available for distribution after the participant reaches the age of 59 1/2.

Pursuant to the Plan terms, distributions will be paid at the participants' election by (a) cash distribution of the participant's balance; (b) rollover distribution to an eligible retirement plan; or (c) a combination of cash distribution and rollover distribution to an eligible retirement plan.

Forfeited accounts

At December 07, 2023 and December 31, 2022, forfeited nonvested accounts totaled \$0 and \$3,334, respectively. These accounts can be used to reduce future Company contributions or pay Plan expenses. During 2023, forfeitures of \$23,248 and \$11,149 were used to reduce Company contributions and Plan expenses, respectively.

Note 2. Summary of Significant Accounting Policies

Basis of accounting

Due to the decision to terminate the Plan during 2023, Plan management determined liquidation of the Plan was imminent and the 2023 financial statements have been prepared using the liquidation basis of accounting. The 2022 financial statements were prepared as a going concern on the accrual basis of accounting.

Contributions

Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

There were no investments remaining in the Plan as of December 07, 2023.

All investments in the 2022 Statement of Net Assets Available for Benefits are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transactions between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a settlement-date basis. Interest income and dividends are recorded on the liquidation basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 07, 2023 and December 31, 2022.

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and other distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent events

The Plan has evaluated subsequent events through September 9, 2024, the date that the financial statements were available to be issued.

Recently issued accounting pronouncements

Accounting standards that have been issued or proposed by the Financial Accounting Standards Board or other standards-setting bodies are not expected to have a material impact on the Plan's financial statements.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly or indirectly, such as:
- Quoted prices for similar assets or liabilities in active markets.
 - Quoted prices for identical or similar assets or liabilities in inactive markets.
 - Inputs other than quoted prices that are observable for the asset or liability.
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 07, 2023 and December 31, 2022.

Collective trust fund:

Valued at net asset value (NAV). NAV as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount differing from the reported NAV. Participant transactions (purchases and sales) may occur daily.

Cash surrender value of life insurance policy:

Valued at the cash surrender value of the policy as reported by the insurer.

Mutual funds:

Note 5. Life Insurance Policy

The Plan purchased a whole life insurance policy on an individual on May 28, 2015, with the Plan named as beneficiary. As part of the Plan termination, the policy was surrendered and the cash surrender value for the policy of \$809,913 was paid to the individual's account. The total face amount of the policy approximated \$2,529,000 at December 31, 2022. The cash surrender value for this policy totaled \$762,896 at December 31, 2022. There were no insurance premiums paid by the Plan during 2023.

Note 6. Related-party and Party in Interest Transactions

Ascensus Trust Company (Ascensus) serves as the trustee as defined by the Plan, and therefore, qualifies as a party in interest. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made direct payments to Ascensus totaling \$43,733 which were not covered by revenue sharing. The Company pays directly any other fees related to the Plan's operations.

Note 7. Tax Status

Effective October 22, 2021, the Plan adopted a non-standardized pre-approved plan sponsored by Ascensus LLC, the plan provider. The plan provider has received an opinion letter from the IRS as to the pre-approved plan's qualified status. The pre-approved plan's letter has been relied upon by this Plan. The plan administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Note 1. Description of the Plan

The following description of the Bradshaw Automotive Companies 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan which was established for the benefit of employees of Bradshaw Automotive Companies (the "Company"). The Plan covers all eligible employees of the Company who have completed at least sixty days of service and have attained the age of eighteen years. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The trustee of the Plan is Ascensus Trust Company (the "trustee").

Plan termination

In January 2023, the Company's business was sold to a third party. In connection with this sale, after May 19, 2023, contributions to the plan were no longer allowed. In October 2023, the Company voted to terminate the Plan effective January 2, 2023 and determined that liquidation was imminent. As of the effective date, all active participants became 100 percent vested. Participants were given the option to roll their balances into the third party's plan or receive a distribution under the terms of the Plan. Final distributions from the Plan were paid on December 7, 2023. The Plan paid \$18,780,030 in distributions for the period ended December 7, 2023, which composed 100 percent of the balances in the Plan.

Contributions

Each year, participants may contribute up to 100 percent of pretax or after tax annual compensation, as defined in the Plan. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Company contributes 60 percent of the first 4 percent of base compensation that a participant contributes to the Plan. Additional profit sharing amounts may be contributed at the discretion of the Company. There was no discretionary profit sharing contribution for the period ended December 7, 2023. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant accounts

Each participant's account is credited with the participant's contributions, Company contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their voluntary contributions plus actual earnings thereon. Vesting in the Company's matching and profit sharing contribution portions of their accounts is based on years of continuous service. A participant is 100 percent vested after 6 years of credited service. Participants became 100 percent vested in all contributions upon the termination of the Plan.

Notes receivable from participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested balance. The loans are secured by the balance in the participant's account. The loans bear interest at the Wall Street Journal prime rate published on the date of the loan application plus 1 percent. Principal and interest is paid ratably through payroll deductions over a period not to exceed 5 years.

Payment of benefits

On termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or other installment options as provided by the Plan. Hardship distributions are permitted upon demonstration of a financial hardship. All fully vested balances are available for distribution after the participant reaches the age of 59 1/2.

Pursuant to the Plan terms, distributions will be paid at the participants' election by (a) cash distribution of the participant's balance; (b) rollover distribution to an eligible retirement plan; or (c) a combination of cash distribution and rollover distribution to an eligible retirement plan.

Forfeited accounts

At December 07, 2023 and December 31, 2022, forfeited nonvested accounts totaled \$0 and \$3,334, respectively. These accounts can be used to reduce future Company contributions or pay Plan expenses. During 2023, forfeitures of \$23,248 and \$11,149 were used to reduce Company contributions and Plan expenses, respectively.

Note 2. Summary of Significant Accounting Policies

Basis of accounting

Due to the decision to terminate the Plan during 2023, Plan management determined liquidation of the Plan was imminent and the 2023 financial statements have been prepared using the liquidation basis of accounting. The 2022 financial statements were prepared as a going concern on the accrual basis of accounting.

Contributions

Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

There were no investments remaining in the Plan as of December 07, 2023.

All investments in the 2022 Statement of Net Assets Available for Benefits are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transactions between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a settlement-date basis. Interest income and dividends are recorded on the liquidation basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 07, 2023 and December 31, 2022.

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and other distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent events

The Plan has evaluated subsequent events through September 9, 2024, the date that the financial statements were available to be issued.

Recently issued accounting pronouncements

Accounting standards that have been issued or proposed by the Financial Accounting Standards Board or other standards-setting bodies are not expected to have a material impact on the Plan's financial statements.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly or indirectly, such as:
- Quoted prices for similar assets or liabilities in active markets.
 - Quoted prices for identical or similar assets or liabilities in inactive markets.
 - Inputs other than quoted prices that are observable for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Collective trust fund:

Valued at net asset value (NAV). NAV as provided by the trustee, is used as a practical expedient to estimate fair value. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount differing from the reported NAV. Participant transactions (purchases and sales) may occur daily.

Cash surrender value of life insurance policy:

Valued at the cash surrender value of the policy as reported by the insurer.

Note 5. Life Insurance Policy

The Plan purchased a whole life insurance policy on an individual on May 28, 2015, with the Plan named as beneficiary. As part of the Plan termination, the policy was surrendered and the cash surrender value for the policy of \$809,913 was paid to the individual's account. The total face amount of the policy approximated \$2,529,000 at December 31, 2022. The cash surrender value for this policy totaled \$762,896 at December 31, 2022. There were no insurance premiums paid by the Plan during 2023.

Note 6. Related-party and Party in Interest Transactions

Ascensus Trust Company (Ascensus) serves as the trustee as defined by the Plan, and therefore, qualifies as a party in interest. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made direct payments to Ascensus totaling \$43,733 which were not covered by revenue sharing. The Company pays directly any other fees related to the Plan's operations.

Note 7. Tax Status

Effective October 22, 2021, the Plan adopted a non-standardized pre-approved plan sponsored by Ascensus LLC, the plan provider. The plan provider has received an opinion letter from the IRS as to the pre-approved plan's qualified status. The pre-approved plan's letter has been relied upon by this Plan. The plan administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.
