## Independent Auditor's Report

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Uptake Technologies, Inc. Retirement Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). #### Note 1. Plan Description

The following brief description of the Uptake Technologies, Inc. Retirement Trust (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General: The Plan was a defined contribution plan that covered all eligible employees of Uptake Technologies, Inc. (the Company). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2024, the Plan merged with Vensure Employer Services, Inc. 401(k) Profit Sharing Plan and all the assets of the Plan transferred title to Vensure Employer Services, Inc. 401(k) Profit Sharing Plan as of the effective date of the merger.

Eligibility: Employees were eligible to participate in the Plan immediately upon hire. Those employees covered by a collective bargaining agreement, reclassified employees, temporary, part-time, seasonal, independent contractors, certain nonresident aliens and residents of Puerto Rico were not eligible to participate in the Plan.

Contributions: Each year, participants were able to contribute a portion of annual compensation, as defined in the Plan, up to limits set by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit and contribution plans (rollover).

Effective January 1, 2023, the Plan was amended to include an automatic enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 6 percent of eligible compensation, as defined, and their contributions invested in a designated balanced fund until changed by the participant. Automatically enrolled participants would have had their deferral rate increase by 1 percent on the anniversary of their enrollment date until their deferral rate reached 10 percent.

The Company provided a safe harbor matching contribution of 100 percent of the participant's salary deferrals up to 3 percent of eligible compensation, as defined, and then 50 percent of participant's salary deferrals up to the next 2 percent of eligible compensation, as defined. The Company could have made additional profit-sharing contributions determined by the Company's Board of Directors. No profit-sharing contributions were made in 2023. Contributions were subject to limitations.

Investment options: Upon enrollment in the Plan, a participant could have directed contributions in a variety of investment choices as more fully described in the Plan's literature. Participants could have changed their investment options at any time.

Participant accounts: Each participant's account was credited with the participant's contribution, Company safe harbor matching contributions as well as allocations of the Company's profit-sharing contributions, if any, and Plan earnings/losses. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings or account balances or compensation, as defined. The benefit to which a participant is entitled was the benefit that could be provided from the participant's vested account.

Vesting: Participants were immediately vested in their contributions and Company safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's discretionary profit-sharing contributions portion of their accounts was based on years of continuous service. A participant was 100 percent vested after 2 years of credited service. Participants who attained retirement age 65 or who terminated employment due to death or disability were 100 percent vested in their account balances.

Notes receivable from participants: Participants could have borrowed from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance, whichever was less. The loan repayment period was not to exceed 5 years except for the purchase of a principal residence, in which case the repayment period was not to exceed 10 years. The loans were secured by the balance in the participant's account. The loan interest rate was set by the Plan Administrator. Principal and interest was paid ratably through payroll deductions.

Payment of benefits: On termination of service due to death, disability, or retirement, a participant could have elected to receive a lump-sum amount equal to the full or partial value of the participant's vested interest in his or her account. In addition, in-service withdrawals were permitted in certain situations as described in the plan agreement.

Forfeited accounts: At January 1, 2024, December 31, 2023 and 2022, forfeited non-vested accounts totaled \$0, \$35,012 and \$44,355, respectively. Forfeited non-vested accounts could have been used to pay for plan expenses or to reduce Company contributions. In 2023, \$122,481 from forfeited non-vested accounts was used to reduce Company contributions and \$22,313 was used to pay for plan expenses.

#### Note 2. Summary of Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affected the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment valuation and income recognition: The Plan's investments are stated at fair value, except for the fully benefit responsive investment contract which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Committee determines the Plan's valuation policies utilizing information provided by the investment trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the plan document.

Payment of benefits: Benefits are recorded when paid.

Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/(depreciation) in fair value of investments.

Subsequent events: The Plan Administrator has evaluated subsequent events for potential recognition and/or disclosure through August 27, 2024, the date the financial statements were available to be issued.

#### Note 3. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2023 and 2022, and net appreciation/(depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal), the trustee of the Plan.

#### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Accounting Standards Codification are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to their fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

*Shares of registered investment companies:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-ended mutual funds that were registered with the Securities and Exchange Commission. These funds were required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

*Common/collective trusts:* Common/collective trusts invest in collective trust funds as well as a variety of separate accounts and mutual funds. The fair values of all these investments were used in determining the NAV, as a practical expedient, of the collective investment trusts, which were not publicly quoted. In general, the majority of the underlying securities have observable level 1 quoted pricing inputs. While the underlying asset values were generally based on publicly quoted prices, the NAV of each individual common/collective trust was not valued using publicly quoted prices. Common/collective trusts could be redeemed on a daily basis and each common/collective trust had its own investment strategy. There were no restrictions, terms or conditions under which the investments could have been redeemed or sold.

#### **Note 5. Guaranteed Investment Contract with Insurance Company**

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Principal totaling \$0 for 2024, \$800,817 for 2023 and \$874,371 for 2022. Principal maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. The crediting rate was based on a formula established by the contract issuer but could not be less than 1 percent or greater than 3 percent. The crediting rate was reviewed on a semi-annual basis for resetting. The guaranteed investment contract did not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value was the relevant measure for fully benefit-responsive investment contracts because this was the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represented contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due was dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations could have been affected by future economic and regulatory developments.

Certain events might have limited the ability of the Plan to transact at contract value with the issuer. Such events included (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that caused a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events were probable of occurring that might have limited the ability of the Plan to transact at contract value with the contract issuers and that also would have limited the ability of the Plan to transact at contract value with the participants.

In addition, certain events could allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

#### **Note 6. Related Party and Party-in-Interest Transactions**

Principal was the trustee of the Plan, and therefore, transactions with Principal qualified as party-in-interest transactions.

MMA Securities, LLC provided certain advisory services to the Plan. Transactions with MMA Securities, LLC qualified as party-in-interest transactions.

The Plan issued loans to participants, which were secured by the participant's account balances. These transactions qualified as party-in-interest transactions.

Certain employees of the Company provided administrative services for the Plan and were not reimbursed for their services from the Plan.

Certain other administrative expenses were paid by the Company on behalf of the Plan. These amounts were not material to the financial statements.

#### **Note 7. Partial Plan Termination**

As a result of a reduction of the plan sponsor's workforce in 2023, the Plan experienced a partial plan termination as defined by ERISA. Under ERISA, a partial plan termination may occur if a significant percentage of the Plan's participants are terminated because of an action taken by the plan sponsor. If a partial plan termination occurs, full vesting is required for the terminated participants, but the remaining participants' vesting continues to be determined according to the plan provisions.

All terminated employees who were participants in the Plan were fully vested in their account balances at the date of the partial plan termination.

#### **Note 8. Tax Status**

The Plan had adopted a non-standardized pre-approved profit-sharing plan sponsored by Principal Life Insurance Co. The pre-approved profit-sharing plan had received an opinion letter from the Internal Revenue Service on June 30, 2020, stating that the pre-approved profit-sharing plan, as then designed, was in compliance with the applicable sections of the IRC. The plan administrator believed the Plan was designed and was currently operating in compliance with applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the U.S. federal, state, or local tax authorities. The Plan was subject to routine audits by taxing jurisdictions; however, there currently were no audits for any tax periods in progress.

#### **Note 9. Risks and Uncertainties**

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### **Note 10. Delinquent Participant Contributions**

For the year ended December 31, 2023, the Company did not remit certain participant contributions to the Plan on a timely basis as defined by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Untimely remittances identified on the Schedule of Delinquent Participant Contributions, which totaled \$1,769, have not yet been corrected.
