To the Plan Administrator
Nothum 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Nothum 401(k) Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of November 15, 2023 and December 31, 2022, and the related statements of changes in net assets available for benefits for the period ended November 15, 2023 and year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of and for the period ended November 15, 2023 and as of and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's elections of ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of the ERISA Section 103(a)(3)(C) audits is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control related matters that we identified during the audits.

Other Matter - Plan Merger

As described in Note 1 to the financial statements, effective November 9, 2023, the plan sponsor elected to merge the plan into the Open Pooled Employer Plan. As a result, all net assets of the plan were transferred to the Open Pooled Employer Plan during the period from January 1, 2023 to November 15, 2023.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of accounting - Nothum 401(k) Plan ("the plan") followed the accrual method of accounting wherein additions and deductions were reflected in the period earned or incurred.

Accounting estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Plan merger - Effective November 9, 2023, the plan sponsor elected to merge the plan into the Open Pooled Employer Plan. As a result, all net assets of the plan were transferred to the Open Pooled Employer Plan during the period from January 1, 2023 to November 15, 2023.

Subsequent events - The financial statements include management's evaluation of the events and transactions occurring subsequent to November 15, 2023 through August 26, 2024, which is the date the financial statements were available to be issued.

Key parties of the plan - Nothum Manufacturing Company, Inc. was the plan sponsor, employer and the plan administrator. Nationwide Trust Company, FSB was the investment agent that maintained investment and participant records and held custody of the mutual fund investments. Nationwide Life Insurance Company ("NLIC") was the investment agent that held custody of the fixed selected investment option. The two investment agents are collectively referred to as "Nationwide". Retirement Strategies, LLC was the third party administrator that maintained plan documents and tax counsel that performed various compliance tests. Two officers of the plan sponsor were the plan trustees. Morgan Stanley Wealth Management was the plan's investment advisor.

Investments - The plan sponsor determined the investments available to plan participants. The participants allocated their contributions and transferred existing balances among the available investment options. Earnings, including the net appreciation (depreciation) in fair value of investments bought, sold, and held during the year / period are reflected in the statements of changes in net assets available for benefits. Participants should refer to the prospectuses and annual reports of the investments for more information.

Fair value measurements - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following is a description of the valuation methodology used for investments measured at fair value.

Mutual funds - Valued at the daily quoted market prices as reported by the fund. Mutual funds held by the plan are registered with the U.S. Securities and Exchange Commission, are required to publish their daily net asset value and are deemed to be actively traded.

Investment at contract value - The plan offered a fully benefit-responsive fixed select investment option through NLIC. NLIC maintained the contributions made to this investment option in a general account. NLIC was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the plan. The interest crediting rate was reset quarterly. The average yield earned by the fund was 1.39% during 2023 and 0.98% during 2022.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the plan by NLIC, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants could direct the withdrawal of all or a portion of the investment at contract value at any time. Amounts could be transferred from the participant's account balance in the fund at any time.

The contract did not have a maturity date and there were no contract provisions that required a distribution at contract value at any specified time. There was no market value adjustment from contract value at the time of liquidation.

2. DESCRIPTION OF PLAN

The following description of the plan provides only general information. Participants should refer to the plan documents for a more complete description of the plan's provisions.

General - The plan was adopted effective January 1, 2018 as a defined contribution plan with a 401(k) salary deferral arrangement. It was subject to provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

Eligibility - Employees were eligible once they had completed 6 months of service and had reached age eighteen. An employee was deemed a participant and allowed to enter the plan on the first day of the plan quarter after meeting the eligibility requirements. Upon meeting these eligibility requirements, employees were also eligible to participate in employer safe harbor matching contributions.

Contributions - Contributions were recorded in the year in which the eligible compensation was paid. Contributions to the plan could be made in the following ways:

- a. Participants could contribute a percentage of their compensation subject to certain limitations (elective deferral contributions). The plan also permitted Roth elective deferral contributions.
- b. Rollover contributions were accepted by the plan from other qualified plans.
- c. Employer safe harbor matching contributions were made equal to 100% of the first 3% contributed by the employee and 50% of the next 2% contributed by the employee. These contributions were funded coinciding with each payroll.
- d. Profit sharing contributions could be made at the employer's discretion. There were no such contributions since the plan's inception.

Participant accounts - Earnings, including the fair value appreciation (depreciation), were allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account was credited with the participant's elective deferral and rollover contributions and an allocation of the employer's contributions. Participants were allowed to change their investment options on a daily basis and change their deferral percentage quarterly.

Vesting - Participant account balances were always 100% vested due to no profit sharing contributions since plan inception.

Payment of benefits - Benefits were recorded when paid. Benefit payments could commence upon termination of employment, retirement, death or disability. Distributions were generally in the form of a single lump sum payment. Hardship withdrawals were not permitted by the plan.

Administrative expenses - Certain administrative expenses of the plan were paid by the employer. Certain other administrative expenses were paid directly from plan assets and recorded as administrative expenses in the accompanying financial statements. Such expenses included participant directed charges for distribution fees and non-participant directed charges for investment advisory and contract administrator fees. Non-participant directed charges were allocated to the participants on an account value basis.

Notes receivable from participants - Participant loans were not permitted under the plan.

3. PARTY-IN-INTEREST TRANSACTIONS

Certain plan investment options were managed by Nationwide. Nationwide also held custody of the plan's investment assets. As such, transactions between Nationwide and the plan qualified as party-in-interest transactions. Direct fees paid by the plan to Nationwide for investment management services were \$44,000 in 2023 and \$25,000 in 2022. These direct fees are recorded as a reduction of net appreciation (depreciation) in fair value of investments in the accompanying statements of changes in net assets available for benefits. In addition, Nationwide provided certain administrative and recordkeeping services for the plan pursuant to a service agreement between the plan and Nationwide. Nationwide received revenue in the form of indirect compensation from mutual fund providers for services Nationwide provided to the funds. This revenue was used to offset certain other amounts that would otherwise be owed by the plan to Nationwide for its administrative and recordkeeping services to the plan. All of these party-in-interest transactions were exempt from the prohibited transaction rules of ERISA.

4. INCOME TAX STATUS

The plan was operating under a pre-approved profit sharing plan that received a favorable opinion letter on May 20, 2021. The favorable opinion letter from the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator did not obtain a separate Internal Revenue Service opinion or determination letter for the plan; however, the plan administrator and tax counsel believe the plan was designed and operated in compliance with the applicable requirements of the Internal Revenue Code.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken by the plan that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of November 15, 2023 and December 31, 2022. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.
