## Reasonable Cause – Missing Accountant Opinion

**Plan:** Tattooed Chef 401(k) Plan (Plan No. 001)  
**Plan Sponsor:** Tattooed Chef Inc. (EIN: 82-5457906)  
**Plan Year Period:** January 1, 2023 – November 29, 2023

The Plan Sponsor, Tattooed Chef Inc., filed a voluntary petition for relief under Chapter 11 of the United States Bankruptcy Code on July 2, 2023 in the Central District of California, Los Angeles Division (Case number 23-14154). On June 29, 2023 just prior to filing for bankruptcy the Plan Sponsor ceased all operations and terminated all the employees. The Plan Sponsor filed a plan of liquidation which was approved by the Court and declared effective on June 5, 2024. On June 6, 2024, Dundon Advisers LLC was appointed as the Liquidating Trustee to wind up the affairs of the Debtors.

Over a year prior to our appointment as the Liquidating Trustee, the Plan Sponsor effectuated the termination of the Plan on June 29, 2023, and on November 29, 2023 distributed all the assets of the Plan to participants. This decision was made and implemented by the prior management of the Plan Sponsor and the Chief Restructuring Officer, Ed Bidanset, without having a 2023 audit performed.

Moreover, due to the bankruptcy filed by the Plan Sponsor, information and/or documentation that would have been provided by the Plan Sponsor to the Auditor is no longer available, so the Independent Qualified Public Accountant's Opinion (the "IQPA Report") is unable to be completed at his time.

Even if the information could somehow be reconstructed, the cost of performing such an audit would be prohibitive and there are no funds available to pay for an audit. Additionally, the cost of meeting the requirement for an IQPA Report which could have been borne by the Plan's Participants is not available since the Plan had been fully distributed to the Plan Participants without performing the audit.

For all the forgoing reasons an exemption is respectfully requested from the IQPA Report requirement.
