INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Loyola University Supplemental Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of November 4, 2023 and December 31, 2022, and the related statements of changes in net assets available for benefits for the period from January 1, 2023 to November 4, 2023 and the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Loyola University Supplemental Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of November 4, 2023 and December 31, 2022, and for the period from January 1, 2023 to November 4, 2023 and the year ended December 31, 2022, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of Loyola University Supplemental Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

As disclosed in footnote 12, on June 23, 2023, the Board of Directors of Loyola University New Orleans approved the merging of the Main Retirement Plan and the Supplemental Plan into one Plan that will be referred to as "the Retirement Plan". The merger of the two plans replaces the mandatory contribution with an automatic enrollment feature to provide flexibility, among other provisions to incorporate certain features offered by the SECURE Act 2.0. The merger took place on November 4, 2023. The financial statements include all adjustments that have resulted from the merger. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Loyola University Supplemental Retirement Plan's ability to continue as a going concern within one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

Auditor's Responsibilities for the Audit of the Financial Statements (continued)

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Loyola University Supplemental Retirement Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Loyola University Supplemental Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1) Description of plan

The following description of the Loyola University Supplemental Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

a) General

The Plan is a defined contribution type of qualified retirement plan commonly referred to as a 403(b) plan, covering substantially all employees of Loyola University New Orleans (Employer or University). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

b) Contributions

Participants may make elective contributions to the Plan by deferring a percentage of their compensation each pay period up to a maximum of 100% of compensation or the statutory maximum dollar amount for the year. In addition, a participant who has attained age 50 before the close of the Plan year shall be eligible to make catch-up contributions in accordance with limitation under the Internal Revenue Code. The total of deferral cannot exceed the statutory maximum.

c) Participant accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) administrative expenses, and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

d) Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon.

e) Payment of benefits

Upon termination of service due to death, disability, retirement, or other reasons, a participant will receive a lump-sum amount, partial payments, installment payments or a distribution in the form of an annuity, equal to the value of the vested interest in his or her account. Participants may also receive in-service withdrawals for their vested account balance upon reaching 59½ years of age. Additionally, under certain circumstances of financial hardship, the participant is allowed to withdraw funds from the Plan.

f) Investment options

Upon enrollment in the Plan, a participant may direct employee contributions in a variety of investment options. Participants may change their investment allocations any time via telephone, internet, or written instructions.

g) Forfeitures

Since participants are immediately vested in their contributions and all earnings thereon, there are no forfeited accounts.

h) Plan loans

Plan loans are issued as separate contracts by Teachers Insurance Annuity Association of America's (TIAA) as contemplated under Internal Revenue Code (IRC) section 72(p)(5) and do not represent Plan assets. Using their account balance as collateral, participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of 50 percent of their vested account balance or \$50,000 subject to annuity contract and Plan provisions. Loans from a TIAA Annuity other than a Retirement Plan Loan are further limited to 45 percent of their vested account balance. Plan loan balances outstanding from participants to TIAA-CREF were \$-0- and \$68,008 as of November 4, 2023 and December 31, 2022, respectively. As the loans are not made directly from the participants' accounts, the loan amounts are not reported in the statements of net assets available for benefits.

h) Plan loans (continued)

There was no balance in defaulted loans outstanding as of November 4, 2023 and December 31, 2022. Loans in default are not required to be repaid until a triggering event occurs that would allow the participant to receive a distribution. The defaulted loan amount and any applicable penalties and interest are deducted from the resulting distribution prior to payment.

In the event a participant defaults, investment balances related to collateralized defaulted, non-distributed Plan loans are reported as the Plan Loan Default Fund on schedule H line 4(i) – schedule of assets held for investment by TIAA-CREF and included in the balance of insurance contracts reported on the statements of net assets available for benefits. The activity related to collateralized defaulted, non-distributed plan loans is reported by TIAA-CREF as other income on the statements of changes in net assets available benefits.

i) Notes receivable - participant loans

Participant loans (also referred to as Retirement Plan loans—RPL) are reported on statements of net assets available for benefit with related income and activity reported in the statements of changes to net assets. The interest rate for participant loans is fixed at the time of issuance and determined by the terms of the plan document (e.g., prime rate plus 1%). The repayments for participant loans are reinvested based on the participant's investment elections in place at the time of repayment. Participant loan balances outstanding as of November 4, 2023 and December 31, 2022, were \$-0- and \$14,093, respectively.

2) Summary of accounting policies

a) Basis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

b) Use of estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America, requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

c) Investment valuation and income recognition

The Plan's investments are stated at fair market value, except for the fully benefit-responsive insurance contracts described in 2(d). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 9 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

d) Insurance contracts

Contributions under the traditional annuity contract can be allocated to a group of contracts that are segregated into non-benefit and fully benefit-responsive categories. The contributions to these investments buy a contractual or guaranteed amount of future benefits for the investing participant. The contracts guarantee principal and a minimum interest rate and provide the opportunity for additional amounts in excess of the guaranteed rate.

d) Insurance contracts (continued)

Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. See note 10 for discussion of contract value measurements.

e) Other income

Other income consists of plan servicing credits which are revenue generated due to a change from premier share class to institutional share class insurance contracts to reduce to lower basis points. These funds were used to provide plan servicing credits to participants.

f) Payment of benefits

Benefits are recorded when paid. There were no amounts allocated to accounts of participants who have elected to withdraw from the Plan but had not yet been paid as of November 4, 2023.

g) Plan administrative costs

Administrative expenses paid by the Plan arise from fees for the processing of loans and distributions that are charged to their respective participants' accounts. In addition, certain investment accounts charge assets and participant fees that are allocated among the respected participants.

3) Investments

During the period from January 1, 2023 to November 4, 2023 and year ended December 31, 2022, the Plan's investments, including gains and losses on investments bought and sold, as well as held during the year, appreciated and (depreciated) in value by \$2,952,430 and \$(9,005,016), respectively.

4) Federal income tax status

The Plan has executed an adoption agreement using a non-standardized prototype profit sharing plan. The prototype plan received an opinion letter from the Internal Revenue Service dated August 7, 2017, in which the Internal Revenue Service stated the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan itself has not separately applied for a determination letter; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provisions for income taxes has been included in the Plan's financial statements.

United States generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is not subject to income tax examinations by tax authorities beyond three years from the filing of those returns.

5) Plan termination

Although it has not expressed any intent to do so, the University has the right under the Plan to terminate the Plan subject to the provisions of ERISA. The plan merger described in Note 13 does not constitute a plan termination as defined under ERISA.

6) Information certified by the trustee/custodian (unaudited)

7) Related party transactions

The Plan invests in a guaranteed interest account and other investment options offered and managed by TIAA, the trustee/custodian. Transactions in such investments qualify as party-in-interest transactions which are exempt from the prohibited transaction rules. Fees paid by the Plan for investment management services amounted to \$227,596 and \$138,582 for the period from January 1, 2023 to November 4, 2023 and year ended December 31, 2022, respectively.

8) Risks and uncertainties

Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9) Fair value measurement

Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

9) Fair value measurement (continued)

The three levels of the fair value hierarchy under Financial Accounting Standards Board ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 4, 2023 and December 31, 2022.

Pooled separate accounts: Valued at net asset value, which is fair market value, as the assets are marked-to-market on a daily basis.

Insurance contracts: Valued at fair value, which approximates contract value.

Mutual funds: Valued at the net asset value of shares held by the plan at year end.

Money market funds: Valued using quoted prices in the active markets in which funds are traded.

Equities: Valued using quoted prices in the active markets in which funds are traded.

Bond funds: Valued at the net asset value of shares held by the plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different measurement at the reporting date.

10) Fully benefit-responsive investment contracts

The Plan has entered into a fully benefit-responsive investment contract with TIAA. TIAA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by TIAA. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may direct the withdrawal or transfer of all or a portion of their investment at contract value. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

10) Fully benefit-responsive investment contracts (continued)

Because the contract is fully benefit-responsive, contract value is the relevant measurement attributable for that portion of net assets available for benefits attributable to the investment contract. Contract value approximates the fair value of the contract. Participants may ordinarily direct the withdrawal or transfer all or a portion of their investments at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The fair value of the investment contract was \$-0- and \$22,747,292 on November 4, 2023 and December 31, 2022, respectively.

Certain events may limit the ability to transact at contract value with TIAA. Such events include retirement, severance from employment, hardship, loan, death, disability or in-service withdrawal after age 59 ½. Upon occurrence of any of these events, a market value adjustment may apply.

TIAA may terminate the contract with 90 days advance written notice to the contract owner to pay out the full value without contract fees or market value adjustment.

The weighted average yield and the crediting interest rate as of November 4, 2023 and December 31, 2022 was 6.16% and 3.40%, respectively. The crediting interest rate fluctuates each quarter. The minimum guaranteed interest rate is established annually for purposes of crediting interest to contributions allocated to the general account.

11) Excess contributions

The Plan was required to return contributions received during the Plan year in excess of the IRC limits. The total of these excess contributions were \$3,000 and are included in benefits paid to participants in the statements of changes in net assets available for benefits.

12) SECURE Act 2.0

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Most of the significant provisions will become effective in 2024 and thereafter. Accordingly, there is no material impact to the Plan's 2023 financial statements.

13) Plan merger

On June 23, 2023, the Board of Directors of Loyola University New Orleans approved the merging of the Main Retirement Plan and the Supplemental Plan into one Plan that will be referred to as "the Retirement Plan". The merger of the two plans replaces the mandatory contribution with an automatic enrollment feature to provide flexibility, among other provisions to incorporate certain features offered by the SECURE Act 2.0. The merger took place on November 4, 2023. The financial statements include all adjustments that have resulted from the merger.

14) Subsequent events

The University has evaluated subsequent events through the date of the auditor's report, the date which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.
