### INDEPENDENT AUDITOR'S REPORT

#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of **Foxworth-Galbraith Lumber Company & Associated Companies 401(k) Plan** (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **Emphasis of Matter-Plan Merger**

As discussed in Note 5 to the financial statements, the stock of Foxworth-Galbraith Lumber Company & Associated Companies (Foxworth), the Plan's sponsor, was acquired in September of 2022 by US LBM Holdings, LLC (LBM). LBM Subsequently approved the merger of the Foxworth Plan into the LBM plan effective October 17, 2023. All plan assets and accumulated plan liabilities were transferred to the control of LBM Plan on November 16, 2023. Our opinion has not been modified with respect to this matter.

**Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.
