## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of  
Anser Advisory LLC 401(k) Profit Sharing Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Anser Advisory LLC 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of November 30, 2023 (in liquidation) and December 31, 2022 (ongoing), and the related statement of changes in net assets available for benefits for the period ended November 30, 2023 (in liquidation) and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules ("DOL") and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of November 30, 2023 (in liquidation) and December 31, 2022 (ongoing) and for the period ended November 30, 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Anser Advisory LLC 401(k) Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Emphasis of Matter – Basis of Accounting**

As discussed in Note 1 to the financial statements, Anser Advisory, LLC, the Plan Sponsor, adopted a resolution to terminate the Plan on July 31, 2023. As a result, the Plan has changed its basis of accounting from the ongoing basis (“going concern basis”), used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors’ Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan’s internal control. Accordingly, no such opinion is expressed.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**Note 1 - Termination of the Plan:**

On July 31, 2023, management of Anser Advisory, LLC (the “Company” or “Plan Sponsor”), adopted a resolution to terminate the Anser Advisory LLC 401(k) Profit Sharing Plan (the “Plan”) effective August 7, 2023. Final distributions were determined based on all participants being 100% vested and fully paid out as of November 30, 2023. As a result, the Plan has changed its basis of accounting from the ongoing basis (“going concern basis”) used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements.

**Note 2 - Description of Plan:**

The following description of the Plan is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

The Plan allows employees from Anser Advisory, LLC and participating employers, Anser Advisory Consulting, LLC, Anser Advisory Management, Ascent Pgm, LLC, Cambridge Construction Management, HR Gray & Associates, Pinck & Co., RW Block Consulting, Wallace & Associates Consulting, Inc., Government Services Group, Inc., IntegrateIT LLC, Lafata Contract Services, LLC, RLH Engineering, Inc., Gafcon Digital, Inc., and Markon LLC to participate in the Plan.

**Plan Administration** – The Plan is administered by the Plan Sponsor. The Plan’s assets are held by Reliance Trust Company, (the “Custodian”), who is responsible for the custody and management of the Plan’s assets.

**Plan Mergers** – During 2023, the Plan Sponsor approved the mergers of IntegrateIT LLC 401(k) Profit Sharing Plan, Lafata Contract Services, LLC 401(k) Profit Sharing Plan, and Markon, LLC Retirement Plan into this Plan. Net assets totaling \$51,422,251 were transferred into the Plan between January and February 2023.

**Transfers Out** – During August 2023, the Plan Sponsor approved the transfer out of the assets of the employees of Markon, LLC into the Markon, LLC 401(k) Plan, totaling \$37,577,117.

**General** – The Company established the Plan on January 1, 2012. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Employees, other than union employees covered by a collective bargaining agreement and employees who are nonresident aliens described in Internal Revenue Code (IRC) Section 410(b)(3)(C) and are not receiving any U.S. source income, are eligible to participate upon immediate employment with the attainment of 21 years of age and two months of service.

**Contributions** - Eligible participants may elect to contribute from 1% to 92% of their compensation to the Plan on a pre-tax or after-tax basis, subject to the IRC limitations for 401(k) plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The employer will make a safe harbor matching contribution equal to 100% of employee contributions, not to exceed 3% of compensation plus 50% of employee contributions, that exceeds 3% of compensation, not to exceed 5% of compensation. The Company may make discretionary employer profit sharing contributions to the Plan. The discretionary profit sharing will be allocated to participants at a ratio equal to the ratio of individual eligible compensation to the total eligible compensation paid to all eligible participants of the Plan. The participant must be an active employee of the Company on the last day of the Plan year to receive an allocation of the

discretionary profit sharing contribution. At November 30, 2023, the Company did not make any discretionary contributions.

**Automatic Enrollment** - All eligible employees are automatically enrolled in the Plan upon meeting eligibility requirements. Employees are deemed to have elected a Safe Harbor elective deferral contribution of 3% of their compensation in the absence of an affirmative election in the contrary. If an eligible employee was automatically enrolled in the Plan, and did not make changes to the percentage automatically enrolled in, the elective deferral percentage will be increased in the year following the anniversary date of the first year automatically enrolled and on January 1 of each of the following years up to a maximum of 6% of compensation.

**Vesting** - Participants are vested immediately in their contributions, if any, plus actual earnings thereon. Vesting in the employer matching and discretionary employer profit sharing contributions are based on an eligible participant working 1,000 hours during a Plan year.

As noted in Note 1, all participants became 100% vested in employer matching and discretionary employer profit sharing contributions as a result of the Plan termination, effective August 7, 2023.

**Participant Accounts** - Individual accounts are established for each plan participant. Each participant's account is credited with the participant's contribution and allocation of (a) the Company's contribution, if any, (b) net Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Payment of Benefits** - A participant's normal retirement date is age 65. Upon retirement or termination of service, a participant may elect to receive either a lump-sum amount, partial payments, installment payments, or annuity contracts equal to the value of the participant's vested interest in his or her account. In-service withdrawals are permitted only when the participant has reached the age of 59.5, as a hardship withdrawal (see Note 3) or if the distribution meets the requirements of a qualified reservist distribution. If death occurs prior to retirement, the participants account is paid to the designated beneficiary.

**Forfeitures** - Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures due to employer matching and discretionary employer profit sharing contributions will be used to reduce future administrative expenses or the Company's discretionary employer profit sharing or employer matching contributions under the Plan. At November 30, 2023 (in liquidation) and December 31, 2022 (ongoing), forfeited nonvested accounts were \$0 and \$1,075, respectively. Forfeitures totaling \$158,771 were used to reduce the employer match during 2023.

**Note 3 - Summary of Significant Accounting Policies:**

**Basis of Accounting** - The accompanying 2023 financial statements are presented on the liquidation basis of accounting which is in accordance with accounting principles generally accepted in the United States of America (see Note 1). The accompanying 2022 financial statements have been prepared on the (ongoing) accrual basis of accounting.

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions in net assets available for benefits during the reporting period. Actual results, as determined at a later date, could differ from those estimates.

**Investment Valuation and Income Recognition** – For 2022, investments are reported at fair value. For 2023, investments are reported on the liquidation basis which approximates fair value and were all transferred out or distributed during termination. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisor and Custodian. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of November 30, 2023 or December 31, 2022. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Administrative Expenses** - Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants, withdrawals and participant recordkeeping are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Payment of Benefits** - Benefits are recorded when paid.

***Hardship Withdrawals*** - The Plan provides for hardship withdrawals from participants' vested balances, not to exceed an amount required to meet an immediate need created by hardship, and then only to the extent that such immediate need cannot be satisfied by other sources reasonably available to the participant. Permissible circumstances for hardship withdrawals include medical expenses, purchase of a home, tuition payments, amounts necessary to prevent eviction from the participants' personal residence, and such other circumstances as the Plan Administrator may determine in accordance with Internal Revenue Service (IRS) rules and regulations.

***Risks and Uncertainties*** - Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the financial statements.

The Plan may have investments in funds with contractual cash flows, such as asset backed securities, collateralized mortgage obligations and commercial mortgage backed securities, including securities backed by sub-prime mortgage loans. The value, liquidity and related income of these securities are sensitive to changes in economic conditions, including real estate value, delinquencies or defaults, or both, and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates.

***Concentration of Investment Risk*** – The Plan's investments were fully liquidated in 2023; therefore, there are no investment concentrations at November 30, 2023. There were no investments greater than 10% of total investments at December 31, 2022.

***Subsequent Events*** - The Plan Administrator has reviewed and evaluated all events and transactions from November 30, 2023 through September 16, 2024, the date the financial statements were available to be issued. The effects of those events and transactions that provide additional pertinent information about conditions that existed at the Statements of Net Assets Available for Benefits date have been recognized in the accompanying financial statements.

**Note 4 – Certified Investment Information:**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, the Custodian, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments, as shown in the Statements of Net Assets Available for Benefits as of November 30, 2023 (in liquidation) and December 31, 2022 (ongoing).
- Investment income, as shown in the Statement of Changes in Net Assets Available for Benefits for the period ended November 30, 2023 (in liquidation).
- Investment information included in the Schedule H, Part IV, Line 4i - Schedule of Assets (Held at End of Period), as of November 30, 2023 (in liquidation), as shown on the ERISA-required supplemental schedule of assets (held at end of period).

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule of assets (held at end of period).

**Note 5 - Fair Value Measurements:**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified contractual term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 30, 2023 and December 31, 2022.

- *Mutual funds:* Valued at the quoted market prices in an active market which is held by the Plan at year end.
- *Common collective trust:* Valued at the net asset value (NAV) of units of a bank collective trust. The NAV, as provided by the Custodian, is used as a practical expedient to estimate the fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Transfers Between Levels**

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. For the period ended November 30, 2023 and the year ended December 31, 2022, there were no significant transfers in or out of levels 1, 2, or 3.

**Note 6 - Common Collective Trust:**

The Plan invests in investment contracts through its common collective trust (“CCT”). The CCT fair value is a relevant measurement attribute. The CCT held by the Plan is a stable value investment which has an objective to preserve capital and to provide a competitive level of income over time that is consistent with the preservation of capital. To achieve this objective the fund invests primarily in investment contracts. Prior to the Plan termination, redemptions were allowed for participants daily except for participant withdrawals which generally require one year written advance notice to the Custodian. There were no unfunded commitments at November 30, 2023 and December 31, 2022.

**Note 7 - Notes Receivable from Participants:**

Participants may obtain loans from the Plan at a minimum of \$1,000 and maximum of one-half of a participant’s account balance, or \$50,000 whichever is less. Loans bear an interest rate of prime plus 1% as reflected by local banks and are collateralized by a participant’s account balance. Loans are generally payable through payroll deductions within four and a half years. The maximum number of loans a participant can have outstanding is two. At November 30, 2023, notes receivable from participants were liquidated as a result of the Plan termination.

**Note 8 - Tax Status:**

The Plan was written on a non-standardized pre-approved document, which obtained its latest opinion letter on October 6, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

**Note 9 - Parties-in-Interest:**

Certain Plan investments are managed by the Custodian. Services provided by the Custodian include investment, recordkeeping, and administrative services to the Plan. The fees associated with these services qualify as party-in-interest. Fees paid by the Plan for investment management services amounted to \$217,060 for the period ended November 30, 2023.
