Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Inland Bancorp 401(k) Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of November 13, 2023 (in liquidation) and December 31, 2022 (ongoing), and the related statement of changes in net assets available for benefits for the period January 1, 2023 through November 13, 2023 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Inland Bancorp 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of November 13, 2023 and December 31, 2022, and for the period January 1, 2023 through November 13, 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the "Auditor's Responsibilities for the Audit of the Financial Statements" section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the “Auditor’s Responsibilities for the Audit of the Financial Statements” section of our report. We are required to be independent of Inland Bancorp 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting

As discussed in Note 1 to the financial statements, the Inland Bancorp 401(k) Committee of Inland Bancorp 401(k) Plan approved a plan of liquidation on May 26, 2023, and management determined liquidation is imminent. As a result, Inland Bancorp 401(k) Plan changed its basis of accounting from the on-going basis of accounting used to present 2022 financial statements to the liquidation basis of accounting used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Inland Bancorp 401(k) Plan’s ability to continue as a going concern within one year after the date that these financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan’s transactions that are presented and disclosed in the financial statements are in conformity with the plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor’s Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor’s report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1: Description of the Plan

The following brief description of the Inland Bancorp 401(k) Plan (Plan) is provided for general information purposes only. Participants should refer to the plan document for more complete information.

General

The Plan is a defined contribution plan covering substantially all employees of Inland Bancorp, Inc. (Company). The Plan was established February 1, 2009, and is subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as amended by subsequent legislation.

The Plan was formed as a result of the acquisition and merger of three companies, all of whom sponsored separate plans, as well as a participating employer of The Inland Group, LLC Savings Plan. Pursuant to terms of the Plan, participants who continued in the employ of the Company following the merger were provided the opportunity to transfer the distributions (including loans) from their respective plans into Inland Bancorp 401(k) Plan.

Plan Termination

In November 2022, the Company and Byline Bancorp, Inc. announced that they had entered into a definitive merger agreement pursuant to which the Company would be acquired by Byline Bancorp, Inc. As a result, the Company terminated the employment of certain personnel resulting in a partial plan termination. Employees terminated as a result of the merger became immediately vested in the balance of their plan accounts. On July 1, 2023, the Company completed its acquisition by Byline Bancorp, Inc.

On April 14, 2023, the plan administrator filed an amendment to officially implement a plan of termination related to the Plan (Plan Termination). On May 26, 2023, Plan participants were notified of the Plan Termination and were instructed to provide Empower Trust Company, LLC with a distribution election by July 27, 2023 (election date). Participants were notified that if they did not provide a distribution election by the election date, the balance of the participant's account would be rolled over to an individual retirement account established with Empower Trust Company, LLC on the behalf of the participant. All assets of the Plan were fully distributed to participants by November 13, 2023.

Eligibility

Eligibility to participate in the Plan is limited to employees, as defined, who have completed 60 days of service, are age 18 or over and are not part of a collective bargaining agreement.

Unless specifically declined, eligible employees are automatically enrolled in the Plan at an amount equal to 3% of eligible compensation. Such percentage is increased by 1% as of each subsequent anniversary of their plan entry date, not to exceed 10%.

Contributions and Transfers

Each year employees may contribute up to 100% of their compensation to the Plan, subject to limitations imposed by the Internal Revenue Code. Participants age 50 or older may contribute an additional amount as a “catch-up contribution.” Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company’s employer-matching contribution, if any, is determined by the Board of Directors of the Company prior to the beginning of a plan year. The Company may also, at its discretion, make a pay-based profit sharing contribution to the Plan.

During 2023 and 2022, the Company contributed 50% of the first 6% of eligible compensation that a participant contributed to the Plan.

During 2023, the Plan received \$19,541 as a transfer of participant accounts from an affiliated plan. The amount is presented as a transfer to the Plan on the statement of changes in net assets available for benefits.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and (b) plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant earnings (losses) or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested balance.

Vesting

Participants are immediately vested in their voluntary contributions and any qualified employer-matching contributions. Vesting in the remainder of their account is based upon years of service. A participant is 100% vested after five years of service prior to 2023, once the determination to terminate the Plan was made all participants were immediately vested in all contributions.

Payment of Benefits

Upon termination of service due to death, disability or retirement, the entire vested balance in a participant’s account may be distributed in a lump-sum payment, rolled over into another qualified plan or, if the amount is in excess of \$5,000, in substantially equal annual installments as selected by the participant or beneficiary. Participants may also withdraw elective deferrals or rollover contributions in the event of hardship due to an immediate and heavy financial need, as defined by the Internal Revenue Service.

If a participant terminates prior to death, disability or retirement with a vested account balance less than \$5,000, the balance of the account will be distributed as soon as administratively feasible.

Notes Receivable From Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. Interest rates at December 31, 2022, ranged from 4.25% to 8.00%, which is commensurate with local prevailing rates for this type of loan as determined by the plan administrator. Principal and interest are paid ratably through monthly payroll deductions and are payable within five years, except for loans used to acquire a principal residence, which are payable within 15 years.

Forfeited Accounts

All forfeitures will be applied to reduce employer discretionary matching contributions to the Plan or to pay the Plan's ordinary and necessary administrative expenses during the plan year. Any remaining forfeitures are to be allocated to participants in the manner described in the Plan. A forfeiture balance of \$69,118 was available to offset future plan expenses or employer contributions at December 31, 2022.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for the fully benefit-responsive investment contract which is reported at contract value. The Plan's investments in shares of registered investment companies are valued at quoted market prices of shares held by the Plan at year-end. The Plan's investment in the guaranteed investment contract is fully benefit-responsive and is valued at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if

they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of administering and operating the Plan are paid by the Company. The Plan pays certain administrative expenses and transaction costs related to participant loans and investment fees. Investment fees are included in net appreciation (depreciation) in fair value of investments.

Revenue Sharing

The Plan recognizes the income from revenue-sharing agreements when received. During 2023, the Plan received \$7,330 of revenue sharing. During 2022, \$7,330 was used to pay expenses for professional and investment management and advisory services.

Notes Receivable From Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions.

Note 3: Fair Value of Plan Assets and Liabilities

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

Level 1 Quoted prices in active markets for identical assets or liabilities

Level 2 Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities

Level 3 Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. There have been no changes in the methodologies used at November 13, 2023 and December 31, 2022.

The fair value of registered investment companies is determined by obtaining quoted market prices on nationally recognized securities exchanges (Level 1 inputs).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4: Certifications of Plan Trustees

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the *Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA*. Accordingly, Empower Annuity Insurance Company of America and Empower Trust Company, LLC (previously Great-West Life & Annuity Insurance Company and Great-West Trust Company, LLC), qualified institutions, have

certified the following information included in the accompanying financial statements is complete and accurate:

- Investments, notes receivable from participants and accrued interest receivable as shown in the statements of net assets available for benefits as of November 13, 2023 and December 31, 2022
- Investment income (loss) components, and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the period from January 1, 2023 through November 13, 2023

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related information included in the financial statements.

Note 5: Guaranteed Investment Contract

Effective March 1, 2020, the Plan entered into a fully benefit-responsive, group annuity contract with New York Life Insurance Company. Empower Annuity Insurance Company of America (previously Great-West Life & Annuity Insurance Company) maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal at a specified interest rate that is guaranteed to the Plan.

The guaranteed investment contract is fully benefit responsive; contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Empower Annuity Insurance Company of America (previously Great-West Life & Annuity Insurance Company), represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Investments may be redeemed daily without prior notice.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit ability of the Plan to transact at contract value with Empower Annuity Insurance Company of America (previously Great-West Life & Annuity Insurance Company). Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption

from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such value event which would limit the Plan's ability to transact at contract value with plan participants is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Note 6: Party-in-Interest Transactions

The Plan's investments are managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC (previously Great-West Life & Annuity Insurance Company and Great-West Trust Company, LLC); therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for professional services rendered by parties-in-interest during 2023 were \$61,791 before the effect of revenue-sharing amounts of \$7,330. The Company provides certain administrative services at no cost to the Plan.

Note 7: Tax Status

The Plan operated under a non-standardized adoption agreement in connection with a prototype 401(k) profit-sharing plan and trust sponsored by Great-West Trust Company LLC. This prototype plan document was filed with the appropriate agency and the prototype sponsor has obtained an opinion letter dated June 30, 2020, from the Internal Revenue Service stating that the prototype constitutes a qualified plan under Section 401 of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes the Plan was designed and was being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan was qualified and the related trust is tax exempt as of the financial statement date.

Note 8: Subsequent Events

Subsequent events have been evaluated through September 11, 2024, which is the date the financial statements were available to be issued.
