Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Ramsey Winch Company Employees' Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits in liquidation as of November 30, 2023 and December 31, 2022, and the related statements of changes in net assets available for benefits in liquidation for the period and year then ended, respectively, and the statement of accumulated plan benefits in liquidation as of December 31, 2022, and the related statement of changes in accumulated plan benefits in liquidation for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the period and year ended November 30, 2023 and December 31, 2022, respectively, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As further discussed in Note 1 and Note 10 to the financial statements, the Board of Directors of the Plan approved a plan of liquidation on December 12, 2022, and management determined liquidation is imminent. As a result, the 2023 and 2022 financial statements are presented using the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Note 1 - Description of Plan

The following brief description of Ramsey Winch Company Employees' Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a noncontributory defined benefit plan covering substantially all employees of Ramsey Winch Company and Auto Crane Company (collectively, the Company) who had completed one year of service and attained age twenty-one prior to October 1, 2006. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan was frozen on October 1, 2006. Thus, no employee hired after September 30, 2006, were eligible to participate in the Plan, and no additional benefits have been accrued after that date. However, a participant in the Plan continued to earn vesting service in accordance with the provisions of the Plan after such date.

Plan Termination

On December 12, 2022, the Company's Board of Directors authorized a plan to terminate the Plan in 2023. Participants became immediately vested in their pension benefits. All participants were provided an option to receive a lump sum payment of their pension benefits or to have an annuity purchased by the Plan in their name equivalent to their pension benefits. The lump sum payments were made, and annuities purchased during the period ended November 30, 2023, effectively terminating the Plan.

Pension Benefits

Participants were entitled to annual pension benefits beginning at normal retirement age (65) equal to 1.56% of the participant's average annual compensation up to \$40,000 and 2.00% of the participant's average annual compensation in excess of \$40,000, limited to a maximum of 35 years, until the Plan was frozen. The Plan permitted early retirement at ages 55-64, provided they had at least 10 years of service with the Company. If employees terminated before rendering five years of service, they forfeited the right to receive a portion of their accumulated plan benefits attributable to the Company's contributions. The normal form of benefit payment was a life annuity with 60 certain payments.

Participants with a vested value of accumulated plan benefits in excess of \$1,000 could elect lifetime or various qualified joint and survivor annuities payable on a monthly, or bi-monthly, basis. Participants with a vested benefit between \$1,000 and \$5,000 could also elect to receive the vested value of their accumulated plan benefits in the form of one lump-sum payment in cash. Participants with an accumulated plan benefit less than \$1,000 were automatically paid out in the form of a single lump-sum payment in cash.

Death Benefits

In the event of a death of a participant prior to retirement, the spouse of the participant received a 50% survivor annuity, as defined in the Plan. The surviving spouse annuity was equal to 50% of the participant's monthly benefit. Payments began within six months after the participant's death.

Note 2 - Significant Accounting Policies

Basis of Accounting

The financial statements as of and for the period ended, November 30, 2023 and as of and for the year ended, December 31, 2022, of the Plan are prepared on the liquidation basis of accounting.

Use of Estimates

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, disclosures of contingent assets and liabilities, and the actuarial present value of accumulated plan benefits at the date of the financial statements. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by its investment advisers, and custodians. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings (losses) reported in the statements of changes in net assets available for benefits may differ from the classification of earnings (losses) on Form 5500 due to different reporting requirements on Form 5500.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Expenses

The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation (depreciation) of fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

Subsequent Events

The Company has evaluated subsequent events through September 16, 2024, the date which the financial statements were available to be issued.

Note 3 - Actuarial Present Value of Accumulated Plan Benefits

Accumulated plan benefits are those future periodic payments, including lump sum distributions that are attributable under the Plan's provisions to the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries. Benefits under the Plan are accumulated based on employees' compensation during each year of credited service prior to the Plan being frozen. The accumulated plan benefits for active employees will equal the accumulation, with interest, of the annual benefit accruals as of the benefit information date. Benefits payable under all circumstances (retirement, death, and termination of employment) are included to the extent they are deemed attributable to employee service rendered to September 30, 2006.

The actuarial present value of accumulated plan benefits is determined by an independent actuary and is that amount which results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, withdrawal, or retirement) between the valuation date and the expected date of payment.

The following is a summary of the more significant actuarial assumptions underlying the actuarial computations:

As of January 1, 2023

Interest Rate 5.03% per annum compounded annually to reflect liabilities under Plan termination assumptions

Mortality rate - Scale Mortality Table for 2023 - table for annuitants and non-annuitants

Retirement age - age 65 or current age, if older

Spouse's age - in valuing pre-retirement death benefits, spouses are assumed to be 3 years older if male

70% of employees are assumed to be married

Target normal cost was loaded by \$220,000 for expenses

The foregoing actuarial assumptions were made for the Plan year beginning January 1, 2023. The Plan was terminated and all assets were distributed out of the Plan during 2023.

The computations of the actuarial present value of accumulated Plan benefits were made as of January 1, 2023. Had the valuation been performed as of December 31 there would be no material differences.

Note 4 - Funding Policy

The Plan's funding policy is for the Company to make annual contributions to the Plan in amounts that are estimated amounts necessary to fund the benefits provided, as determined by the Plan actuary, in an amount that will meet or exceed the annual ERISA minimum funding requirement. During 2023 and 2022, no contributions were made. The Company's contribution for 2023 and 2022 met the minimum funding requirements established by ERISA.

Note 5 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 30, 2023 and December 31, 2022.

U.S. government securities – Valued using pricing models maximizing the use of observable inputs for similar securities.

Mutual funds (including the money market mutual fund) – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

There were no assets at fair value as of November 30, 2023.

Note 6 - Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplementary information, including investments held at November 30, 2023 and December 31, 2022, and net appreciation (depreciation) in fair value of investments, interest and dividends for the period and year then ended, respectively, was obtained by management and agreed to or derived from information certified as complete and accurate by BOKF, N.A. (the trustee of the plan).

Note 7 - Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated March 12, 2004, that the Plan and related trust were designed in accordance with the applicable regulations of the Internal Revenue Code (IRC). Subsequent to the issuance of this determination letter, the Plan was amended. However, the Company and Plan management believes that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC, and the Plan and related trust continue to be tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 - Related Party and Party-in-Interest Transactions

As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in- interest transactions under ERISA.

Note 9 - Risks and Uncertainties

The Plan invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Plan contributions are made, and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Note 10 - Plan Termination

Upon final termination of the Plan in 2023, the net assets of the Plan were allocated as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

1. Annuity benefit that former employees or their beneficiaries have been receiving for at least three years, or that employees eligible to retire for that three-year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority amount is limited to the lowest benefit that was payable (or would have been payable) during those three years. The amount is further limited to the lowest benefit that would be payable under the Plan provisions in effect at any time during the five years receding the Plan termination.
2. Other vested benefits insured by the Pension Benefit Guaranty Corporation (the PBGC) (a U.S. government agency) up to the applicable limitations.
3. All other vested benefits (that is, vested benefits not insured by the PBGC).
4. All non-vested benefits.

Certain benefits under the Plan are insured by the PBGC when the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivors' pensions. However, the PBGC does not guarantee all types of benefits under the Plan and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect at the date of the Plan termination.

The Plan had sufficient assets to fully fund all pension benefit obligations to participants in the Plan during the period ended November 30, 2023. Lump sum payments made to participants totaled \$12,058,342 and annuities purchased by an insurance carrier totaled \$6,063,327. No Plan assets or pension benefit obligations remained at November 30, 2023.

Plan Freeze

All benefit accruals under the Plan were frozen as of September 30, 2006. After this date, no new participants are allowed into the Plan.

Benefit Service

Benefit Service is the period of employment used in determining the amount of pension benefits. For Plan Years prior to 2006, a Year of Benefit Service is earned for each year of employment for the Employer in which a Plan participant receives credit for at least 1,000 Hours of Service. For the Freeze Year (a 9 month period beginning on January 1, 2006 and ending on September 30, 2006), a full Year of Benefit Service is earned if a participant completes 1,000 Hours of Service during the Freeze Year. If a participant completes less than 1,000 Hours of Service during the Freeze Year, one month of Benefit Service is earned for each month during the Freeze Year in which a participant receives credit for at least 83 Hours of Service.

Vesting Service

Vesting Service is the period of employment used in determining eligibility for benefits. Vesting Service is based on an elapsed methodology. To be 100% vested, an employee must have five years of Vesting Service.

Normal Retirement

Normal Retirement is the first day of the month coincident with or next following attainment of age 65 with 5 Years of Service.

Early Retirement

Early Retirement is the attainment of age 55 and the completion of 10 Years of Vesting Service and before Normal Retirement.

Normal Retirement Benefit

The annual benefit is equal to the greater of (a) or (b):

- (a) The sum of
 - (i) The benefit as of December 31, 1988, as determined under the Prior Plan in effect at that time; plus
 - (ii) 1.56% of Average Compensation up to \$40,000 times Years of Benefit Service plus 2.00% of Average Compensation in excess of \$40,000 times Years of Benefit Service (up to a maximum of 35 years).
- (b) \$60.00 multiplied by the number of years and months of Service.

Early Retirement Benefit

The benefit is equal to the Normal Retirement Benefit reduced by 5/12 of 1% for each month that commencement precedes the participant's Normal Retirement Date.

Spouse's Pre-Retirement Death Benefit

Eligibility: Participant's death occurs after he is vested under the Plan.

Benefit: 50% of the Joint and Survivor annuity at Early Retirement, payable at the participant's earliest Retirement age had he (she) not died.

Severance Benefit

Eligibility: A participant is 100% vested after 5 years of Vesting Service or Normal Retirement Date if earlier.

Normal Form of Payment

The Normal Form of Payment is a life annuity with five years guaranteed for single participants, and for married participants is the 50% Joint and Survivor Annuity.

Optional Methods of Settlement

All Optional Methods of Settlement are actuarially equivalent to the Normal Form of Payment. If a married participant does not elect the Normal Form of Payment or does not elect one of the Optional Methods of Settlement described below, then the participant's Retirement Benefit shall automatically be paid under option (1) below. The options are:

- (1) A reduced benefit to be paid during the participant's lifetime with one-half of the reduced benefit to be continued to his spouse for her lifetime after his death.
- (2) A reduced benefit to be paid during the participant's lifetime with $\frac{3}{4}$ of the reduced benefit to be continued to his spouse for her lifetime after his death.
- (3) A reduced benefit to be paid during the participant's lifetime with equal payments of the reduced benefit to be continued to his spouse for her lifetime after his death.
- (4) A reduced benefit to be paid for a period of ten years certain and life thereafter.

All Optional Methods of Settlement are actuarially equivalent to the Normal Form of Payment on a unisex basis.

Amendment or Termination of Plan

The Plan Sponsor amended the Plan to provide for a plan termination as of December 31, 2022. The Plan assets will be distributed among the Plan participants based upon a priority allocation procedure, and the Employer shall be liable for any unfunded vested benefits to the extent required by law.
