INDEPENDENT AUDITORS' REPORT

To the Participants and Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Phelan Hallinan 401(k) Savings/Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits in liquidation as of November 30, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits in liquidation for the period ended November 30, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Phelan Hallinan 401(k) Savings/Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of November 30, 2023 and December 31, 2022, and for the period ended November 30, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Phelan Hallinan 401(k) Savings/Profit Sharing Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As described in Note 1 to the financial statements, the governing body of the Phelan Hallinan 401(k) Savings/Profit Sharing Plan made a decision to terminate the Plan effective November 6, 2020. As a result, the Plan used the liquidation basis of accounting in presenting the financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. NOTE 1 - Description of the Plan

The following description of the Phelan Hallinan 401(k) Savings/Profit Sharing Plan (the "Plan"), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan was a defined contribution and profit sharing plan covering substantially all employees of Phelan Hallinan Diamond & Jones LLP F/K/A Phelan Hallinan, LLP and affiliated companies (the "Company"), as described in the Plan agreement, who met the eligibility requirements of the Plan. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The following employers had also adopted the Phelan Hallinan 401(k) Savings/Profit Sharing Plan as participating employers: Easy Closings LLC F/K/A LTS Acquisition Co., LLC, Phelan Hallinan Diamond & Jones PC F/K/A Phelan Hallinan & Diamond, PC, Phelan Hallinan Diamond & Jones, PLLC F/K/A Phelan Hallinan, PLC, Full Spectrum Holdings, LLC and FSS Acquisition Co., LLC. The Administrative Committee was responsible for the oversight of the Plan including the appropriateness of the Plan's investment offerings and monitoring of the investment performance.

Plan Termination and Liquidation Basis of Accounting - The governing body of the Plan made a decision to terminate the Plan effective November 6, 2020. Plan management considered liquidation to be imminent upon the decision to terminate the Plan. Participants were not permitted to make contributions after November 6, 2020. As of November 30, 2023, all assets have been distributed to the participants.

Contributions - Prior to the termination of the Plan, there were two types of salary deferrals: Pre-Tax 401(k) deferrals and Roth 401(k) deferrals. Each year, participants could contribute up to 100 percent of their pretax annual compensation, as defined in the Plan. Participants could elect to make Roth 401(k) deferrals, these deferrals were subject to federal income taxes in the year of deferral. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants could direct the investments of their contributions into various investment options offered by the Plan. Participants could change their investment options at any time. The Company could elect to make discretionary profit sharing contributions to the Plan. Profit sharing contributions were not limited to the current and accumulated profits of the business. To be eligible for profit sharing contributions, a participant must have been credited with at least 501 hours or one year of service in the Plan year and be an employee on the last day of the Plan year. Profit sharing contributions were allocated to eligible participants on a pro rata basis of individual compensation to the total compensation of all eligible participants. The profit sharing contributions are participant directed as above.

NOTE 1 - Description of the Plan (continued)

Participant Accounts - Prior to the termination of the Plan, each participant's account was credited with the participant's contributions, as well as allocations of the Company's discretionary profit sharing contributions, Plan earnings, and forfeitures, if applicable. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants were vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts was based on years of continuous service. A participant was 100 percent vested after six (6) years of credited service. A participant shall become 100 percent vested upon death, disability or normal retirement. Upon termination of the Plan on November 6, 2020, all participants were 100 percent vested.

Notes Receivable from Participants - Prior to the termination of the Plan, participants could borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The notes were secured by the balance in the participant's account and bore interest at the Prime Rate plus 1 percent, which was commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest were paid ratably through payroll deductions.

Payment of Benefits - Prior to the termination of the Plan, on termination of service due to death, disability or retirement, or upon termination of employment, a participant or their beneficiary (ies) would receive a lump sum payment for participant vested account balances under \$5,000 and if the participant's vested account balance exceeds \$5,000, the participant or their beneficiary (ies) may elect to receive a lump sum payment or installment payments equal to the value of the participant's vested account balance.

Forfeited Accounts - Prior to the termination of the Plan, forfeitures could be used to pay Plan expenses or to reduce amounts otherwise required to be contributed to the Plan. In some cases; however, forfeitures will be reallocated to participants as though they were additional Employer contributions. At November 30, 2023 and December 31, 2022, there was no forfeited non-vested accounts.

NOTE 2 - Summary of Significant Accounting Policies

Basis of Accounting - As a result of the termination of the Plan, the Plan's financial statements have been prepared on the liquidation basis of accounting.

NOTE 2 - Summary of Significant Accounting Policies (continued)

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition - As a result of the termination of the Plan, the Plan's investments are stated at liquidation value, which approximates fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determined the Plan's valuation policies utilizing information provided by the investment advisers and trustee prior to the termination of the Plan. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the liquidation basis. Dividends were recorded on the ex-dividend date. Net appreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Prior to the termination of the Plan, notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan is reduced and a benefit payment is recorded. No allowance for credit losses has been recorded as of November 30, 2023 or December 31, 2022.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Prior to the termination of the Plan, certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and participant distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events - The Plan has evaluated subsequent events through September 16, 2024, the date the financial statements were available to be issued.

NOTE 3 - Certification of Investment Information

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule and notes receivable from participants, including investments and notes receivable from participants held at November 30, 2023 and December 31, 2022, and net appreciation in fair value of investments, interest and dividends for the period ended November 30, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Matrix Trust Company, the trustee of the Plan, as of November 30, 2023 and for the period from April 25, 2023 to November 30, 2023 and Charles Schwab Trust Bank, the trustee of the Plan, as of December 31, 2022 and for the period from January 1, 2023 to April 24, 2023.

NOTE 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include <ul style="list-style-type: none">· Quoted prices for similar assets or liabilities in active markets;· Quoted prices for identical or similar assets or liabilities in inactive markets;· Inputs, other than quoted prices, that are observable for the asset or liability;· Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 30, 2023 and December 31, 2022.

Mutual Funds and Money Market: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds and money market are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds and money market held by the Plan are deemed to be actively traded.

The Plan's assets at fair value were \$0 as of November 30, 2023.

NOTE 5 - Related Party Transactions and Party in Interest Transactions

Plan investments were shares of mutual funds and a money market fund managed by Matrix Trust Company ("Matrix"), the trustee of the Plan. Matrix is the trustee as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. Fees paid by the Plan for administrative expenses were \$33,088 for the period ended November 30, 2023, which were not covered by revenue sharing. The Plan Sponsor pays directly any other fees related to the Plan's operations. Notes receivable from participants qualify as party in interest transactions and are exempt from prohibited transaction rules.

NOTE 6 - Tax Status

The underlying non-standardized pre-approved profit sharing plan has received an opinion letter dated June 30, 2020 from the Internal Revenue Service (IRS) stating that the form of the Plan is acceptable for use by employers for the benefit of their employees under Internal Revenue Code (IRC) Section 401. The Plan Sponsor adopted this Plan and may rely on the current qualifications of the non-standardized pre-approved profit sharing plan opinion letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualifications. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan was qualified, and the related trust was tax-exempt.

NOTE 6 - Tax Status (continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Although terminated, the Plan may still be subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities were exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits in liquidation. The current economic environment has increased the degree of uncertainty.
