INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Menufy 401(k) Plan ("Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 (in liquidation) and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the year then ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As further described in Note 1 to the financial statements, the Board of Directors of Menufly.Com, LLC approved a resolution to freeze the Plan effective January 1, 2023. At that time, management determined liquidation was imminent. As a result, the Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2022 financial statements to the liquidation basis of accounting used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1 - Description of Plan

The following description of Menufy 401(k) Plan ("Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

Menufy.com, LLC ("Company") established the Plan to provide employees with the opportunity to save for retirement. The Plan is a qualified retirement plan that enables the Company and employee to contribute to an investment account for the benefit of employees on a tax-advantaged basis. The Plan was originally effective on January 1, 2019, and most recently amended and restated effective January 1, 2022, to conform to new tax laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

A meeting of the Board of Directors of the Company was held to freeze the Plan effective January 1, 2023. The Board of Directors resolved to freeze the Plan and merge the Plan into the HungerRush 401(k) Plan. The Company determined liquidation was imminent. As a result, the Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2022 financial statements to the liquidation basis of accounting used in presenting the 2023 financial statements.

In March 2023, Plan investments of \$1,497,352 were liquidated and transferred to the HungerRush 401(k) Plan. The Plan also transferred \$18,555 in notes receivable from participants to the HungerRush 401(k) Plan.

In March 2024, the Plan was fully liquidated as it transferred the remaining \$208 in assets to the HungerRush 401(k) Plan.

Eligibility

Employees were eligible to participate in the Plan once they had been employed for at least 3 months and reached age 18. An employee became a participant effective as of the next full pay month period that came directly after the date the eligibility requirements were met. Excluded employees included independent contractors, union employees, leased employees, and certain nonresident aliens.

Contributions

Participants could choose to contribute a percentage of their pay to the Plan instead of receiving that amount in cash. Participant contributions could have been pre-tax traditional 401(k) contributions or post-tax Roth 401(k) contributions. Total participant contributions could not exceed a dollar limit set by the Internal Revenue Service ("IRS"). If a participant was, or would turn, 50 years of age or older during the year, the participant could also make an additional catch-up contribution. The Plan also included an automatic enrollment feature. A participant would automatically be enrolled at the Plan's default contribution rate of 1% after entering the Plan unless they selected an alternative contribution rate or opted out. Participants could have changed their contribution rate or opted out of participation in the Plan at any time.

The Company made a basic safe harbor matching contribution equal to 100% of a participant's contributions which did not exceed 3% of their compensation, plus 50% of their contributions which exceed 3% but did not exceed 5% of compensation.

Employees could roll eligible funds from other retirement plans into the Plan once they had become a participant in the Plan.

Participant accounts

Each participant's account was credited with the participant's contributions, employer contributions, rollovers, and Plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants controlled how their money is invested in the Plan by choosing from several diverse investment securities.

Vesting

Participants were 100% immediately vested in all participant, employer, and rollover contributions and actual earnings thereon.

Notes receivable from participants

Loans were available to participants on a reasonably equivalent basis. The minimum loan amount that a participant could request was \$1,000. The maximum loan amount a participant could request was 50% of their vested balance, not to exceed \$50,000, less the highest outstanding balance of loans in the past 12 months. Loans were required to be repaid within 5 years, unless used for the purchase of a primary residence. A participant's vested account balance was used as security for the loan. Loans bore a commercially reasonable interest rate. No more than one outstanding loan from the Plan at a time was allowed.

Payment of benefits

The Plan was intended to provide employees with retirement benefits. However, a participant could receive a full or partial distribution from the vested portion of their account before retirement. Reasons for which a participant may receive a distribution of the vested portion of some or all of their accounts included: attainment of age 59.5, hardship withdrawal, termination of employment, or required minimum distribution.

The following distribution options were available to participants after termination of employment: stay in the Plan, roll the vested balance to an IRA, roll the vested balance to another qualified retirement plan, or take a distribution as a check payable to the participant.

Note 2 - Summary of Accounting PoliciesUse of estimates

Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent events

The Plan has evaluated subsequent events through August 20, 2024, the date the financial statements were available to be issued.

Note 3 - Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 31, 2022, and net appreciation in fair value of investments and dividends for the year ended December 31, 2023, was obtained by the Company and agreed to or derived from information certified as complete and accurate by Benefit Trust Company.

The following description of Menufy 401(k) Plan ("Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

Menufy.com, LLC ("Company") established the Plan to provide employees with the opportunity to save for retirement. The Plan is a qualified retirement plan that enables the Company and employee to contribute to an investment account for the benefit of employees on a tax-advantaged basis. The Plan was originally effective on January 1, 2019, and most recently amended and restated effective January 1, 2022, to conform to new tax laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

In March 2024, the Plan was fully liquidated as it transferred the remaining \$208 in assets to the HungerRush 401(k) Plan.
