NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF PLAN:

The following description of the Arkay Packaging Corporation (“Corporation”) 401(k) Retirement Plan (“Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General

The Plan is a defined contribution plan covering all employees who have worked for the Corporation for at least ninety days, excluding leased employees and nonresident aliens. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Corporation’s management team oversees governance of the Plan by working with outside advisors in monitoring the Plan’s investment offerings and compliance with Plan provisions.

Investment Options

The Plan currently offers a selection of pooled separate accounts sponsored by John Hancock.

Contributions

Participant Contributions

The Plan has an auto-enrollment feature whereby a participant is automatically enrolled in the Plan to make pre-tax contributions at 3% of eligible compensation unless the participant affirmatively opts out. In addition, the Plan has an automatic deferral escalator feature whereby participants who were automatically enrolled will have their deferral rates increased each year by 1% until their deferral rate reaches 10%, unless the participant elects out of this treatment. Participants can elect deferral modification on the first day of each month.

Plan participants can elect to contribute up to 100% of their eligible compensation, not to exceed the allowable amount under Section 402(g) of the Internal Revenue Code (“IRC”). Contributions are based upon total eligible compensation, which includes all W-2 compensation paid during the taxable year, excluding production bonuses and any fringe benefits. Contributions made by highly compensated employees may be restricted by dollar limits set annually by the Internal Revenue Service (“IRS”). Participant’s contributions are made through automatic payroll deductions every pay period. These contributions are not federally taxable to the participant until they are withdrawn from the Plan.

The Plan also has a Roth feature. Contributions are made from after-tax eligible compensation. Participants will not be taxed on future distributions of their contributions and related earnings if certain requirements are met.

NOTES TO FINANCIAL STATEMENTS – (Continued)

1. DESCRIPTION OF PLAN - (Continued):

Employer Contributions

The Corporation may also make annual discretionary matching and/or profit-sharing contributions in an amount to be determined at Plan year end by the Corporation's Board of Directors. These discretionary contributions will be allocated following the end of the Plan year to all eligible participants.

Rollover Contributions

Participants who were members of a former employer's qualified plan may elect to make rollover contributions from that plan to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions, an allocation of the employer's contributions, and Plan earnings and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant's contributions for that Plan year or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary participant and rollover contributions, plus actual earnings thereon. Vesting in any discretionary matching and/or profit-sharing contributions is based on years of continuous service. The participant's vested interest shall be determined in accordance with the following vesting schedule:

Upon completion of less than two (2) Plan years	0%
Upon completion of two (2) Plan years	40%
Upon completion of three (3) Plan years	60%
Upon completion of four (4) Plan years	90%
Upon completion of five (5) Plan years	100%

If the Corporation were ever to terminate the Plan, all participants become fully vested in their account balances.

Payment of Benefits

The Plan is designed to provide participants with benefits at the time of retirement. However, if employment with the Corporation is terminated because of death, disability, or retirement then the balance of a participant's vested Plan accounts becomes distributable to them. Upon proper notification of the Plan Administrator, the account balance will be distributed to the participant in the form of a lump-sum cash payment or installments over a period not extending beyond: a) the life expectancy of the participant; b) the joint life and last survivor expectancy of the participant's designated beneficiary or; c) the life expectancy of the participant's designated beneficiary as determined at the time of distribution. The participant may also request a rollover distribution, as soon as practicable after separation from service.

1. DESCRIPTION OF PLAN - (Continued):

Payment of Benefits – (Continued)

The normal retirement age for the Plan is the later of (1) age 65 or (2) the 5th anniversary of the date the employee commenced participation in the Plan but not later than attainment of age 70. Participants are not required to terminate employment with the Corporation when they reach retirement age under the Plan.

If a participant dies before any or all of their account balance has been distributed to them, then their beneficiary will be entitled to receive all undistributed benefits. Participants will automatically become 100% vested in their account balance upon their death.

Prior to terminating service or attaining normal retirement age, a participant under certain hardship conditions, may elect to receive a distribution of all or any portion of their prior cumulative participant contributions. Any such distribution may be subject to a 10% early distribution penalty.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, with a maximum of one loan outstanding per participant. Loan transactions are treated as a transfer to (from) an investment fund, from (to) the participants loan fund. Loans are amortized over a reasonable period not to exceed 5 years. The loans are secured by the balance in the participant's account and bear interest at Prime rate plus 1% as of the loan origination date.

Forfeited Accounts

Non-vested benefits of participants who cease to be employees are used to reduce employer contributions. During the year ending December 31, 2023, \$0 of forfeitures were used to pay employer contributions. As of December 31, 2023 and 2022, forfeited non-vested accounts totaling \$6,277 and \$2,965, respectfully, were available to pay employer contributions.

2. SUMMARY OF ACCOUNTING POLICIES:

Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with U.S. generally accepted accounting principles and the Department of Labor Rules and Regulations and Disclosure under ERISA.

Valuation of Investments and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price).

Purchases and sales of securities are recorded on a trade-date basis. Net (depreciation) appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Participant Notes Receivable

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, and the participant has incurred a distributable event, the participant loan balance is reduced and a benefit payment is recorded.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Plan's provisions are recorded as a liability with a corresponding reduction to contributions.

Payment of Benefits

Benefits are recorded when paid.

Income Taxes

The income tax returns of the Plan for 2020, 2021, 2022, and 2023 are subject to examination by the taxing authorities, generally for three years after they were filed.

2. SUMMARY OF ACCOUNTING POLICIES - (Continued):

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Corporation and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Administrative expenses of the Plan are allocated or directly charged to participant accounts.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

3. PLAN TERMINATION:

While the Plan is intended to be permanent, it may be terminated at any time at the discretion of the Board of Directors of the Corporation and subject to the provisions of ERISA. If the Plan is terminated, no further contributions shall be made and participants shall become fully vested in their Plan accounts.

4. FAIR VALUE MEASUREMENTS:

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs are not available. There are no Plan assets requiring the use of Level 3 inputs for the periods presented.

Investments in pooled separate accounts are valued at the net asset value ("NAV") of shares held by the Plan at year end as reported by the fund managers.

6. INCOME TAX STATUS:

The Plan has adopted a volume submitter plan document provided by Prime Pensions, Inc.. The IRS has determined and informed Prime Pensions Inc. by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate income tax positions taken by the Plan and recognize an income tax liability for any uncertain income tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

7. RELATED PARTY TRANSACTIONS:

Certain administrative functions are performed by officers or employees of the Corporation. No such officer or employee receives compensation from the Plan.

Plan assets were invested in funds managed by John Hancock. John Hancock served as the Trustee as defined by the Plan and; therefore, these transactions qualify as parties-in-interest transactions.

The Plan paid \$57,099 to John Hancock for contract administration fees for the year ended December 31, 2023.

These parties-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

8. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. SUBSEQUENT EVENTS:

The Plan's management has evaluated subsequent events through August 26, 2024, the date the financial statements were available to be issued.
