Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Pediatric Medical Services of Florida, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for plan benefits as of April 29, 2024 (in liquidation), December 31, 2023 (in liquidation) and December 31, 2022, and the related statements of changes in net assets available for plan benefits for the period from January 1, 2024 through April 29, 2024 (in liquidation) and the years ended December 31, 2023 (in liquidation) and December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of April 29, 2024, December 31, 2023 and 2022, and for the period from January 1, 2024 through April 29, 2024 and the years ended December 31, 2023 and December 31, 2022, respectively, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As discussed in Note 2(a) to the financial statements, the Board of Directors of Pediatric Medical Services of Florida, Inc. approved a plan of liquidation on October 30, 2023 and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2022 financial statements to the liquidation basis of accounting used in presenting the 2024 and 2023 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. generally accepted accounting principles, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. (1) Description of Plan

The following description of Pediatric Medical Services of Florida, Inc. (PMSI) 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan document for more complete information.

(a) General

The Plan is a defined contribution 401(k) plan, which covers the employees of Children's Health Alliance (CHA), a wholly owned subsidiary of PMSI. PMSI is a wholly owned subsidiary of The Nemours Foundation. CHA is also known as Nemours Children's Primary Care. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On October 30, 2023, the PMSI Board of Directors adopted a resolution to terminate the Plan as of December 31, 2023 and to distribute the Plan assets as soon as administratively possible. The Plan assets were distributed to participants by April 29, 2024.

(b) Plan Administration

The Plan is administered by The Nemours Foundation Retirement Plans Administrative Committee (the Plan administrator) under the direction of the PMSI Board of Directors. The assets of the Plan were held by State Street Bank and Trust Company (State Street), as Trustee and administered by Transamerica Retirement Services (TRS), as the record keeper.

(c) Eligibility

All employees of CHA, excluding employees such as leased employees, independent contractors, any person who is engaged in the business solely as a member of the Board of Directors, and of any controlled group employer (or affiliated service group employer) that does not affirmatively adopt this plan, are eligible to participate in the Plan for purposes of making pre-tax salary deferral or Roth contributions to the Plan beginning on the date of hire.

For purposes of employer contributions, all employees are eligible to receive matching contributions and a safe harbor nonelective employer contribution.

(d) Contributions

During 2023 and 2022, each participant may contribute up to \$22,500 and \$20,500, respectively, as defined by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions of an additional \$7,500 and \$6,500 in 2023 and 2022, respectively.

CHA matches 50% up to 4% of eligible compensation of an employee's pre-tax salary elective deferral or Roth contribution each payroll period up to a maximum of 2% of an employee's salary. CHA match for 2023 and 2022 totaled \$273,328 and \$242,269, respectively.

CHA makes an annual nonelective contribution of 3% of eligible compensation. The nonelective contribution for 2023 and 2022 totaled \$571,797 and \$509,661, respectively.

CHA makes quarterly nonelective contributions based on a participant's years of service. The nonelective contributions for 2023 and 2022 totaled \$113,332 and \$73,156, respectively.

Given the Plan termination was approved in the fourth quarter of 2023, there were no contributions to the Plan for the period from January 1, 2024 through April 29, 2024.

(e) Participant Accounts

Each participant's account is credited with the participant's contribution bi-weekly and investment earnings monthly, applicable to the account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a money market fund, various mutual funds, and investments in insurance contracts as investment options for participants.

(f) Vesting

Participants are always 100% vested in their employee and employer contributions.

(g) Notes Receivable from Participants

Participants may borrow from their participant accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or up to 10 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate of prime rate plus 1%. Any change in the prime rate will be updated the following day by the Plan administrator. Principal and interest are paid directly to TRS through payroll deductions.

Upon termination of the Plan, active participants with a 401k loan could rollover the loan to The Nemours Foundation Section 403(b) Plan (403(b) plan), pay off the loan or default on the loan.

(h) Payments of Benefits

Upon termination from service due to retirement, death, disability, or other reasons, participants may receive their participant account plus investment earnings as a lump-sum distribution to the individual. Participants may select other payment options which include life annuity, joint and survivor annuity, term certain annuity guaranteed for 5, 10, 15, or 20 years, installment payments, partial cash payments, or may rollover benefits to another qualified retirement account or plan. Participants in active service may elect to receive a distribution of certain contributions once they have attained the age of 59-½.

Upon termination of the Plan, participants were permitted to rollover their balance to an individual IRA or elect to receive a cash distribution. Current employees with a balance in the Plan were also permitted to rollover their balance to the 403(b) plan.

(i) Forfeitures

As participants are always 100% vested in their participant and employer contributions, there are no forfeitures.

(j) Plan Expenses

Certain investment management fees are netted against investment income. Participants may incur account or loan service fees and investment management fees, which are paid to the record keeper or trustee and are reflected as administrative expenses in the accompanying financial statements.

(2) Summary of Significant Accounting Policies

(a) Basis of Presentation

The Plan's financial statements have been prepared on the accrual basis in conformity with U.S. generally accepted accounting principles (U.S. GAAP).

As a result of the October 30, 2023 adopted resolution to terminate the Plan, the Plan's financial statements as of and for the year ended December 31, 2023 and for the period from January 1, 2024 through April 29, 2024, have been prepared on the liquidation basis, in accordance with U.S. GAAP. Under the liquidation basis of accounting, assets are measured to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process and liabilities are measured using the accrual basis of accounting and would include any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process. The adoption of the liquidation basis of accounting did not have a material effect on the carrying values of the Plan's assets and liabilities since the fair value of the Plan's investments approximated the liquidation value and any costs incurred during the liquidation process will be paid by the Employer.

(b) Investment Valuation

Investments are reported at fair value as determined by quoted market prices. The Plan assets are invested on a participant-directed basis.

(c) Income Recognition

Interest income is recorded when earned. Mutual fund dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes realized gains and losses on investments bought and sold and the change in (depreciation) appreciation of the fair value of investments held at the end of year. Purchases and sales of securities are recorded on a trade-date basis.

(d) Notes Receivable from Participants

Participant's loans are classified as notes receivable from participants and are measured at their unpaid principal balance plus any accrued but unpaid interest. Investments underlying defaulted loan balances, if any, are reflected in the statements of net assets available for plan benefits until a distribution event occurs.

(e) Payment of Benefits

Benefit payments to participants are recorded upon distribution.

(f) Use of Estimates

The preparation of financial statements, in conformity with U.S. GAAP, requires management to make estimates and assumptions that affect the reported amount of assets and liabilities and disclosure of contingent assets and liabilities, at the date of the financial statements and the reported amounts of additions to, and deductions from net assets during the reporting period. Actual results could differ from those estimates.

(g) Risks and Uncertainties

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

(3) Information Certified by the Trustee

The Plan administrator has elected to have the audit performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure. The Plan Administrator determined that the certifications received from State Street, the trustee of the Plan, meet the requirements of ERISA Section 103(a)(3)(C). The trustee of the Plan has certified that the investments shown in the statements of net assets available for plan benefits at April 29, 2024, and December 31, 2023 and 2022, the schedule of assets (held at end of year) as of December 31, 2023 and the related investment activity reflected in the statements of changes in net assets available for plan benefits for the period from January 1, 2024 through April 29, 2024 and for the years ended December 31, 2023 and 2022 included in the accompanying financial statements and supplemental schedule is complete and accurate as of April 29, 2024, and December 31, 2023 and 2022 and for the period from January 1, 2024 through April 29, 2024 and for the years ended December 31, 2023 and 2022.

The Plan's independent auditors did not extend their audit procedures to the information certified by the Trustee, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

(4) Fair Value Measurements

The Plan applies the provisions of Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement* (FASB ASC Topic 820), for fair value measurements and disclosures of financial assets and financial liabilities and for fair value measurements of nonfinancial items that are recognized or disclosed at fair value in the financial statements on a recurring basis.

FASB ASC Topic 820 defines fair value as the exit price that would be received to sell an asset or paid to transfer a liability in the principal or most advantageous market in an orderly transaction between market

participants at the measurement date. FASB ASC Topic 820 also establishes a framework for measuring fair value and expands disclosures about fair value measurements requiring investments to be grouped into three categories based on certain criteria as noted below:

- Level 1: Fair value is determined by using quoted prices for identical assets or liabilities in active markets.
- Level 2: Fair value is determined by using other than quoted prices that are observable for the asset (e.g., quoted prices for identical assets in inactive markets, quoted prices for similar assets in active markets, observable inputs other than quoted prices, and inputs derived principally from or corroborated by observable market data by correlation or other means).
- Level 3: Fair value is determined by using inputs based on management assumptions that are not directly observable. There were no Level 3 assets in the Plan as of December 31, 2023 and 2022.

As required by FASB ASC 820, assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. There were no investments as of April 29, 2024. The following tables set forth by level within the fair value hierarchy the investment assets measured at fair value as of December 31, 2023 and 2022:

(5) Tax Status

The Plan was amended and restated onto an IRS pre-approved plan document sponsored by Hill, Ward & Henderson, P.A. during 2021 (“IRS Pre-Approved Plan Document”). The IRS opinion letter dated June 30, 2020, for the IRS Pre-Approved Plan Document provides that the IRS Pre-Approved Plan Document is acceptable for use by employers for the benefit of their employees under section 401(a) of the Internal Revenue Code of 1986, as amended (“IRC”). The Plan administrator believes that the Plan is currently designed and being operated in compliance with applicable requirements of the IRC and as such is exempt from federal income taxes.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator of the Plan has analyzed the tax positions taken by the Plan, and has concluded that as of April 29, 2024 and December 31, 2023 and 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(6) Related-Party and Party-in-Interest Transactions

Certain Plan investments are units or shares of insurance contracts managed by TRS, the record keeper, as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. Additionally, participant loans are secured by participant’s account balances. These transactions also qualify as party in interest transactions.

(7) Delinquent Participant Contributions

During 2023, the Plan Sponsor determined that during 2022 certain employees were excluded from receiving contributions. The Plan Sponsor has administratively identified and corrected the errors and compensated participants for lost earnings resulting from the delay in contributions.

(8) Subsequent Events

The Plan evaluated events through September 17, 2024, the date on which the financial statements are available for issuance and determined that no disclosures were necessary.
