Report on the Audit of the Financial Statements in Liquidation

Opinion

We have audited the financial statements in liquidation of K-M Industries Holding Co., Inc. Employee Stock Ownership Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets in liquidation as of February 29, 2024, December 31, 2023 and 2022, and the related statements of changes in net assets in liquidation for the period January 1, 2024 through February 29, 2024, and the year ended December 31, 2023, and the related notes to the financial statements in liquidation.

In our opinion, the accompanying financial statements in liquidation present fairly, in all material respects, the net assets in liquidation of K-M Industries Holding Co., Inc. Employee Stock Ownership Plan as of February 29, 2024, December 31, 2023 and 2022, and the changes in its net assets in liquidation for the period January 1, 2024 through February 29, 2024, and the year ended December 31, 2023, in accordance with accounting principles generally accepted in the United States of America (GAAP).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of K-M Industries Holding Co., Inc. Employee Stock Ownership Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As further discussed in Note 1 to the financial statements in liquidation, the Board of Directors of K-M Industries Holding Co., Inc., voted in September 2022 to terminate the plan effective September 30, 2022. As a result, the Plan changed its basis of accounting from the ongoing basis of accounting to the liquidation basis of accounting. Our opinion is not affected with respect to this matter.

Responsibilities of Management for the Financial Statements in Liquidation

Management is responsible for the preparation and fair presentation of the financial statements in liquidation in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements in liquidation that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements in liquidation are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements in Liquidation

Our objectives are to obtain reasonable assurance about whether the financial statements in liquidation as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements in liquidation.

In performing an audit in accordance with GAAS, we:

- exercise professional judgment and maintain professional skepticism throughout the audit.
- identify and assess the risks of material misstatement of the financial statements in liquidation, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements in liquidation.
- obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of K-M Industries Holding Co., Inc. Employee Stock Ownership Plan's internal control. Accordingly, no such opinion is expressed.
- evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements in liquidation.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplementary Information Required by ERISA

Our audits were conducted for the purpose of forming an opinion on the financial statements in liquidation as a whole. The supplementary information of Schedule H, Line 4(i) – Schedule of Assets (Held at End of Year) as of December 31, 2023, and Schedule H, Line 4(j) – Schedule of Reportable Transactions for the year ended December 31, 2023, are presented for purposes of additional analysis and are not a required part of the financial statements in liquidation but are supplementary information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements in liquidation. The information has been subjected to the auditing procedures applied in the audits of the financial statements in liquidation and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements in liquidation or to the financial statements in liquidation themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplementary information, we evaluated whether the supplementary information, including its form and content, is presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements in liquidation as a whole, and the form and content is presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 – PLAN DESCRIPTION AND BASIS OF PRESENTATION

The following description of the K-M Industries Holding Co., Inc. Employee Stock Ownership Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General – K-M Industries Holding Co., Inc. (the Company or KMHI), established the Plan effective as of January 1, 1998. The Plan was designed to comply with Internal Revenue Code (IRC) Section 4975(e)(7) and the Regulations thereunder and as a Stock Bonus Plan under section 401(a). The Plan was subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The participating employers of the Plan were Kelly-Moore Paint Company, Inc.; K-M Universal Paint Company, Inc.; Preservative Paint Co.; and Premier Drywall Tool Co. (The Kelly-Moore Paint Co. Inc.).

Plan termination – Effective September 30, 2022 (Termination Date), the Company was sold and the Board of Directors of the Company resolved to terminate the Plan. Effective with the Plan termination, all participants with an account balance remaining in the Plan became fully vested in all contribution sources, regardless of status or years of vested service. The Plan termination also ceased employer contributions into the Plan.

Payment of benefits – When participants separate from service due to death, disability, or after attaining normal retirement age, distribution of the participant's benefits shall commence after the close of the Plan year in which the event occurs and shall be distributed in a lump sum.

Upon a participant's termination of service from the Company (for any reason other than death, disability, or reaching normal retirement age), if the participant's vested Plan benefit exceeds \$10,000, then distribution of the participant's account will be made as soon as administratively feasible in five substantially equal installments commencing after the close of the fifth Plan year following the Plan year in which the participant separated from service.

If the participant's vested Plan benefit does not exceed \$10,000, distribution of the participant's Plan benefit will be made in a lump sum as soon as administratively feasible after the close of the plan year in which the participant separated from service.

All distributions were subject to a put option, discussed below.

Put option – Under federal income tax regulations, the employer stock that was held by the Plan and its participants and was not readily tradable on an established market, or was subject to trading limitations, includes a put option. The put option was a right for up to 60 days after the stock is distributed to require the Company to purchase the stock at fair market value. The Company can pay for the purchase with interest over a period of five years or in a single payment. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America, using the accrual method of accounting. As a result of the termination, the Plan changed its basis of accounting from the ongoing basis of accounting to the liquidation basis of accounting.

Use of estimates – The preparation of financial statements in conformity with U.S. GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Cash and cash equivalents – The Company considers cash on hand, cash in banks, and cash investments with maturities of three months or less when purchased as cash and cash equivalents. The Plan maintains its cash and cash equivalents in commercial money market funds. Periodically throughout the year, cash is maintained in trust accounts in excess of insured (FDIC) limits.

Investment valuation – Investments are stated at fair value.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of other investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Administrative expenses – Administrative expenses are paid by the Plan. Certain nonrecurring transaction fees are paid by the Company.

Subsequent events – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits, but arose after the statement of net assets available for benefits date and before financial statements are available to be issued.

The Plan has evaluated subsequent events through September 6, 2024, which is the date the financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There had been no changes in the methodologies used at December 31, 2023 and 2022.

Registered investment companies (mutual funds) – Valued at the net asset value (NAV) of shares held by the Plan at year end using prices quoted by the relevant pricing agent.

NOTE 4 – TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated September 26, 2013, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

In accordance with guidance on accounting for uncertainty in income taxes (ASC 740–10), management evaluated the Plan’s tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
