Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Landmark Industries Employees Savings & Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets in liquidation as of September 1, 2023, the statement of net assets available for benefits as of December 31, 2022 (ongoing), and the related statement of changes in net assets in liquidation for the period from January 1, 2023 to September 1, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of September 1, 2023 and December 31, 2022 and for the period from January 1, 2023 to September 1, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matters – Plan Termination and Liquidation Basis of Accounting

As discussed in Note 1 to the financial statements, the trustees of the Plan approved a plan of liquidation on May 1, 2023 and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2022 financial statements to the liquidation basis of accounting used in presenting the 2023 financial statements. Also as described in Note 1, pursuant to the Plan's termination, the assets of the Plan were fully distributed as of September 1, 2023. Our opinion is not modified with respect to these matters.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTE 1 – DESCRIPTION OF PLAN

Landmark Industries Employee Savings & Retirement Plan (the Plan) was a qualified retirement plan adopted by Landmark Industries, Ltd. And its affiliate Southern Retail Management, Inc. (collectively, the Company). The Plan was originally effective January 1, 1996 to provide employees with the opportunity to save for retirement on a tax-advantaged basis and was amended and restated effective January 1, 2022, to conform to new tax laws and regulations. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

In conjunction with the sale of the Company in 2023, on May 1, 2023 the Company elected to terminate the Plan and to distribute the Plan assets as soon as administratively practicable. In accordance with Plan provisions, the Company vested 100% of the Plan's assets and all assets were distributed by September 1, 2023.

The following description of the Plan provides only general information. Participants should refer to the legal plan document for a more complete description of the Plan's provisions.

Eligibility: Prior to termination, in order to participate in the Plan, an employee must have been at least 21 years old and have completed one period of service. Employees would enter the Plan as participants on the first day of the Plan year quarter that coincided with or next followed the date the employee satisfied the eligibility requirements.

Contributions: Prior to termination, participants could elect to defer up to 90% of their compensation into the Plan, not to exceed a dollar limit which is set by law. Participants who were projected to be age 50 or older by the end of the taxable year and who were making deferral contributions to the Plan could also make a catch-up contribution not to exceed a dollar limit which is set by law. Participants could modify or revoke the amount they were contributing at any time.

The Company could make a discretionary matching contribution equal to a uniform percentage of participant salary deferrals. In 2023 and 2022, the Company matched 100% on the first 2% of compensation deferred by a participant and 50% of the next 2% of compensation deferred by a participant.

Participants could also deposit into the Plan distributions they had received from other retirement plans and certain IRAs as rollover contributions.

Participant Accounts: Each participant's account was credited with the participant's contributions and an allocation of (a) the Company's contributions (b) Plan earnings or losses and was charged with his or her withdrawals and an allocation of administrative expenses. Allocations were based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account. Each participant directed the investment of his or her account to any of the investment options that were available under the Plan.

Vesting: Prior to termination, participants were always 100% vested in their contributions and rollovers plus actual earnings thereon. Vesting in the employer contribution portion of their accounts plus actual earnings thereon was based on periods of service. A participant was fully vested after six periods of credited service.

Retirement, Death and Disability: Prior to termination, a participant was entitled to 100% of his or her account balance upon retirement, death or disability.

Notes Receivable From Participants: Prior to termination, loans were available to participants on a reasonably equivalent basis. A participant could borrow the lesser of \$50,000 reduced by the excess of their highest outstanding balance of loans from the Plan during the prior one-year period or ½ of their vested interest in the Plan. No loans in an amount less than \$1,000 were made, and a participant could only have only one outstanding loan at any one time. The loans were adequately secured and were charged an interest rate equal to 2% above the prime rate. Loan repayments were made through payroll deductions and must have been fully repaid within five years unless the loan was for the purchase of the participant's principal residence.

Investment Options: Participants could direct the investment of their entire interest in the Plan into various investment securities offered by the Plan. Prior to termination, the Plan offered various pooled separate accounts and a group annuity contract as investment options for participants.

Payment of Benefits: Prior to termination, upon termination of employment, normal retirement, disability, or death, a participant (or beneficiary in case of death) could receive a distribution of the vested portion of some or all of their accounts. If the vested account balance did not exceed \$5,000, then the vested account balance could only be distributed in a single lump-sum payment. If the vested account balance exceeded \$5,000, then the participant must have consented to any distribution before it was made. The participant could elect to receive the distribution as a single lump-sum payment or in partial withdrawals.

Participants could receive a distribution from the Plan from certain accounts prior to termination of employment if they had attained age 59½ or incurred a financial hardship that required them to satisfy certain immediate and heavy financial needs.

Forfeited Accounts: Prior to termination, forfeitures were retained in the Plan and could be used to pay administrative expenses or reduce employer contributions.

Administrative Expenses: Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net appreciation.

Subsequent Events: The Plan has evaluated subsequent events through July 19, 2024, the date the financial statements were available to be issued.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: Due to the Company terminating the Plan during 2023, it was determined by Plan management that termination was imminent and therefore, the financial statements were prepared on the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP) for the period from January 1, 2023 to September 1, 2023. The change in accounting basis did not result in any adjustments. For the year ended December 31, 2022, the financial statements of the Plan used the accrual basis of accounting in accordance with GAAP.

Estimates: The preparation of financial statements in accordance with GAAP requires the Company to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition: The Plan's investments other than fully benefit responsive investment contracts were reported at fair value as further described in Notes 4 and 5. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value was the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value was the amount Plan participants generally received when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable From Participants: Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Repayments of principal and interest were received through payroll deductions and the notes were collateralized by the participants' account balances. Related fees were recorded as administrative expenses and were expensed when they are incurred.

Payment of Benefits: Benefits were recorded when paid.

Risks and Uncertainties: The Plan held various investments. Investments were exposed to various risks such as interest rate, market, liquidity, credit and risks related to global events. Due to the level of risk associated with certain investments, it was at least reasonably possible that changes in the fair values of investments would occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits in liquidation and statement of net assets available.

NOTE 3 – CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at September 1, 2023 and December 31, 2022, net appreciation in fair value of investments, interest and interest income on notes receivable from participants for the period from January 1, 2023 to September 1, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (U.S.A.) (John Hancock).

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

- *Level 1* – Quoted prices (adjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.
- *Level 2* – Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

- *Level 3* – Significant unobservable inputs that reflect the Plan’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy. The

Pooled Separate Accounts: The fair values of participation units held in pooled separate accounts are based on the net asset values reported by the fund managers as of the financial statement date and recent transaction prices. Each pooled separate account provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund’s net asset value per unit.

(*) Certain investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in the table above are intended to permit reconciliation of the fair value hierarchy to the line item presented in the statement of net assets.

NOTE 5 – INVESTMENT CONTRACT

As of December 31, 2022, the Plan held a fully benefit-responsive investment contract option with John Hancock and the contract was included in the financial statements at contract value as reported to the Plan by the custodian. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under contract, plus earnings, less participant withdrawal or transfer of all or a portion of their investment contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no valuation reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limited the ability of the Plan to transact at contract value with John Hancock. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan, or (4) failure of the trust to qualify for the exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The contract was terminated and liquidated as part of the Plan’s termination in 2023. No adjustments were made to the contract value as a result of the termination.

NOTE 6 –PARTY IN INTEREST TRANSACTIONS

Parties-in-interest are defined under the Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee received compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Plan Sponsor. Plan investments were managed by John Hancock. These transactions qualify as party in interest transactions. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibited transaction rules under ERISA. Notes receivable from participants also reflected party-in-interest transactions.

NOTE 7 – TAX STATUS

The Company adopted a non-standardized pre-approved profit-sharing plan sponsored by Nova 401k Associates Inc. The non-standardized pre-approved profit-sharing plan obtained its latest opinion letter dated June 30, 2020, in which the Internal Revenue Service (IRS) stated that the pre-approved profit sharing plan, as then designed, was acceptable under section 401 of the Internal Revenue Code (IRC) for use by the employer for the benefits of its employees. Although the Plan has been amended and restated since receiving the opinion letter, the Company believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan as taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of September 1, 2023 and December 31, 2022, there were no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the accompanying financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.
