Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Headway Workforce Solutions, Inc. Salary Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of February 1, 2024, December 31, 2023 and December 31, 2022, and the related statements of changes in net assets available for benefits for the period from January 1, 2024 through February 1, 2024, and for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Headway Workforce Solutions, Inc. Salary Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of February 1, 2024, December 31, 2023, and December 31, 2022, and for the period from January 1, 2024 through February 1, 2024, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Headway Workforce Solutions, Inc. 

NOTE 1 DESCRIPTION OF PLAN

The following description of Headway Workforce Solutions, Inc. Salary Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established to provide retirement benefits for employees of Headway Workforce Solutions, Inc. (Company) who have at least three consecutive months of service and have reached the age of 21. Eligible employees may enroll in the Plan on the first day of January, April, July, or October once eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company was acquired by Staffing 360 Solutions, Inc. in May 2022. The Plan was amended effective December 31, 2023 to freeze contributions to the Plan as participants became eligible to participate in the Staffing 360 Solutions, Inc. & Subsidiaries 401(k) Plan (Staffing 360 Solutions Plan) effective January 1, 2024. The Plan was merged into the Staffing 360 Solutions Plan effective February 1, 2024, see Note 8.

Contributions

Prior to January 1, 2024, participants were able to contribute up to 90% of eligible compensation, as defined in the Plan on either a pre-tax or Roth basis. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified retirement plans (rollovers). The Plan included an elective automatic savings increase program which increased the participant's deferral by 1% each year up to a maximum of 10%.

The Company allows for discretionary matching or profit sharing contribution, however; the Company did not make any discretionary contributions during 2023 or 2024.

All contributions are subject to certain limitations imposed by the Plan and the Internal Revenue Code (IRC).

Participant Accounts

Each participant's account was credited with the participant's contributions and Company contributions, and allocations of Plan earnings or losses. Participant accounts were charged with an allocation of administrative expenses paid by the Plan. Allocations of Company contributions, investment income and administrative expenses were based on participants' compensation or account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested accounts.

Investment Options

Participants were able to direct their contributions into any of the funds offered by the Plan, which were held at Charles Schwab Trust Bank (Schwab). These funds included a variety of investment options with various objectives and degrees of financial risk.

Vesting

Participants became immediately vested in their deferral and rollover contributions, including the earnings on those amounts. Vesting in the Company contributions portion of their accounts was based on years of continuous service. Participants became fully vested in employer contributions upon the completion of six years of service.

Notes Receivable from Participants

Prior to January 1, 2024, participants could borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or one-half of their vested account balance. Loan terms ranged from one to five years, except for loans to purchase a primary residence, which were offered over a term of up to 15 years. The loans were secured by the balance in the participants' accounts and bore interest at a rate commensurate with local prevailing rates. Generally, principal and interest were paid ratably through payroll deductions. In connection with the merger and transfer of assets to the Staffing 360 Solutions Plan, loan balances totaling \$29,559 were transferred out of the Plan to the Staffing 360 Solutions Plan on February 1, 2024.

Payment of Benefits

Upon retirement, disability, death or termination of employment, participants became entitled to the total value of his or her vested account which was payable in a lump sum. If a participant terminated employment for any reason and his or her vested account balance did not exceed \$1,000, the Plan administrator could distribute such amount in a lump-sum payment to the participant without consent of the participant. If the participant's balance was between \$1,000 and \$5,000, the Plan administrator could roll the amount into an individual retirement account on behalf of the participant without the consent of the participant.

The Plan also provided for in-service withdrawals by participants who had attained the age of 59½. In addition, upon financial hardship, a participant was entitled to the value of his or her deferral accounts which was payable immediately in a lump-sum distribution.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on the trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits to participants are recorded when paid.

Plan Expenses

Certain expenses of maintaining the Plan are paid directly by the Company. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

Risks and Uncertainties

The Plan provides for various investment options. These investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and those changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

Subsequent events were evaluated through August 22, 2024, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION BY THE INVESTMENT TRUSTEE

Information presented in the accompanying statements of net assets available for benefits as of February 1, 2024, December 31, 2023, and 2022, the statements of changes in net assets available for benefits for the period January 1, 2024 through February 1, 2024 and for the year ended December 31, 2023 and the supplemental schedule of assets (held at end of year) as of December 31, 2023, for investments, notes receivable from participants, investment income, and interest income from notes receivable from participants was derived from information certified to be complete and accurate by Charles Schwab Trust Bank as permitted by the election made by the Plan administrator under 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 4 FAIR VALUE MEASUREMENTS

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value:

Interest-Bearing Cash: Interest bearing cash is valued at its stated account balance which approximates fair value.

Mutual Funds: Mutual funds are valued at the quoted net asset values of shares held by the Plan at year-end.

Self-Directed Brokerage Accounts: Self-directed brokerage accounts consist of common stocks, money market funds, mutual funds, and exchange traded funds, all of which are valued at the closing price reported in the active market in which the individual securities are traded.

There have been no changes in the methodologies used at February 1, 2024, December 31, 2023 and 2022.

NOTE 4 FAIR VALUE MEASUREMENTS (CONTINUED)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Due to the transfer of assets to the Staffing 360 Plan, the Plan held no investments at fair value as of February 1, 2024. The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2022 and 2023:

NOTE 5 PARTY-IN-INTEREST TRANSACTIONS

Charles Schwab serves as the trustee of the Plan, and, therefore, fees paid to Charles Schwab, or its affiliates qualify as party-in-interest transactions. Other parties-in-interest include recordkeepers and professional service firms who provided services to the Plan. Certain employees of the Company who participated in the Plan perform administrative services to the Plan at no cost to the Plan. Notes receivable from participants are also party-in-interest transactions. All of these transactions are exempt from being prohibited transactions by ERISA.

NOTE 6 INCOME TAX STATUS

The Plan has adopted a preapproved plan document opinion letter from the Internal Revenue Service (IRS) that it was in compliance with the applicable requirements of the IRC. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 NONEXEMPT PROHIBITED TRANSACTIONS

During 2022, the Company failed to remit employee deferral contributions for certain payroll periods within the timeframe prescribed by the Department of Labor. During 2023, the Company corrected the failures and a market value adjustment was made to the affected participant accounts which represented the change in value from the missed payroll dates through the date of correction.

NOTE 8 PLAN MERGER AND TRANSFER

In January 2024, the Company authorized the merger and transfer of the Plan to the Staffing 360 Solutions Plan. A summary of the net assets transferred out of the Plan on February 1, 2024 is as follows:
