INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of the Hensel Phelps Hourly Money Purchase Pension Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Hensel Phelps Hourly Money Purchase Pension Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 6, 2023 and December 31, 2022, and the related statements of changes in net assets available for benefits for the period ended December 6, 2023 and for the year ended December 31, 2022, and the related notes to the financial statements.

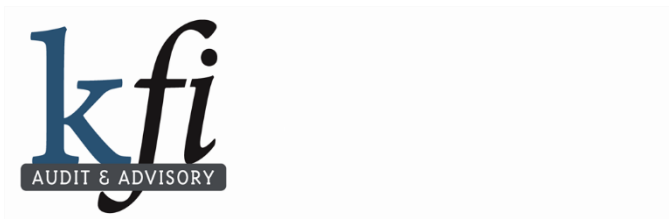

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Prudential Bank & Trust, FSB and Empower Trust Company, LLC, qualified institutions, as of December 6, 2023 and December 31, 2022, and for the period ended December 6, 2023 and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

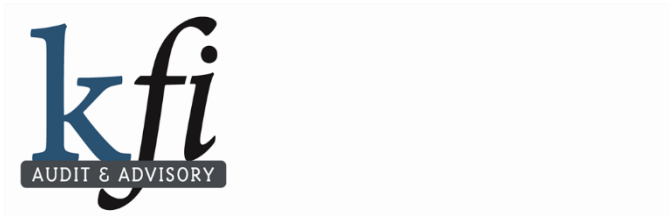

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

(1) Description of the Plan

The following description of the Hensel Phelps Hourly Money Purchase Pension Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

(a) *General*

The Plan is a defined contribution money purchase plan established effective July 1, 1993, and amended and restated effective January 1, 2020. Hourly paid employees of Hensel Phelps Construction Co. (the Company) who perform services for the Company on a public contract that is subject to the Davis-Bacon Act or any other prevailing wage law become eligible to participate immediately. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Prudential Bank & Trust, FSB and Empower Trust Company, LLC (collectively, the Trustees or Empower) have been designated to invest the Plan's assets and perform other record-keeping functions. The Company is the administrator of the Plan. The Hensel Phelps Retirement Plan committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

As of April 1, 2022, Prudential's retirement business, including record keeping, was acquired by Empower Retirement. Effective December 6, 2023, the Plan was merged into the Hensel Phelps Hourly Retirement Plan. All Plan assets transferred to the Hensel Phelps Hourly Retirement Plan by close of business on December 5, 2023.

(b) *Contributions*

The Company makes a contribution in an amount required by the Davis-Bacon Act or other applicable prevailing wage law according to the hourly contribution rate determined by each participant's employment classification for applicable construction projects. The amount contributed for a participant cannot be greater than 100% of the participant's pay. Federal law limits the total amount the Company can contribute on behalf of each participant to the lesser of 100% of the participant's pay or \$66,000 and \$61,000 for the years ended December 31, 2023 and 2022, respectively. The minimum funding requirements were met for the period ended December 6, 2023, and for the year ended December 31, 2022. Except for employee rollover contributions made pursuant to the plan agreement, contributions by participants are not permitted.

(c) *Participant Accounts*

Participants may elect to invest their account balances in any combination of the available investment options. Each participant's account is credited with participant rollover contributions, an allocation of the Company's contribution as determined by the applicable provisions of the plan agreement and plan earnings (losses). Earnings (losses) are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. Participants are charged with certain administrative fees that are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested balance.

(d) Vesting

Participants are immediately vested in all employer and rollover contributions plus actual earnings thereon.

(e) Distributions

Distributions from the Plan may be made as follows:

- Upon retirement, disability, or death, the participant or beneficiary may receive the entire balance in the participant's account, arrange to receive a series of payments over time, or leave the balance in the Plan. The participant must begin withdrawing the account balance from the Plan by the time he or she reaches age 73;
- Terminated participants are entitled to distributions of their vested account balances in the form of a lump-sum distribution, installments, direct rollover or annuity. Balances above \$1,000 may be left in the Plan until the participant requests a distribution, except in the case of a participant meeting the 73 year minimum distribution requirement.

(f) Forfeited Accounts

Forfeitures result from participants failing to take a distribution that they are entitled to within two years of notification by the plan administrator. However, the forfeited amounts are restored if subsequently claimed by the participant. At December 6, 2023, and December 31, 2022, forfeited accounts totaled \$0 and \$927,693, respectively. These accounts are used to restore prior forfeitures for qualifying participants who return to employment before a five-year break in service and for qualifying participants who claim their previously forfeited amounts after the two-year notification period. Any remaining forfeitures can be used to pay administrative fees. During the period ended December 6, 2023, and the year ended December 31, 2022, approximately \$3,446 and \$3,392, respectively, in forfeitures were used to pay administrative fees. During the period ended December 6, 2023, and the year ended December 31, 2022, approximately \$0 and \$66,307, respectively, of forfeitures were used to restore rehires and restore qualifying participants who claimed their previously forfeited amounts after the two-year notification period. During the period ended December 6, 2023, and the year ended December 31, 2022, no forfeitures were used to reduce employer contributions. During the period ended December 6, 2023, forfeitures of \$948,003 transferred to the Hourly Plan during the merge described in footnote 1(a).

(g) Administrative Fees

Administrative fees for participant-directed transactions are charged against the participant's account. In addition, certain investment related expenses reduce investment income in the accompanying statements of changes in net assets available for benefits. During the period ended December 6, 2023, and the year ended December 31, 2022, Empower remitted to the Plan certain amounts, in the form of revenue sharing, which were used to pay plan expenses, including investment advisory and auditing fees. These amounts are presented net of revenue sharing on the statements of changes in the net assets available for benefits. Administrative fees not paid directly by participants or the Company are paid by the Plan. Administrative fees paid by the Company are excluded from these financial statements.

(2) Summary of Accounting Policies

(a) *Basis of Accounting*

The financial statements are prepared on the accrual basis of accounting. Non-elective contributions from the Employer are recorded in the year in which compensation is paid to participants.

(b) *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted (GAAP) in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for plan benefits at the date of the financial statements and the changes in net assets during the reporting period and when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates and could be material to the Plan's financial statements.

(c) *Valuation of Investments and Income Recognition*

Investments in pooled separate accounts and mutual funds are recorded at fair value as further described in Note 4 – *Fair Value Measurements*. The Guaranteed Income Fund is recorded at contract value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net realized and unrealized gains and losses are reflected in the accompanying statements of changes in net assets available for benefits as net appreciation or depreciation in fair value of investments, which is determined as the difference between fair value at the beginning of the year (or date purchased during the year) and selling price or year-end fair value.

The Plan has entered into a fully benefit-responsive investment contract (the Guaranteed Income Fund) with Empower. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described above, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent upon the third-party issuer's ability to meet its contractual obligations and may be affected by future economic and regulatory requirements. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 1.50%. Such interest rates are reviewed on a semiannual basis for resetting.

Certain events could limit the ability of the Plan to transact at contract value with the issuer. Such events include the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exempt under ERISA. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, a breach of material obligation under that contract allows the issuer to terminate the contract and to settle at an amount different from contract value. Upon full liquidation of the investments by the Plan, there could be a redemption period of up to 90 days imposed by the issuer.

(d) *Benefits Paid to Participants*

Benefits paid to participants are recorded when paid.

(3) Investment Information Certified by Plan Trustees

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustees, qualifying institutions, have certified that the following data included in the accompanying financial statements is complete and accurate:

- Investments, as shown in the statements of net assets available for benefits as of December 6, 2023, and December 31, 2022, and Note 4;
- Net realized and unrealized appreciation in fair value investments and interest and dividend income, as shown in the statements of changes in net assets available for benefits for the period ended December 6, 2023, and for the year ended December 31, 2022;

As such, we instructed the Plan's independent auditors to not perform any auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

(4) Fair Value Measurements

U.S. GAAP has established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 – Quoted prices (unadjusted) for identical assets or liabilities that the reporting unit can access at the measurement date;
- Level 2 – Inputs with quoted prices for similar assets or liabilities in active or inactive markets, or inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly;
- Level 3 – Unobservable and significant inputs for the measurement of the asset or liability.

The Plan's investments in mutual funds are classified as Level 1 investments and are valued daily at the closing price as reported by the funds. Mutual funds held by the Plan are open-ended and registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The Plan's investments in pooled separate accounts are investment vehicles valued using the NAV of the units held by the Plan as of year-end as determined and certified by Prudential Bank & Trust, FSB and Empower Trust Company, LLC. These NAVs are the result of the accumulated values of the underlying investments, which are traded in an active market. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different estimate of fair value at the reporting date.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

(5) **Income Tax Status**

The Plan has received a favorable opinion letter from the Internal Revenue Service (IRS) dated December 4, 2020 as to the qualified status of the Plan. Plan management is of the opinion that the Plan fulfills the requirements of a qualified plan, and the trust established under the Plan is not subject to income tax. Accordingly, the financial statements contain no provision for federal and state income taxes.

Accounting principles generally accepted in the United States of America requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 6, 2023, and December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(6) **Concentrations, Risks and Uncertainties**

The Plan provides for various investments in mutual funds, pooled separate accounts, and a Guaranteed Income Fund. Investments, in general, are exposed to various risks, such as significant world events, interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The Plan's investment funds may invest in securities with contractual cash flows, such as asset-backed securities, collateralized mortgage obligations, and commercial mortgage-backed securities, and could potentially include securities backed by subprime mortgage loans. The value, liquidity, and related income of those securities are sensitive to changes in economic conditions, including real estate values, delinquencies or defaults, or both, and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates.

As of December 6, 2023, and December 31, 2022, there were no investments and one investment (Guaranteed Income Fund), respectively, which individually represented 10% or more of investments held.

(7) **Related-Party and Party-in-Interest Transactions**

Certain plan investments are shares of pooled separate accounts and a Guaranteed Income Fund managed by Empower. During the period ended December 6, 2023, and the year ended December 31, 2022, the Plan paid fees to the investment advisor, Empower and the Plan auditor; some of these fees were paid through an expense account funded by Empower through a revenue sharing arrangement. These transactions qualify as party-in-interest, which are exempt from the prohibited transaction rules.

(8) **Subsequent Events**

Management has evaluated the need for disclosure and/or adjustments resulting from subsequent events through September 16, 2024, the date the financial statements were issued, and determined that there were no other subsequent events that necessitated disclosure and/or adjustments to these financial statements.
