For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTES TO FINANCIAL STATEMENTS

(1) Description of plan

The following description of the Bravas 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan’s provisions, which are available from the plan administrator.

General - The Plan is a defined contribution plan sponsored by Bravas, LLC (the “Company”) for the benefit of its full-time employees who have three months of service and are age twenty-one or older. Union employees are not eligible to participate. The Plan has the following participating employers: Audio Intersections, LLC, Audio Video Innovations, LLC, Avid Technology Group, LLC (effective July 1, 2023), Bravas Colorado, LLC, Digitech Custom Audio & Video, LLC, E.P.J. Enterprises, Inc, Elevated Electronics, LLC, Greyhaven Smart Systems, LLC, Hi-Fi Sales Company, LLC, Home Technology Specialist, LLC, Home Theater Technologies, LLC, Imagine Audio/Video Inc., J.J. Vanderson & Co., LLC, Sound Entertainment Solutions, LLC, Spectrum Technology Holding LLC, and Starr Systems Wholesale, LLC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan is administered by members of management of the Company. These members of management have overall responsibility for the operation and administration of the Plan. The members of management, along with the investment advisor, determine the appropriateness of the Plan’s investment offerings and monitor investment performance.

Plan change and restatement - Effective April 1, 2022, the Plan changed the trustee and recordkeeper to Ascensus Trust Company and Ascensus LLC, respectively. With the change, the Plan adopted the Internal Revenue Service (“IRS”) cycle 3 pre-approved document provided by Ascensus. The IRS has determined that the pre-approved plan is designed in accordance with applicable sections of the Internal Revenue Code (“IRC”) and informed Ascensus of such in a letter dated June 30, 2020. The plan administrator adopted the pre-approved plan and believed that the Plan and related trust operated with the applicable requirements of the IRC.

Effective July 1, 2023, the Plan transitioned the third-party administrator to National Associates, Inc. With this transition, the Plan adopted National Associates, Inc. pre-approved non-standardized profit sharing 401k plan. The IRS has determined that the pre-approved plan is designed in accordance with applicable sections of the IRC and informed the third-party administrator of such in a letter dated August 11, 2020. Additionally, the Plan added Avid Technology Group, LLC as a participating employer and increased the maximum deferral limit from 90% to 100% of compensation.

Contributions - Each year, participants may contribute up to 90% (100% effective July 1, 2023) of annual compensation as pre-tax, Roth or after-tax contributions, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan. Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation. The automatic deferral percentage will increase by 1% per year up to a maximum of 10% of eligible compensation.

NOTES TO FINANCIAL STATEMENTS

(1) Description of plan (continued)

Contributions (continued) - The Company makes a safe harbor matching contribution of 100% of the first 3% of base compensation and 50% on the next 2% of base compensation that a participant contributes to the Plan. Additional amounts may be contributed at the option of the Company. Contributions are subject to certain IRC limitations.

Participant investment account options - The Plan currently offers various mutual funds as investment options for participants. Each investment option has its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants may change their investment options at any time.

Participant accounts - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants' contributions plus actual earnings are 100% vested immediately. QACA Safe Harbor Contributions are subject to the following vesting schedule:

Notes receivable from participants - The Plan does not allow loans; however, loans were transferred in as a result of transfers into the Plan. No new loans are allowed to be issued. The loans are secured by the balance in the participant's account and bear interest rates which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

Payment of benefits - On termination of service for any reason, if a participant's balance is less than \$5,000, their benefit equal to the value of the participant's vested interest in his or her account, will be distributed in a lump sum payment. For balances greater than \$5,000, a participant may elect to receive an amount equal to the value of the vested interest in his or her account as a lump sum distribution, substantially equal installments, partial withdrawals or continue to participate in the plan investments.

Forfeited accounts - At December 31, 2023 and 2022 forfeited nonvested accounts totaled \$20,850 and \$7,727, respectively. These accounts will be used to reduce future employer contributions or pay plan expenses. For the years ended December 31, 2023 and 2022, employer contributions were reduced by \$51,658 and \$24,313, respectively, from forfeited nonvested accounts.

(2) Summary of significant accounting policies

Basis of accounting - The financial statements of the Plan are prepared on the accrual method of accounting.

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Management determines the Plan's valuation policies utilizing information provided by the investment trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions - Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis.

Payment of benefits - Benefits are recorded when paid.

Administrative expenses - Certain expenses of the Plan are paid by the Company and are not included in the statements of changes in net assets available for benefits. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

(3) Information prepared and certified by the trustees

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company held the Plan's investment assets and executed investment transactions from January 1, 2022 through March 31, 2022 and Ascensus as agent for Ascensus Trust Company held the Plan's investment assets and executed investment transactions from April 1, 2022 through December 31, 2023. The trustees of the Plan, have certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate with respect to investments:

- Investments at fair value
- Notes receivable from participants
- Net appreciation (depreciation) in fair value of investments
- Dividends
- Interest
- Interest income on notes receivable from participants
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

(4) Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described below:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Interest bearing cash: Stated at cost, which approximates fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

(5) Related party transactions and party-in-interest transactions

ADP, Inc. was the recordkeeper as defined by the Plan through March 31, 2022, and therefore, certain transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of the investments, as they were paid through revenue sharing, rather than a direct payment. The Plan made direct payments to ADP, Inc. of \$13,931 for the year ended December 31, 2022, which was not covered by revenue sharing.

Certain plan expenses are shares of mutual funds managed by Vanguard. The Vanguard Group, Inc. has retained Ascensus, LLC as a subcontractor to provide plan recordkeeping and administrative services on its behalf. These transactions qualified as party-in-interest transactions. The Plan made direct payments to The Vanguard Group, Inc. of \$37,761 and \$17,330 for the year ended December 31, 2023 and 2022, which were not covered by revenue sharing.

(5) **Related party transactions and party-in-interest transactions (continued)**

The Plan paid certain expenses related to the Plan's operations and investment activity to various service providers. These transactions are party-in-interest transactions. The Plan Sponsor pays directly any other fees related to the Plan's operations.

(6) **Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

(7) **Tax status**

The IRS determined that the prototype non-standardized profit-sharing plan was designed in accordance with applicable sections of the IRC and informed the recordkeeper of such in a letter dated July 8, 2014. Although the Plan had been amended since receiving the opinion letter, the plan administrator believes that the Plan and related trust were designed and operated in compliance with the applicable requirements of the IRC.

Effective April 1, 2022, the Plan adopted the IRS cycle 3 pre-approved document provided by Ascensus. The IRS determined that the pre-approved plan was designed in accordance with applicable sections of the IRC and informed Ascensus of such in a letter dated June 30, 2020. The plan administrator adopted the pre-approved plan and believes that the Plan and related trust were designed and operated in compliance with the applicable requirements of the IRC.

Effective July 1, 2023, the Plan adopted National Associates, Inc. pre-approved non-standardized profit sharing 401k plan. The IRS has determined that the pre-approved plan is designed in accordance with applicable sections of the IRC and informed the third-party administrator of such in a letter dated August 11, 2020. The plan administrator has adopted the pre-approved plan and believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) **Risks, uncertainties and concentrations**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTES TO FINANCIAL STATEMENTS

(8) **Risks, uncertainties and concentrations** (continued)

At December 31, 2023 and 2022, approximately 20% and 19%, respectively, of the Plan's investments were invested in American Funds Target Retirement 2045 R6 Fund.

(9) **Delinquent participant contributions**

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. While the Company remitted all employee contributions to the Plan, contributions of \$9,755 were not remitted within the required time period for the year ended December 31, 2023. The Company has remitted these delinquent contributions to the Plan and remitted the lost earnings as a result in June 2024.

(10) **Subsequent events**

The Plan has evaluated subsequent events through September 17, 2024, which is the date the financial statements were available to be issued and noted the following items for disclosure:

Effective February 1, 2024, the Plan will begin to allow participants to take a loan from their vested benefit. Participants will be able to borrow from their fund accounts a minimum of \$5,000 up to maximum equal to the lesser of \$50,000 or 50% of their vested account balance.

Also, effective February 1, 2024, Bravas Florida, LLC, became a participating employer in the Plan and the following participating employers ceased participation under the Plan: Audio Video Innovations, LLC; Home Technology Specialist, LLC; Home Theater Technologies, LLC; Spectrum Technology Holding, LLC.
