### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Pride Management, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. ## **Emphasis of Matter – Plan Merger**

As discussed in Note 1, the Plan Sponsor, Pride Management, LLC was acquired by GPM Investments, LLC on December 5, 2022. Effective January 1, 2023, all participants of Pride Management, LLC became eligible to participate in the GPM Investments 401(k) Plan and were no longer active participants in the Pride Management, LLC 401(k) Plan. Additionally, the Board of Directors of GPM Investments, LLC approved the merger of this Plan into the GPM Investments 401(k) Plan. As a result, all investments were transferred from the Plan into the GPM Investments 401(k) Plan effective December 29, 2023. Our opinion is not modified with respect to that matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with generally accepted auditing

standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. ### Note 1 – Description of Plan

---

The following description of the Pride Management, LLC 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### *General*

The Plan was formed as a defined contribution plan covering substantially all full-time employees of Pride Management, LLC (the “Company”) who had 6 months of service. The Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Effective December 5, 2022, the Plan Sponsor, Pride Management, LLC was acquired by GPM Investments, LLC. Effective January 1, 2023, all participants of Pride Management, LLC became eligible to participate in the GPM Investments 401(k) Plan and were no longer active participants in the Pride Management, LLC 401(k) Plan. Additionally, the Board of Directors of GPM Investments, LLC approved the merger of this Plan into the GPM Investments 401(k) Plan. As a result, all investments were transferred from the Plan into the GPM Investments 401(k) Plan effective December 29, 2023.

#### *Contributions*

Each year participants may contribute 90% of annual compensation as defined in the Plan, up to the maximum allowed by the Internal Revenue Code (IRC). The Plan allows for both pre-tax and Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company makes a safe harbor matching contribution equal to 100% of each participant’s salary deferrals up to the first 4% of plan compensation. Contributions are subject to certain limitations.

#### *Participant Accounts*

Each participant’s account is credited with the participant’s contributions, the Company’s matching contribution, and an allocation of Plan earnings (losses), and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### *Vesting*

Participants are immediately vested in their voluntary contributions and safe harbor matching contributions plus actual earnings thereon.

#### *Payment of Benefits*

Upon termination of service due to death, disability, retirement, or other reasons, a participant with a vested account balance in excess \$5,000 may elect to receive a lump-sum distribution, installments, or any other form of distribution permitted by the Plan. For vested balances of \$5,000 or less, participant consent is not required for the distribution. An in-service distribution is permitted under certain situations.

### Note 2 – Summary of Significant Accounting Policies

---

#### *Basis of Accounting*

The financial statements of the Plan are prepared using the accrual method of accounting.

#### *Administrative Expenses*

Plan fees and administrative expenses are paid by the Company or the Plan on a discretionary basis.

#### *Estimates*

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect reported amounts of assets and liabilities, and changes therein and disclosures. Actual results may differ from those estimates.

#### *Valuation of Investments and Income Recognition*

The Plan's investments are recorded at fair value. All Plan assets were transferred to GPM Investments 401(k) Plan before close of business on December 29, 2023. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a full discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### *Benefit Payments*

Benefits paid to participants are recorded when paid.

### Note 4 – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used only when Level 1 inputs are not available.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2022. All Plan assets were transferred to GPM Investments 401(k) Plan before close of business on December 29, 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

### Note 5 – Investment Contracts

At December 31, 2022, and during the year ended December 31, 2023 prior to plan merger, the Plan had investments in the Putnam Stable Value Fund. Included in this fund are certain guaranteed investment contracts and wrapper contracts. These contracts are considered to be benefit responsive and are required to be stated at fair value. The yield earned by the fund with an adjustment to reflect the actual interest rate credited to participants was 3.31% for the year ended December 31, 2023, prior to plan merger and 3.14% for the year ended December 31, 2022. The percentage of contributions allocated to each fund is determined by the participants.

### Note 6 – Income Tax Status

The Plan adopted a non-standardized pre-approved profit sharing plan sponsored by ADP, LLC and has not requested a determination letter but rather has relied upon the Internal Revenue Service opinion letter dated October 6, 2020 issued on the non-standardized plan stating the Plan and related trust are designed in accordance with applicable sections of the *Internal Revenue Code (IRC)*. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the *IRC*.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the *Internal Revenue Service*. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

### Note 7 – Plan Merger

Effective January 1, 2023, all participants of Pride Management, LLC became eligible to participate in the GPM Investments 401(k) Plan and were no longer active participants in the Pride Management, LLC 401(k) Plan. As of December 29, 2023, the Plan's Trustee had effectively merged all remaining investments of the Plan to the GPM Investments 401(k) Plan.
