All plan assets have been distributed as of December 29, 2023. Our opinion is not modified with respect to this matter.

### 1. DESCRIPTION OF THE PLAN

The following description of Quotient Technology Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### a. General

The Plan was a defined contribution 401(k) plan covering all eligible employees of Quotient Technology Inc. (the Plan Sponsor) (the Company). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Retirement Plan Committee determined the appropriateness of the Plan's investment offerings and monitored investment performance.

During 2023, the Company was acquired by Neptune Retail Solutions. As a part of the evaluation of the retirement plan structure post acquisitions, Neptune Retail Solutions decided to terminate the Plan. The Plan Sponsor instructed the third-party administrator to amend the Plan to provide for such termination and be liquidated in accordance with the terms and conditions of the Plan, including any rules or regulations promulgated by the Internal Revenue Service (IRS). Liquidation of the assets in the Plan occurred on December 29, 2023.

#### b. Eligibility

All employees, upon employment with the Plan Sponsor and attainment of 21 years of age, were eligible to participate in the Plan. Leased employees, collectively bargained employees, non-resident aliens who did not have U.S. source income, and residents of Puerto Rico were excluded from participation in the Plan.

#### c. Contributions

Each year, prior to plan termination, participants could contribute up to 70% of pre-tax annual compensation or make after-tax (Roth) contributions, as defined in the Plan, up to the maximum allowed by the IRS. The Plan allowed for catch-up contributions for participants who had attained age fifty by the end of the plan year. Participants could also contribute amounts representing distributions from other qualified retirement plans (rollover contributions). Participants directed the investment of their contributions into various investment options offered by the Plan.

The Plan Sponsor could make discretionary matching contributions, and the discretionary matching contributions were determined annually by the Company. In 2023, the Company matched 50% of employee deferrals, up to 3% of each eligible participant's compensation, not to exceed \$6,000, for the plan year, totaling \$1,223,641. The Company could also make discretionary non-elective contributions as determined by the Plan Sponsor. The Company did not contribute a discretionary non-elective contribution for the period from January 1, 2023 to December 29, 2023.

#### d. Participant Accounts

Each participant's account was credited with the participant's contributions, allocations of discretionary matching and discretionary non-elective contributions and plan earnings, and charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant's earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled to was the benefit that could be provided from the participant's vested account.

#### e. Vesting

Participants were fully vested in their own contributions, rollover balances, and earnings thereon. Participants became fully vested upon death, disability or retirement. Participants vested in the Plan Sponsor's discretionary matching contributions after one year of credited service. Participants vested in the discretionary non-elective contributions based on years of service as follows:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than 1 year	0%
1 year but less than 2 years	25%
2 years but less than 3 years	50%
3 years but less than 4 years	75%
4 year or more	100%

As a result of the Plan Sponsor approving a plan to terminate the Plan, all participants became fully vested.

#### f. Notes Receivable from Participants

Participants may have borrowed from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or one-half of their vested account balance. The loans were secured by the balance in the participant's account. Participants may have had one loan outstanding at any time. Loan terms ranged from one to five years, unless for the purchase of a primary residence, which was to be no longer than ten years. Notes receivable from participants bore interest at the available market financing rates. Principal and interest were paid ratably through payroll deductions.

#### g. Payment of Benefits

Upon normal retirement at age 65, early retirement at age 55, or termination of services, a participant may have elected to receive either a lump-sum equal to the value of the participant's vested account balance, or leave their balance in the Plan if the balance is over \$5,000. The Plan required balances up to \$5,000 be paid out to participants upon termination. There were also retirement benefits available upon disability or death.

The Plan allowed in-service withdrawals upon attainment of age 59½. A participant could also request a withdrawal upon demonstration to the Plan Administrator that they were suffering a "hardship". Hardship is defined in applicable regulations promulgated or to be promulgated pursuant to the applicable section of the Internal Revenue Code (IRC) or standards established by the Secretary of the Treasury or their delegate. As a result of the plan termination, all participant accounts were distributed as of December 29, 2023.

#### h. Forfeitures

Forfeitures represented non-vested Company contributions forfeited by participants who terminate their employment or who withdraw from the Plan. Forfeitures were retained by the Plan and used to reduce Company discretionary matching and non-elective contributions and plan expenses. The Plan had no unallocated forfeitures as of December 29, 2023. The Plan had \$28,389 of unallocated forfeitures as of December 31, 2022. There were \$189,893 of forfeitures utilized during the period January 1, 2023 to December 29, 2023.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### **Basis of Presentation**

The Plan prepares its financial statements in accordance with generally accepted accounting principles (U.S. GAAP) established by the Financial Accounting Standards Board (FASB). References to U.S. GAAP in these notes are to the FASB Accounting Standards Codification (ASC).

The 2023 financial statements are presented on the liquidation basis of accounting, due to the Plan Sponsor voting to terminate the Plan, management determining liquidation was imminent, and the Plan's assets being fully distributed as of December 29, 2023 (see Note 1a). The 2022 financial statements are presented on the ongoing basis of accounting.

Under the liquidation based of accounting, assets are measured to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process and liabilities are measured using the accrual basis of accounting and would include any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process. The difference between assets measured under the liquidation basis of accounting and fair value is immaterial to the financial statements, references to fair value are synonymous to liquidation basis.

#### **Use of Estimates**

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and qualified institution. See Note 4 for disclosure of fair value measurement.

Purchases and sales of investments were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation of investments includes the Plan's gains and losses on investments bought or sold, as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants was recorded on the accrual balance. Related fees were recorded as administrative expenses and were expensed when incurred. No allowances for credit losses had been recorded as of December 29, 2023 and December 31, 2022. If a participant ceased to make loan payments and the Plan Administrator deemed the participant loan to be in default, the participant loan balance was reduced and a benefit payment was recorded. All remaining loans were deemed distributed and included in benefits paid to participants for the period from January 1, 2023 to December 29, 2023.

#### Contributions

Contributions from plan participants and the discretionary matching contributions from the Plan Sponsor were recorded in the year in which the participant contributions were withheld from compensation. Discretionary non-elective contributions were recorded when such contributions were authorized by the Plan Sponsor.

#### Payment of Benefits

Benefits were recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan were paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to recordkeeping, the administration of participant loans and processing of distributions were charged directly to the participant's account. Investment-related expenses are included in net appreciation of investments.

#### Subsequent Events

The Plan has evaluated subsequent events through September 17, 2024, which is the date the financial statements were available to be issued. There were no events that met the criteria for recognition or disclosure in the financial statements.

### 3. INFORMATION PREPARED AND CERTIFIED BY THE PLAN'S QUALIFIED INSTITUTION

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, T. Rowe Price Trust Company, a qualified institution, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in accompanying statements of net assets available for benefits as of December 29, 2023 and December 31, 2022, and the related investment transactions and investment income and interest income on notes receivable from participants reported in the accompanying statement of changes in net assets available for benefits for the period from January 1, 2023 to December 29, 2023.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to certified investment information, except for comparing such certified investment information included in the accompanying financial statements.

### 4. FAIR VALUE MEASUREMENT

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. *Fair Value Measurement* establishes a hierarchy of the valuation techniques based upon whether the inputs to those valuation techniques reflect assumptions other market participants would use based upon market data obtained from independent sources (also referred to as observable inputs). The fair value hierarchy is as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Mutual funds are measured using Level 1 inputs.

*Common collective trust:* Valued at the NAV of units of a collective trust. The NAV, as provided by the qualified institution, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. As of December 31, 2022, the Plan had no plans to sell the common collective trust at amounts different from NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

All plan assets were distributed as part of the Plan termination. Accordingly, there are no investments held as of December 29, 2023.

### 5. COMMON COLLECTIVE TRUST

The Plan's investment in the Common Collective Trust (CCT) was represented by the CCT's underlying investment in the T. Rowe Price Stable Value Fund which invests in fully-benefit-responsive investment contracts, commonly referred to as guaranteed investment contracts (GICs), synthetic investment contracts, and similarly designed contracts issued by insurance companies, banks and other financial institutions. The Plan's investment in the CCT was not considered a fully-benefit-responsive investment contract and is reported at fair value (see Note 4).

### 6. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, notes receivable from participants and transactions with investment funds managed and held by the Plan's qualified institution are considered party-in-interest transactions. Certain plan investments are managed by T. Rowe Price Trust Company who is also the qualified institution and record keeper for the Plan, and therefore, these transactions qualify as party-in-interest transactions.

The Plan also allows for a revenue sharing credit, which is used to offset certain amounts owed to T. Rowe Price Trust Company for its administrative services to the Plan. During 2023, the Plan paid the qualified institution and investment advisor administrative expenses totaling \$126,825, which is presented net of \$85,124 of the revenue sharing credit in the accompanying statement of changes in net assets available for benefits.

### 7. TAX STATUS

The Plan Sponsor has obtained an opinion letter dated August 19, 2020, in which the IRS stated that the restated prototype plan document was in compliance with applicable requirements of the IRC. The Plan Administrator timely adopted the restated prototype plan. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan was operated in accordance with the IRC.

### 7. TAX STATUS (Continued)

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions' however, there are currently no audits for any tax periods in progress.

### 8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant balances, and the amounts reported in the accompanying statements of net assets available for benefits.

### 9. PLAN TERMINATION

As discussed in Note 1a of the financial statements, the Plan was terminated during 2023. At the effective date of the termination, all participants were 100% vested. All assets of the Plan were distributed on or before December 29, 2023.
