
We are filing the attached 2022 Form 5500 for Mid-Atlantic Truck Centre, Inc. 401(K) Profit Sharing Plan & Trust late. We are asking for penalty relief due to reasonable cause.

The assets of the plan sponsor were sold to a new owner during 2021, and the plan was liquidated almost entirely in that year. There were a few participants remaining for whom the administrator could not locate transfer information until 2022, and those participants were paid in 2022 in full liquidation of the plan.

The chief financial officer of the sold company remained with the new entity but was terminated by the new entity in early 2023. Unbeknownst to the owner of the old company, the CFO had not filed the 5500-SF prior to his termination. To make matters worse, the new owner did not forward the previous IRS notices to the former owner until the final notice dated September 9, 2024. As soon as we received this notice, we took immediate action and prepared and filed this final return.

We have never previously missed a filing and respectfully request that any IRS penalties be abated due to reasonable cause.
